Councilor Shevlin shared she had been traveling out of state for the past two weeks. However, the Councilor was still staying engaged and noted she enjoyed reading the City Councilor applications. Lastly, Councilor Shevlin provided a detailed report on the French Prairie Forum meeting that was held on October 15, 2025, and featured a presentation by City Attorney Guile-Hinman.

Based on the SurveyMonkey rankings and the consensus among Council members, the Mayor announced that Sam Scull had emerged as the preferred candidate to fill the vacancy.

Councilor Cunningham noted he also asked applicants to fill out an additional questionnaire.

During discussion of the motion, Council President Berry emphasized the importance of filling the position with someone knowledgeable about the City of Wilsonville who had participated on different boards and volunteered their time. She noted Sam Scull's strong business background and volunteer experience within Wilsonville.

Councilor Cunningham raised concerns about Mr. Scull's social media activity, particularly his use of the "laughing emoji" reaction on posts where community members were sharing their opinions about City issues or political candidates. Councilor Cunningham questioned whether such behavior indicated

readiness to collaborate with people holding different views. Councilor Cunningham submitted for the record examples of Sam Scull's social media activity he was referring to. Councilor Cunningham noted he was fine with disagreement however, he felt the behavior was disenfranchising. Councilor Cunningham also referenced campaign donations as another concern and suggested that Sam Scull should run for a seat in the 2026 election instead.

Councilor Shevlin acknowledged the concerns about social media behavior but emphasized that it was a lesson for everyone to be careful about their online activities, as they will be scrutinized when serving in public positions.

Mayor O'Neil endorsed Sam Scull, noting his experience serving the community on the Development Review Board, Budget Committee, and other roles. He emphasized Sam Scull's commitment to making fair, correct, and thoughtful decisions and stated that criticizing someone for emoji use was not comparable to more serious issues. The Mayor stressed that Sam Scull's experience would be valuable given that this would be the newest Council in the City's history, facing important decisions including selecting a new city manager.
