# **MAYOR'S BUSINESS**

The Mayor took a moment to reflect on the tragic loss of Wilsonville community member Darci Oliver whom was killed in a car accident.

Next the Mayor brought to the audience's attention the efforts by the Wilsonville Police Department, Clackamas County Search and Rescue and the Clackamas County Sherriff's Office to locate community member Kathryn Gerke who had been missing since March 26, 2025.

It was announced that Wilsonville community member Senator Aaron Woods had been granted leave from the Senate President in order to undergo medical treatment.

The Mayor addressed the recent financial challenges and increasing prices affecting many residents, noting that 38% of households in Wilsonville were experiencing cost burdens. The Mayor acknowledged the stress and anxiety economic uncertainties create.

Gratitude was extended to the Wilsonville Police Department in conjunction with Clackamas County Sherriff's Office for their outstanding efforts on the Retail Crime Mission on April 3, 2025.

### 2. A Safe Place Family Justice Center Presentation

Robert Wurpes, Chief of Police introduced Erin Henkelman, Director of A Safe Place Family Justice Center. The Director then presented an overview of the organization's efforts to assist individuals and families in Clackamas County. The center focused on providing support and safety planning for victims of violence, sexual violence, stalking, elder abuse, and various forms of domestic violence. A Safe Place Family Justice Center also offered a wide range of services, including advocacy, culturally-specific support, safety planning, counseling, support groups, legal assistance, law enforcement collaboration, and additional resources for survivors.
