A regular meeting of the Wilsonville City Council was held at the Wilsonville City Hall beginning at 7:00 p.m. on Monday, November 3, 2025. The Mayor called the meeting to order at 7:00 p.m., followed by the roll call and the Pledge of Allegiance.

COUNCILOR COMMENTS, LIAISON REPORTS AND MEETING ANNOUNCEMENTS

9. Council President Berry

Council President Berry thanked citizens for providing input at the meeting.

The Council President explained that she had recently undergone a total knee replacement and was participating remotely, noting that she was behind on email correspondence as a result. She also reported on her experience using the City's Dial-A-Ride program during her recovery.

The Council President welcomed newly sworn in City Councilor Sam Scull.

In addition, the Council President reported on the following:

- 10. Councilor Cunningham

Councilor Cunningham reported on his participation in the Tualatin Valley Fire and Rescue (TVF&R) Community Fire Academy on October 24, 2025. He described the experience, which included CPR training, operating fire hoses, breaching doors, driving a fire truck, and cutting apart vehicles. The photos displayed during the Councilor's comments have been added to the record.

In closing, Councilor Cunningham encouraged Councilors to read a blog post by Sherwood Mayor Tim Rosener titled *Sherwood Takes Action to Protect Our Right to Self-Govern.* A copy of the blog post was added to the record.

11. Councilor Shevlin

Councilor Shevlin welcomed Councilor Sam Scull to the Council and thanked Mayor O'Neil for advocating for the City. She noted that the Mayor had just returned from Washington DC where he met with US Senators and Representatives about the Boone Bridge and other matters.

Moreover, Councilor Shevlin expressed appreciation for the Mayor's advocacy for immigrant and refugee neighbors and the time he spent representing the City at numerous meetings and events. The City Councilor added she had found the Mayor to be a reasonable, dedicated, and well-informed individual who handles disagreements by seeking more information. She expressed confidence that the Council would work together respectfully under the Mayor's leadership.

12. Councilor Scull

Councilor Scull thanked the Mayor, fellow Councilors, City staff, and community members for their support, as well as former Councilor Dunwell for her service to the City. He acknowledged his family, including his wife Robin, his parents, and his extended family. He also thanked lifelong friends Mayor Bill Velto and Ed Masters for their mentorship.

Councilor Scull provided his background, shared his hobbies and prior community service roles which included the Development Review Board (DRB), Budget Committee (BC), Planning Commission (PC), Red Cross, and neighborhood board.

Councilor Scull then outlined his focus areas in his new role which included economic development, supporting local businesses, attracting opportunity, revitalizing commercial and industrial space; public safety, including disaster preparedness and community resilience; and communication to ensure residents, organizations, and businesses have a voice in shaping the City's future.

NEW BUSINESS

15. 2026 Legislative Agenda Adoption and DC Lobby Trip Recap

Everett Wild, Government Affairs Manager, summarized the presentation he gave during Work Session regarding the 2026 Legislative Agenda.

It was noted that the agenda would be amended to add the City's Lobbyist Greg Leo to the agenda.

Motion: Moved to adopt the 2026 State Legislative Agenda.

Motion made by Councilor Berry, Seconded by Councilor Shevlin.

Everett Wild, Government Affairs Manager, then recapped the federal lobbying trip to Washington DC, which included Mayor O'Neil, Assistant City Manager Jeanna Troha, and himself. It was reported that the trio met with Senator Wyden's staff, Senator Merkley, and Congresswoman Salinas to discuss housing, infrastructure, the Aurora Airport, and the Boone Bridge. They also met with the House Transportation and Infrastructure Committee majority staff to emphasize the Boone Bridge's role in interstate commerce. A scheduled meeting with US Department of Transportation (DOT) was affected by the federal shutdown, but materials were left for future discussion. They met with the FAA about the Aurora Airport and had dinner with Oregon Institute of Technology (OIT) leadership who happened to be in DC at the same time.

The Mayor added that he raised concerns from City of Wilsonville residents about federal funding cuts, rising corporate-controlled residential and commercial rents, and recent Immigration and Customs Enforcement (ICE) activity. With OIT leadership, discussions included increased enrollment and exploring Wilsonville's future for workforce and student housing.

16. Resolution No. 3218

A Resolution Of The City Of Wilsonville Adopting The Climate Action Plan.

The Mayor provided the public hearing format and opened the public hearing at 8:38 p.m.

Kerry Rappold, Natural Resources Manager along with consultant Maurya Braun of Sustainability Solutions Group (SSG), summarized the staff report and presented PowerPoint, which has been made a part of the record.

Council asked clarifying questions and provided comments.

The Mayor invited public testimony. The following individuals provided testimony:

- Brad Williams opposed.
- Jeff Zundell supported.

- Doris Wehler opposed.
- Lee Barckman supported.

The Mayor asked for additional public comment hearing none the Mayor closed the public hearing on Resolution No. 3218 at 9:23 p.m.

The Mayor then requested a motion on Resolution No. 3218.

Motion: Moved to adopt Resolution No. 3218, Climate Action Plan.

Motion made by Councilor Berry, Seconded by Councilor Scull.

Councilor discussion ensued.

During Council deliberation, Councilor Shevlin supported the Climate Action Plan, emphasizing that it incentivizes rather than mandates changes. The Councilor noted that as equipment needs replacement, incentives might make cleaner alternatives more attractive, like Portland's approach to gas-powered lawn equipment.

Councilor Cunningham opposed the Climate Action Plan, expressing concerns about costs, questioning the funding sources, and noting the city's projected budget deficit. The Councilor objected to the plan's call for multi-unit mixed use developments when focus groups indicated resistance to such density. He stated that the plan conflicts with what residents want for the community's development.

Councilor Scull supported the Climate Action Plan, focusing on "the cost of inaction" and viewing it as a starting point with a 20–30-year horizon. The Councilor described it as a data-driven path to reduce greenhouse gas emissions, boost energy efficiency, and strengthen community resilience, with details to be determined by future budget committees and councils.

City Council November 03, 2025 Councilor Cunningham reiterated his prior comments.

The Mayor expressed support for the Climate Action Plan, stating that future generations might question why the City did not act if they chose not to adopt a Climate Action Plan. The Mayor acknowledged concerns about community members struggling financially but noted that the plan was not responsible for those issues and that financial assessments would guide implementation through annual budget processes.
