MAYOR'S BUSINESS

4. Adoption of 2024 State Legislative Priorities

The Mayor recalled that during Work Session prior to the Council meeting a set of legislative priorities for the 2024 session of the Oregon Legislature, which starts on February 5, 2024, was discussed.

The legislative priorities represented current, specific issues of timely importance to the City Council and the community.

Moreover, the legislative priorities complemented the City's State Legislative Agenda, which was broader and more general in scope.

In summary, the list of 2024 Legislative Session Priorities included:

- 1. Restore Recreational Immunity for Public Use of Trails
- 2. Fund the WES Westside Express Service Commuter Rail Extension Study
- 3. Create a State Residential Housing Infrastructure Fund; and Oppose Efforts to Override Land-Use Laws for UGB Urban Growth Boundary Expansion
- 4. Reauthorize and Fund the Business Oregon RSIS Regionally Significant Industrial Sites Program
- 5. Provide Charbonneau and Wilsonville with an I-5 Boone Bridge Tolling Waiver or Exemption
- 6. Extend the Sunset or Ending Date of the VHDZ Vertical Housing Development Zone Incentive; and
- 7. Improve Childcare Resources to Benefit Families, Workers and Employers

Winter Ice and Snowstorm

- The Mayor appreciated the work of City staff and public safety during the recent storm.
- The Mayor shared most of the power lines in the City are buried which resulted in power that is more reliable.

Civics Academy

- Council participated in the Wilsonville Civics Academy on January 11, 2024.
- The Civics Academy was a seven-month-long program for Wilsonville residents, which, goes indepth into the way the City operates.
- The Mayor appreciated all whom participated in the Civics Academy.

Developmental/Hearing Screenings for Children

- On Friday, January 19, 2024, the Clackamas Education Service District's Community and Referral
 Assistant would provide a free developmental and hearing screenings for children ages birth
 through 5 years at the Wilsonville Public Library.
- The free screenings provided by Clackamas Education Service District were doctor-recommended to assess the physical, social, emotional and development of children, birth to 5 years.

Representative Neron Coffee Hour

- Wilsonville State Representative Courtney Neron was to hold a Coffee Hour event on Saturday, January 20, 2024 at the Wilsonville Public Library.
- Representative Neron wanted to hear from constituents about issues of concern, and planned to give a preview of the 2024 short legislative session that was scheduled to start on February 5, 2024.

Metropolitan Mayors Consortium (MMC) and Greater Portland Inc. (GPI) Meet the Mayors Event

COMMUNICATIONS

9. Willamette Water Supply Program Project

Zach Weigel, City Engineer introduced Eric Ward, Conveyance Project Manager and Mike Britch of Willamette Water Supply Program (WWSP). The presenters then updated Council on the one-billion-dollar project led jointly by the Tualatin Valley Water District and City of Hillsboro. The project involved working with Wilsonville to tap into the Willamette River, and build a 26-mile-long pipeline as a long-term water supply for Hillsboro, Beaverton and customers of the Tualatin Valley Water District (TVWD). The PowerPoint displayed was added to the record.

Council questions and comments followed the presentation.

CITIZEN INPUT AND COMMUNITY ANNOUNCEMENTS

Preston Korst, Director of Government Affairs at the Home Builders Association (HBA) of Greater Portland expressed concern over the following decisions and requested Council direct staff to re-review:

- 1) The City's Parks System Development Charge (SDC) fee increase from \$7,000 to \$14,000 per/unit effective January 1, 2024.
- 2) Wilsonville's Frog Pond West Infrastructure Fee for the Boeckman Road totaling nearly \$35,000 per/unit, effective January 15, 2024.

The Community Development Director recalled that staff was willing to make accommodations in response to HBA's request. Council was reminded that staff provided them with a written summary of all events that had occurred to this point, which was then summarized for the audience.

Based on Community Development Director's assessment, staff followed all necessary procedures outlined in the noticing requirements. Moreover, the City considered themselves as partners of Home Builders Association and acknowledged their challenges.

Council was informed over the past two weeks; staff discussed options like spreading fee payments over time, possibly delaying collecting the Frog Pond fee until later, and adjusting the timeline to a framing inspection. These proposals aimed to offer practical accommodations and would be brought forth for Council adoption via a resolution at the February 22, 2024 City Council meeting.

Further discussion on the request ensued.
