#### **MAYOR'S BUSINESS**

### 4. Upcoming Meetings

The Mayor extended warm wishes for a joyful St. Patrick's Day and then provided updates on the recent meetings, events, and activities. A comprehensive written report listing all the meetings attended by the Mayor has been included in the official record.

#### City Council Retreat and Goal Setting

- Discussed key staff departures that would occur in 2025. Noted Council was aware the next City Manager would need time and grace to get up to speed and establish relationships with the Council and staff.
- Under the umbrella of public health, safety, and welfare, the Council identified the following goals:
  - Streamline response to code enforcement challenges.
  - Expand on-the-ground mental health resources to support the community.
  - Evaluate and update the public nuisance code and explore a rental inspection program, including identifying potential revenue streams to fund such a program.
- The Council also discussed the current and future fiscal health of the City's many operating funds and developed specific goals under the heading of financial outcomes:
  - $\circ~$  Explore cost savings, efficiencies, and alternative revenue options for sustainable fiscal health.
  - Future-proof revenues and avoid large rate spikes in the sewer, water, and stormwater funds by indexing these utilities to a CIP Index.
- Council discussed ways the City can build trust through communication and community engagement. The following goals were established:
  - Engage the community on urban renewal and other infrastructure funding sources.
  - Create a Town Center communication and engagement strategy to help inform Council direction.
  - Evaluate and improve online engagement and social media tools to expand the audience and reach within the community.
- Council advanced a goal to ensure the current level of parks maintenance is provided for the long term . As the City's parks portfolio continued to grow, with an additional 30 acres of maintenance responsibility coming online in the next 2-3 years. The goal was to:
  - Maintain existing maintenance levels of service with upcoming parks expansion by identifying additional revenue opportunities and potential cost savings.

Legislative Testimony

- Support of Senate Bill (SB) 179, which restores recreational immunity for landowners who allow free public access to trails and recreational activities.
- Support of amended House Bill (HB) 3031-1, the City urged an enlarged scope of residential infrastructure resources that could substantially advance state goal for housing production. In addition, the City advocated for funding of off-site infrastructure improvements, such as Wilsonville's \$18 million Boeckman Road sewer-interceptor project to serve housing proposed for the new urban growth areas of Frog Pond.
- Support of House Bill (HB) 3560, this proposed legislation addresses critical need to improve child care availability that benefits both working families and employers.
- Support of House Bill (HB) 2679, Sponsored by representative Courtney Neron, this proposed legislation restricts the use of products containing powerful class of neonicotinoid pesticides shown to be harmful to pollinators and the agricultural industry.
- Support of amended version House Bill (HB) 2138-1, the City's proposed amendments would provide greater clarity and remove uncertainty that allows local governments and developers to focus on producing more middle-housing residential development.
- Support of House Bill (HB) 3503, would support an innovative housing plan by Clackamas County that provides an opportunity for older homes to be acquired by lower-income residents who can become homeowners.
- Support of House Bill (HB) 3700, would create a state program to certify qualified out-of-state operators of water and wastewater systems.
- Support of Senate Bill (SB) 1086, provides for state agencies' collaboration to increase the number of qualified building inspectors who can help with housing production.
- Support of House Bill (HB) 3453, would create the Westside Express Service authority to assume operational responsibility of WES, or the Westside Express Service commuter train, from TriMet.

#### LEGAL BUSINESS

15. Wilsonville Code Chapter 3 Interpretation

Amanda Guile-Hinman, City Attorney provided City Council a memorandum interpreting Wilsonville Code provisions 3.340 and 4.300 through 4.320. The provisions governed the undergrounding requirements in the City of Wilsonville. Portland General Electric had applied for a right-of-way permit in which it sought to locate new high-voltage transmission lines and transmission poles along SW Grahams Ferry Road. City staff had informed PGE that under Wilsonville Code Section 3.340, PGE must underground its utilities. The only exception in Section 3.340 is that PGE may run new transmission lines on existing poles, but nothing in the Section 3.340 allowed PGE to install new transmission poles.

PGE referred to a different provision, Wilsonville Code 4.310, to argue that high-voltage transmission lines are exempt from undergrounding requirements and, thus, it can install new transmission poles. However, Wilsonville Code Sections 4.300 through 4.320 are the undergrounding requirements for new developments. And the exception that PGE refers to was the exception that new development does not need to underground high-voltage transmission lines. Nothing in those provisions allow PGE to install new transmission poles.

PGE disagreed with the staff's interpretation of these Wilsonville Code provisions. Thus, staff seek Council direction whether it agrees with staff's interpretation. If Council does, staff seek a motion to adopt the interpretations of Wilsonville Code 3.340 and 4.300 through 4.320, as described in the presented memorandum.
