#### **Community Cultural Events and Programs Grant**

Following the presentations from the applicants the ACHC discussed. Susan Schenk made a motion to fund all three applications at their full ask request: Charbonneau Arts Association: Wilsonville Music Festival receiving \$10K, Wilsonville Rotary Foundation: Rotary Summer Concerts – 2025 receiving \$8K and Wilsonville STAGE: Pop Up Performances receiving \$3K. Benjamin Mefford Seconded the motion. Chair Deb Zundel, Vice Chair Nadine Elbitar, David Altman, Sageera Oravil Abdulla Koya, and Joan Carlson voted yes. Motion Passed.

#### **Boones Ferry Public Art RFQ**

Erika Valentine presented the updated Boones Ferry Public Art RFQ. The ACHC had reviewed this at a previous meeting and had revisions so staff returned with updates which included new zone locations. The Commission was happy with the updated location options for artists. Valentine updated the Commission of next steps with the project and posting/marketing the RFQ.

#### We Are All Bound Up Together: Art and Stories From Behind the Walls

PSU's Higher Education in Prison (HEP) program launched in 2019 with a single class offered at Coffee Creek Correctional Facility (CCCF), and has grown into a full bachelor's degree pathway in Liberal Studies, with a Business Minor option. Currently 65 students at CCCF are fully enrolled at Portland State University and are pursuing their degrees.

#### **Mission**

Our program's mission is to provide access to rigorous, quality higher education for people experiencing incarceration, and to support students post-release.

#### Vision

HEP's **vision** is a community where the transformational power of education is accessible to all, changing lives, opening doors, reducing recidivism and enhancing community safety and well-being.

#### **Art Class and Exhibit: Coffee Creek Correctional Facility**

Through generous funding from the Wilsonville/Metro Community Enhancement Grant, we were able to offer an art course at CCCF in Summer term 2024. This not only fulfilled an arts requirement for students' degree pathway, but also allowed the students to explore their own identities, as related to place. The art highlights where students come from, where they are now, and where they envision themselves in the future. The art will be exhibited in the Wilsonville Public Library in April. We are excited that it will be technology-enhanced. Viewers will be able to use their smartphone to scan areas of the art and hear more from the artists themselves. We hope this will help to break down stigmas and reduce barriers between people who live in Wilsonville *outside* the fence, and those *behind* the fence. We are, after all, all bound up together.

**Subject: Temporary Pride Month Mural Artist Selection** 

#### **Recommended Action:**

Review and score the three artists who are interested in the temporary pride mural.

At the February 19 ACHC meeting, the ACHC (Selection Panel) will discuss and make a determination on which TWO artists they would like to invite to create and submit a design for their review. Those designs will be reviewed at a future meeting.

#### **Background and Process:**

The purpose and goal of the mural is to provide visual representation to uplift, recognize and celebrate the LGBTQIA+ community and celebrate and honor Pride Month.

This is the 2<sup>nd</sup> Pride Month Mural Process. Last year, a traditional Call for Art Application was issued which only received two responses. This year staff worked with the organization Portland Street Art Alliance (PSAA), due to their large networks of muralists. PSAA provided staff with a list of ten artists who they thought would be a good fit for the project. Staff narrowed that list down to five artists. PSAA reached out to those five artists to see if they were interested in the project. Artists were given information about the project such as "Designs may incorporate or be inspired by the Progress Pride Flag and its colors, but ultimately artists should use their own creativity when submitting a design that they feel is representative, celebratory and meaningful of the LGBTQIA+ community and Pride Month. The site is very visible by both pedestrians and cars and will likely be utilized as a photo opportunity." Three of the five artists are interested and are included in this packet. The ACHC (Selection Panel) will determine with TWO artists they would like to invite to create and submit a design for this project by looking at their provided work samples and visiting each artists' website. The determined two artists will be compensated for their time and effort in creating a unique design, specific for Wilsonville's Pride Month Mural Project. Those two design options will be brought back to a future meeting in order for the Panel to determine which artist and corresponding design to award the project to.

When scoring the three artist options, Panelists should consider their style, aesthetic, color palettes, etc. and how it may translate to the pride mural project's intent, scope, location, etc. Panelists should visit each artists' website to learn more and view more work samples (links are provided in artist packet). Panelists will score each of the three artists a 1-10 score (1 being low and 10 being high/perfect). Please only use whole numbers. Staff will receive everyone's scores ahead of time (by 9am Tues February 18) in order to compile them and then show a ranked list at the meeting.
