3. Minutes of the May 18, 2023 Urban Renewal Budget Committee Meeting.

Member Moulton moved to approve the Minutes of the May 18, 2023, Urban Renewal Budget Committee Meeting. The motion was seconded Member Berry and passed by a 7 to 0 vote.

5. Urban Renewal Budget Message

Matt Lorenzen, Economic Development Manager, presented via PowerPoint an overview of urban renewal in general as well as the City's historic and current use of urban renewal to provide proper context for the budget discussion. His presentation included an explanation of tax increment financing and the status of each of the City's four urban renewal plans, two of which were active, highlighting details and key projects within each urban renewal plan. (Slides 1-14)

- He addressed questions from the Committee about revenue sharing in other cities, noting that
 Wilsonville started revenue sharing before it was mandated and capped tax increments even when
 it was unnecessary, which was best practice in the use of urban renewal.
- 6. Urban Renewal Budget Presentation

Finance Director Katko presented the \$9.6 million Total Agency Budget, summarizing the budgets for the three open urban renewal plans and noting the estimated tax increment collections for each plan. (Slide 16)

• He confirmed the Westside Plan would be continued in next year's budget as it included \$2.1 million for the continuation of the Brown Road project, but no more increment would be collected. The total Brown Road Project cost was estimated at \$6.6 million over several years.
