a. UTV Ordinance Update

Trustee Ackerman led the discussion surrounding the UTV Ordinance, with specific concern regarding McNair Rd. Upon review of the Ordinance, it was reiterated that UTVs were not allowed on roads with speed limits over 35mph. Trustee Ackerman noted that the UTV signs, liability forms, and permit applications/stickers still needed to be addressed and completed prior to the Ordinance going into effect.

b. McNair Road Speed Limit

Chief White spoke to the traffic studies done for the community and the criteria for determining the speed limits on specific roads. The Police Committee discussed the speed limit on McNair Rd at length. Chief White will reach out to his contacts for further information on the logistics of changing the speed limit.
