Looking into whether the Fire Dept owns the equipment. Discussion of Rock Comm owning the equipment and whether Rock Comm needs to be leasing from us.
  - ii. Four Rivers Sanitation Authority (FRSA, formerly RRWRD) IGA Amendment #2 -Title company for closing schedule and wanted to make sure that the county would not have an issue as we would be splitting the land into two different plots of land.

Attorney Gaziano will call the title company to finalize and should be complete by Mid-October.

- iii. Approval of legal expense for easement and possible annexation for water main looping, 624 S Church and 620 S Goodling Streets -- Chad will look over the paperwork and assess whether the information is appropriate before moving forward for easement.
