5. DISCUSSION

a. Budget 2023

Budget was discussed, with the mention that everything is currently on track. The Fiscal Year Budget is approximately 50% complete at this time.

b. Audit 2022

Treasurer Bennett stated that the Audit for FY 2022 has been completed. A draft was sent to Benning Group where a couple of errors were discovered; Treasurer Bennett will discuss with Benning Group to make the necessary corrections.

- c. Aging Write-Off Review IDROP & Water Bill Delinquency No issues
- d. Bank Reconciliation Review June

Treasurer Bennett stated that the June Bank Reconciliation is currently off by \$106, which may be due to the reissuing of outstanding checks but will need to investigate further.

e. Software Upgrades

The \$1.25 credit card transaction fee should be being charged to the Village now, but the Utility Bill is still not available online yet. It was noted that the online bill should be ready by September 2023.

Chairman Graham proposed that the credit card usage fee be capped at 3.5% for the consumer, with the remainder being covered by the Village. Treasurer Bennett stated that she was unsure if it was able to be divided or if it needed to be paid in its entirety by either the consumer or the Village and that each credit card company has a different assigned fee. Treasurer Bennett will be looking into how much each credit card charges and how easy it is to charge the customers for a portion if the fee is greater than 3.5%.

It was also recommended that any customer still receiving paper billing after January 1, 2024, be charged a fee of \$1.25 to encourage use of the online payment system.

f. Credit Card Review - June

The Elan Credit Card statement from June was reviewed with no discussion. The new Community Card has not had a statement to be reviewed at this time.

g. Grant Updates
