10. Consider and take appropriate action on Resolution No. 2026-024 approving an assignment of a waste collection service contract with South Plains Waste Service, LLC to BFI Waste Service of Texas, LP, also known as Republic Waste Services.

Matthew Peterson spoke to the Council on behalf of Republic Services. Republic Services has acquired South Plains Waste Services including all assets and contracts. Republic looks to continue the stellar service that SPWS provided and has worked to hire all of the SPWS employees along with all equipment. He states little to no changes will be made with the exceptions of some staff that choose other opportunities. Contractually there will be no changes for the remaining term of the contract.

The City Council voiced concerns over past service performance from Republic and they understand that the citizens of Wolfforth are concerned. There have been no issues with SPWS over the past year and the Council expects Republic to meet that same level of service.

Matthew Peterson assured the Council that significant internally changes have been made over the last year that have increased service. They have expanded use of area landfills including Plainview and Brownfield so that they are no longer limited by the City of Lubbock landfill schedules. Six new trucks have been purchased for this area as well. Republic has taken lessons from South Plains Waste during this transition in regards to operations, leadership changes, and routes.

Republic has purchased the Meadow landfill and is awaiting TCEQ approval. They expect that landfill to open in Quarter 1 2027 which will increase efficiency.

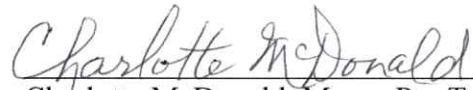
