### CITIZEN ENGAGEMENT

Builders feel that any higher amount than that will cause builders to choose other neighborhoods. Developers request discussion of credits for developers for installing infrastructure. Also, a roll out schedule is necessary to alert builders and buyers of the increase in cost.

Comments by Victoria Whitehead, CEO of West Texas Home Builders Association, included support for all developments across the area. Study performed of single family homes and the economic impact in regards to property tax on communities.
