

**WHEREAS**, the Texas Legislature in Local Government Code 505.158 allows Type B economic development corporations created by a municipality with a population under 20,000 to promote new or expanded business within the community; and

WHEREAS, the City of Wolfforth currently has a population of under 20,000;

**WHEREAS,** on September 2, 2025, the Wolfforth Economic Development Corporation (the "WEDC") held a public hearing regarding the proposed extension of the Business Improvement Grant Program (the "Program");

**WHEREAS,** on August 18, 2025, the Wolfforth City Council held a public hearing regarding a proposed extension of the Business Improvement Grant Program by the WEDC;

**WHEREAS,** the Wolfforth City Council gave this Resolution two readings on August 18, 2025, and September 15, 2025; and

**WHEREAS,** the City Council finds that it is in the best interest of the City to extend the Business Improvement Grant Program and to authorize the funding of such Program in the amount of \$50,000 for the 2025-2026 fiscal year.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WOLFFORTH, TEXAS, THAT:

Section 1. **Findings.** The foregoing recitals are hereby found to be true and correct and are hereby adopted by the City Council and made hereof for all purposes as findings of fact.

Section 2. **Proceedings.** The City Council of the City of Wolfforth approves the extension of the Business Improvement Grant Program to promote new and expanded business.

Section 3. **Funding.** The WEDC is authorized to fund the Program in the amount of \$50,000 for budget year 2025-2026.

Section 4. **Policy.** The Program policy, a copy of which is attached hereto as Exhibit "A" and incorporated herein by reference, be and is hereby adopted.

Section 5. **Open Meetings.** It is hereby officially found and determined that the meeting at which this resolution is passed was open to the public as required and that public notices of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551, of the Texas Government Code.

# THE CITY OF WOLFFORTH FOR ON-SITE SEWAGE MANAGEMENT

This Agreement is made and entered into by and between the Lubbock County, a body corporate and politic under the laws of the State of Texas (hereinafter referred to as the ("County") acting by and through its duly authorized representative, the Commissioners Court of Lubbock County, Texas, Judge Curtis Parrish presiding, and the City of Wolfforth, a political subdivision of the State of Texas (hereinafter referred to as the "City") acting by and through its duly authorized representative, Charles Addington, II, Mayor.

WHEREAS, this Agreement is made under the authority granted by and pursuant to Chapter 791 of the Texas Government Code; and

WHEREAS, County adopted an Amended Order Adopting Rules of Lubbock County, Texas for On-Site Sewage Facilities on August 12, 2002; and

WHEREAS, a person in Lubbock County must hold a permit and an approved plan to construct, alter, repair, extend, or operate an on-site sewage disposal system; and

WHEREAS, an on-site sewage disposal system in Lubbock County may not be used unless it is inspected by the Texas Commission on Environmental Quality (TCEQ) or by Lubbock County through its Designated Representative; and

WHEREAS, this Order applies to all areas in Lubbock County except for areas regulated under existing Rules and areas within incorporated cities; and

WHEREAS, the parties to this Agreement desire that the Order apply to the City.

NOW THEREFORE, the parties agree as follows:

# I. DUTIES

- 1.1 Lubbock County, through its Designated Representative, shall provide on-site sewage inspection for the City in accordance with the Amended Order Adopting Rules of Lubbock County, Texas for On-Site Sewage Facilities.
- 1.2 Inspections for on-site sewage permitting will be assessed at rates set by the Lubbock County Commissioners Court.

# II. TERM

This agreement shall become effective upon the date executed by the last party and will remain in full force and effect for one year. Thereafter this agreement will automatically renew four successive one-year terms, unless terminated with thirty (30) day written notice by either party.

# III. ENTIRE AGREEMENT

This Agreement represents the entire agreement between the parties and supersedes all prior representations, agreements, statements, and understandings related to its subject matter, whether verbal or in writing.

# INTERLOCAL AGREEMENT BETWEEN LUBBOCK COUNTY, TEXAS AND CITY OF WOLFFORTH FOR FIRE SUPPRESSION AND RESCUE SERVICES

THE STATE OF TEXAS \$ FISCAL YEAR 2026 \$ COUNTY OF LUBBOCK \$

WHEREAS, this Agreement is made between the County of Lubbock, Texas, hereinafter referred to as "COUNTY" and the City of Wolfforth, hereinafter referred to as "DEPARTMENT", under and pursuant to the Interlocal Cooperation Act, Chapter 791 of the Texas Government Code and under Section 352.001 of the Texas Local Government Code, for the performance of governmental functions and services, specifically, fire suppression and firefighting services; and

WHEREAS, the COUNTY and DEPARTMENT represent that each is independently authorized to perform the functions contemplated by this Agreement; and

WHEREAS, the COUNTY has determined that a need exists for fire suppression and rescue services in the unincorporated areas of Lubbock County; and

WHEREAS, the DEPARTMENT is the owner of certain trucks and other equipment designed for and capable of being used in the protection of people and property from and in the suppression and fighting of fires; and

WHEREAS, the COUNTY desires to obtain such services for its citizens residing in unincorporated areas of Lubbock County, and the DEPARTMENT is willing to provide such services as hereinafter set forth and provided.

**NOW, THEREFORE,** in consideration of the above recitals, mutual covenants and agreements each to the other made herein, the COUNTY and DEPARTMENT do hereby agree as follows:

- Section 1. The DEPARTMENT agrees to furnish, equip, train and supervise personnel and equipment in response to fire suppression and rescue operations in the unincorporated areas of Lubbock County, upon being dispatched by the Lubbock County Sheriff's Office. The term of this agreement shall be from October 1, 2025, and continues through September 30, 2026.
- **Section 2.** In consideration of the services provided under this Agreement, the COUNTY agrees to pay the DEPARTMENT \$198,835.00 for fire suppression and rescue services for fiscal year 2026, said amount to be paid following the approval of said funding by the Lubbock County Commissioner's Court, consistent with the Texas Open Meetings Act. This Amount was calculated based on a five-year fiscal year average (FY2020-FY2024) of 305.9 fire calls, multiplied by \$650.00/run.
- **Section 3.** The DEPARTMENT shall make or cause to be made a fire report, showing the date, time, location and description of all fire suppression and rescue operations conducted by the DEPARTMENT in the unincorporated areas of Lubbock County each month. A report must be submitted even if no fire suppression and rescue operations are performed in a given month. A copy of said reports shall be furnished monthly to the Lubbock County Office of Emergency Management by sending an email to firereports@lubbockcounty.gov. True copies of such reports shall be retained by the DEPARTMENT, subject to inspection by COUNTY, by the County Auditor or the Lubbock County Commissioners Court, at any time during normal business hours.
- **Section 4.** The DEPARTMENT shall make or cause to be made an annual budget proposal each fiscal year and must submit to the COUNTY by May 31<sup>st</sup> of each year the proposed annual budget for the following fiscal year by email to firereports@lubbockcounty.gov.

**Section 5.** The DEPARTMENT shall make or cause to be made a final budget to be filed with the COUNTY by October 31<sup>st</sup> of each year. This budget shall be of the preceding fiscal year and shall be submitted to the COUNTY by email to firereports@lubbockcounty.gov.

**Section 6.** This Agreement shall become effective and shall remain in effect unless terminated by written notice from either party, delivered not less than ninety (90) days in advance of such termination.

**Section 7.** Any notice required to be given under this Agreement shall be in writing and shall be duly served when it is deposited with a United States post office, with proper postage affixed thereto via certified mail, return receipt requested, addressed as shown below:

**Section 8.** All payments made by COUNTY shall be made from current funds. All payments made by COUNTY to DEPARTMENT for the performance of governmental functions or services is in an amount that fairly compensates the performing party for the services or functions performed under this Agreement.

**Section 9.** No provisions in this Agreement will waive the requirements of Texas Government Code § 552.001 et seq., as amended (the "Open Records Act").

**Section 10.** The construction, interpretation, and performance of this Agreement and all transactions under it shall be governed by the domestic laws of the State of Texas, and any suit regarding this Agreement must be filed in the state courts of Lubbock County, Texas.

**Section 11.** The purpose of this Agreement is only to set forth the rights and duties of the parties with regard to the governmental function or services described. This Agreement does not create any right, benefit, expectation, warranty, promise, or cause of action for any other person or entity who is not a party to this Agreement. By executing this Agreement, no party waives, or will be deemed to have waived, any immunity or defense that would otherwise be available to it against claims arising in the exercise of governmental powers and functions. Each Party will be solely responsible for any attorney fees, costs, loss, damages, injury, or death to others, or their property arising out of or related to the acts or omissions only of the Party's employees or agents and not those of any other Party.

**Section 12.** The DEPARTMENT agrees that it shall abide by all statutes, ordinances, rules and regulations pertaining to, or regulating the provision of, fire suppression and rescue services, including those not in effect and hereafter adopted.

**Section 13.** The DEPARTMENT agrees that it shall, at its own cost and expense, purchase and keep in force at all times insurance for the minimum amount of liability under the Texas Tort Claims Act. The DEPARTMENT agrees to provide copies of such policy or policies of insurance and/or other evidence satisfactory to the COUNTY by emailing copies to firereports@lubbockcounty.gov.

**Section 14.** This Agreement constitutes the entire Agreement and understanding between the parties. Any modification, change or amendment to this Agreement shall be in writing and approved by both parties.

**Section 15.** If any provision hereof or the application thereof to any person or circumstance is held to any extent, to be void, invalid, or unenforceable, the remainder of this Agreement, and the application of such provision to other persons or circumstances, will not be affected thereby, and will be valid and enforceable to the fullest extent permitted by law.

# **BACKGROUND:**

Senate Bill 2038 passed the 88<sup>th</sup> Texas legislative session and became effective September 1, 2023. This law allows landowners to petition a city to release their property from the city's extraterritorial jurisdiction (ETJ) through either a petition or an election. The bill establishes that the area is released by operation of law if a municipality fails to take such action to release the area by the later of the 45th day after the date the municipality receives the petition or the next meeting of the municipality's governing body that occurs after the 30th day after the date the municipality receives the petition.

Attached you will find a petition received on August 12, 2025, from the landowner of Kerry and Debra Hunt located at 8724 FM 1585. A map is attached for your reference.

The City Attorney has reviewed the petition and finds that it meets the requirement for ETJ removal and has prepared a Resolution granting this request.








#### **BACKGROUND:**

The Wolfforth Economic Development Corporation Board has voted to allocate \$20,000 from the FY25–26 budget to establish a new Marketing Grant program. This program is designed to support Wolfforth's small businesses by helping them increase visibility, attract customers, and strengthen overall market presence. Grants will be available on a matching basis to encourage businesses to invest in their own growth while benefiting from EDC support.

Over the past year, the EDC has made significant investments in façade improvements through the Business Improvement Grant (BIG) program. Several local businesses have already completed projects, including new signage for Evie Mae's Barbecue, Buffalo Grace, and Boujee Boutique, as well as exterior upgrades to Good Line Public House and others. With these visible improvements now taking shape throughout the community, the next step is to amplify that progress through marketing. The Marketing Grant program will allow businesses to highlight their new improvements, attract new customers, and ensure Wolfforth's commercial areas remain vibrant and competitive.

Because the Marketing Grant represents a new incentive program, state law requires City Council to hold a public hearing and formally authorize its implementation.

The EDC believes this program is a timely and complementary investment that builds on the momentum of the façade improvements and the recent United Supermarkets project announcement. Together, these initiatives are positioning Wolfforth for continued growth and a stronger local economy.

- Remit sales tax to the City of Wolfforth (proof of sales tax remittance is required with the application)

#### **Ineligible Businesses:**

Any business that does not remit sales tax to the city of Wolfforth is ineligible for this grant.

#### C. Objective

Grant funds will be made available aimed at increasing marketing efforts and initiatives to boost sales, customer engagement, and brand recognition for local businesses, such as:

- Leveraging digital marketing (social media, TV, radio) for advertisements
   Advertising campaigns (Targeted Ads)
  - Photography of products and/or services Video Creation

#### D. Grant Amounts

Each approved business is eligible for a matching grant of up to \$1,000. To receive the EDC's portion of the match, the business must first spend at least \$1,000 of its own funds on eligible marketing expenses. Proof of this expenditure must be submitted to the EDC before any EDC funds will be applied. Once verified, the EDC will pay the marketing vendor directly, up to \$1,000. If the total cost exceeds \$1,000, the business is responsible for covering the remaining balance and providing documentation of full payment.

#### E. Grant Limitation

The Grant monies must be utilized within ninety (90) days of approval. If the business fails to utilize the Grant monies within the given time frame, the business forfeits the Grant, and the marketing project will not be funded by the EDC office. The business can reapply for the Grant every 2 years.

#### F. Grant Eligibility & Requirements

- Funds cannot be used for payroll, rent, utilities, construction, sponsorships, equipment purchases unrelated to marketing, previous marketing debt or expenses incurred before the grant award date.
- Funds cannot be used for residential properties or vacant commercial buildings
- Funds must be used for marketing-related expenses such as:
  - Branding (ie: logo design, website design)
  - o Digital marketing advertisements (ie: social media, TV or radio commercial)
  - Advertising campaigns (ie: targeted ads for social media, TV or radio)
- Businesses must be located within Wolfforth's City Limits.
- Businesses must be a brick-and-mortar that offer taxable services and/or sales, with proof of building ownership and/or a signed lease agreement.

- Businesses must have a valid business license/sales tax ID/Certificate of Occupancy and be in good standing with the City of Wolfforth and the State of Texas.
- Businesses must have an active "Google My Business" listing.
- Businesses of any age are eligible. Start-ups are eligible if they have a formal business plan and active business registration.

#### G. How to Apply

- 1. Contact the EDC office to confirm grant funds are available.
- 2. Fill out the Business Marketing Grant Application and submit it with proof of sales tax remittance to the EDC office, in person or via email.
- 3. Your application may be reviewed by the Board of Directors. To ensure consideration, please submit your application at least three weeks prior to the scheduled EDC Board of Directors meeting, held on the first Tuesday of each month. Applications submitted after the deadline will be reviewed at the following month's meeting.
- 4. Contact the marketing entities/agencies of your choice, to discuss the best marketing plan for your business.
- 5. Submit the marketing quote/contract/plan, from the marketing entity, that outlines the proposed marketing effort, initiative, or campaign and must include the marketing firm's contact information.

#### H. Important Notes

- The Grant funds are available until the funds are depleted and renewed every fiscal year pending approval by the EDC Board of Directors.
- Submitting an application does not guarantee approval. Processing typically takes 1–2 months once all required documentation is received.
- These funds are intended for new marketing efforts, initiatives, or campaigns and cannot be used for those already in progress.
- Any previous marketing debt or expenses incurred before the grant award date will not be considered.
- Businesses can enhance their chosen marketing effort by contributing additional funds; however, the EDC will only cover a maximum of \$1,000 in matching funds.
- The business must reference the City of Wolfforth in the marketing effort (e.g., "Made in Wolfforth," "Proudly Made in Wolfforth", "Wolfforth, TX", "Grown in Wolfforth", etc.). The WEDC logo will be provided for use.

- Proof of valid business license/sales tax ID/Certificate of Occupancy/sales tax remittance
- Quote/contract/plan that outlines the proposed marketing effort, initiative or campaign
- A detailed performance report, including data analytics from your business website, social media,
- Copy of "Google My Business" page

#### **After Grant Approval:**

- Proof of aired advertisements on TV, radio, or social media
- A detailed performance report, including data analytics before and after the marketing campaign
- Receipts and proof of contract with the ad agency (grant payments will be made directly to the ad agency)

**WHEREAS**, the Wolfforth City Council gave this Resolution two readings on September 15, 2025, and October 6, 2025; and

**WHEREAS,** the City Council finds that it is in the best interest of the City to establish a Marketing Grant Program and to authorize the funding of such Program in the amount of \$20,000 for the 2025-2026 fiscal year.

### NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WOLFFORTH, TEXAS, THAT:

Section 1. **Findings.** The foregoing recitals are hereby found to be true and correct and are hereby adopted by the City Council and made hereof for all purposes as findings of fact.

Section 2. **Proceedings.** The City Council of the City of Wolfforth approves the creation of the Marketing Grant Program to promote new and expanded business.

Section 3. **Funding.** The WEDC is authorized to fund the Program in the amount of \$20,000 for budget year 2023-2024.

Section 4. **Policy.** The Program policy, a copy of which is attached hereto as Exhibit "A" and incorporated herein by reference, be and is hereby adopted.

Section 5. **Open Meetings.** It is hereby officially found and determined that the meeting at which

this resolution is passed was open to the public as required and that public notices of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551, of the Texas Government Code.



Dear Dr. Addington:

It is time once again to conduct the selection process for appraisal district directors. SB2, passed during the 88th Legislature 2nd Special Session, states that appointed district directors shall serve staggered four-year terms. In the past, the directors served two-year terms. To comply with SB2, the five directors appointed during the 2024 selection process are serving staggered terms with two terms ending December 31, 2025 and three terms ending December 31, 2027. For the 2025 selection process, two directors will be appointed to serve a four-year term. Thereafter all appointed directors will serve four-year terms with the nomination process in every other odd numbered year.

Another change made by SB2 that I would like to remind you of is the increase in the number of total appraisal district directors. As of July 1, 2024, the district's board is made up of nine directors. Five are appointed by the taxing units as outlined below as you have done in the past. Three directors were elected during the general election, which took place May 4, 2024. Terms for the three elected directors began July 1, 2024 and end December 31, 2026. The County Tax Assessor-Collector fills the ninth position.

Section 6.03 of the Texas Property Tax Code, establishes the selection process for taxing unit appointments of appraisal district directors. This process is not an "election" governed by the Texas Election Code but an independent procedure unique to the property tax system. To be valid nominations MUST be by RESOLUTION of your GOVERNING BODY and submitted to the CHIEF APPRAISER BEFORE OCTOBER 15, 2025.

Your current board members with terms ending on December 31, 2025, both of whom are eligible for reappointment, are:

Brady Goen, Shallowater Texas Boys Ranch and Farmer

Greg Jones, Lubbock Prosperity Bank, retired

The following are several important dates for the selection process as contained in Section 6.03 of the Texas Property Tax Code:

Before October 1 - The chief appraiser shall calculate the number of votes to which each taxing unit is entitled and shall deliver written notice; (1) to the county judge and each commissioner of the county served by the appraisal district; (2) to the presiding officer of the governing body of each city or town participating in the appraisal district, to the city manager of each city or town having a city manager, and to the city

secretary or clerk, if there is one, of each city or town that does not have a city manager; and (3) to the presiding officer of the governing body of each school district participating in the district and to the superintendent of each school district.

**Before October 15** - The presiding officer of the governing body of the unit shall submit the name(s) of the unit's nominee(s), if any, to the chief appraiser. **Each taxing unit that is entitled to vote may nominate** by resolution adopted by its governing body one candidate for each position to be filled on the board of directors. For the 2025 selection process, there are two positions to be filled. Eligibility requirements to serve on the board of directors may be found in Property Tax Code Section 6.0301(d).

**Before October 30** - The chief appraiser shall prepare a ballot listing the candidates alphabetically according to the first letter in each candidate's surname, and shall deliver a copy of the ballot to the presiding officer of the governing body of each taxing unit that is entitled to vote.

Before December 15 - The governing body of each taxing unit entitled to vote shall determine its vote by resolution and submit it to the chief appraiser.

**Before December 31** - The chief appraiser shall count the votes, declare the candidates who receive the largest cumulative vote totals elected, and submit the results to the governing body of each taxing unit in the district and to the candidates. The chief appraiser shall resolve a tie vote by any method of chance.

Enclosed you will find the number of votes to which each taxing unit is entitled as prescribed by Section 6.03 (d) and (e) of the Texas Property Tax Code. PROVIDING AN EFFECTIVE DATE.

#### **BACKGROUND:**

As you know, the southern half of FM 179 between the MSF and FM 1585 still has a 70-mph posted speed limit. We get many concerns expressed by homeowners, contractors, and motorists about this, and every single of those calls asks why the speed limit isn't lower; it's too fast and it's dangerous.

Three years ago, and even before any of these complaints began to be common, I asked TxDOT to perform a Speed Study on that stretch of highway. (A Speed Study is a process whereby TxDOT would determine if the current speed limit was appropriate, and if not would recommend a change). I was told it would be done within the next few months, and I followed up several times, then there was personnel changeover at TxDOT. I recently was told it hadn't been done.

If you agree, I recommend we make a very formal, very official request of TxDOT so they won't ignore it again. The resolution prepared requests the Speed Study to be performed by the end of 2025.

#### **BACKGROUND:**

At my request, Kimley Horn has prepared the attached IPO for engineering services for Donald Preston Drive. As we have previously discussed, Donald Preston Drive from Cambridge Avenue to the Marsha Sharp Freeway is in varying stages of condition, the worst being very poor, especially in the area of the railroad grade crossing. We've also had multiple issues with heaving and pushing of the pavement (remember the entrance into Braums before we milled it off a few months ago). The traffic load that will be added to this roadway from the United development will result in its failure and therefore necessitates its reconstruction before the United development begins. Is it my intention that this project be built within the same timeline as the Alcove project.

The IPO is for full engineering design and bid phase services for a lump sum fee of \$294,400. A resolution has been prepared to authorize the execution of this agreement.

Describing a specific agreement between Kimley-Horn and Associates, Inc. (the Consultant), and the <u>City of Wolfforth</u> (the Client) in accordance with the terms of the Master Agreement for Continuing Professional Services dated November 8, 2019, which is incorporated herein by reference.

#### **Identification of Project**

#### **Project Description**

The work to be performed by the Consultant shall consist of providing engineering services for the Client for the development of plans, specifications, and estimate for the reconstruction of Donald Preston Drive.

The proposed project limits for Donald Preston Drive are from the western curb return of Cambridge Avenue to the western limits of the westbound US 62/82 frontage road (0.21 miles). The project consists of reconstructing the existing 5-lane section, maintaining existing alignment, profile, and curb line elevations.

The project will consist of field survey, geotechnical investigation, pavement design, plans, specifications and estimate (PS&E), and bid phase services.

#### **Specific Scope of Basic Services**

#### Task 1. Project Management

- 1.1. Project Management
  - 1.1.1. Schedule, prepare for, attend, and document meetings for the project.
    - Project Kickoff Meeting (one in-person meeting)
    - Project Status Meetings (Two (2) total meetings)

#### Task 2. Survey

- 2.1. Survey Data Consultant will develop existing topographic data within the limits of this project to prepare roadway design PS&E.
  - 2.1.1.Design Survey
    - The limits of the survey along Donald Preston Drive will extend from the west curb return of Cambridge Avenue to the western curb line of the westbound US 62/82 frontage road. The survey will consist of the existing curb lines, plus 20-feet outside curb lines.
    - The following areas shall also be surveyed:
      - o Cambridge Intersection 100-feet north and west of intersection curb line.
      - Railroad crossing within Donald Preston limits
    - Place control monuments with aluminum caps in concrete. Establish horizontal state
      plane coordinates (NAD 83) using GPS. Establish vertical control coordinates on NAVD
      88. Monuments will be set to accommodate the limits of construction where possible.
    - Locate and establish coordinates for adjacent TxDOT (and/or City of Wolfforth) control
      monumentation.
    - Perform a field survey to identify and locate existing topographic elements within the roadway corridor consisting of the following:
      - o Existing pavement, curbs, sidewalks, and barrier free ramps.
      - o Roadway and lane striping along Donald Preston Drive and intersecting streets
      - Driveways (including material)
      - Existing culvert sizes and invert elevations, material, including cross sections approaching culvert crossings and headwalls/wingwalls
      - Existing swales
      - Visible utilities consisting of: manholes, vaults, water valves, water meters, telephone poles, power poles, utility markers, water well features, other public utilities, and franchise utilities
      - Traffic signal poles, cabinets, and other signal equipment
      - o Signs (excluding temporary signs)
      - o Retaining walls, if applicable
      - Railroad tracks and crossing equipment
      - Other applicable physical features that could impact design
    - Prepare a final topographic drawing in digital format (including contours and break lines) showing the features located in the field, an ASCII coordinate file of the points located in the field with point numbers and descriptions where applicable.

#### Task 3. Geotech (Subconsultant)

The purpose of the geotechnical engineering and pavement section design will be to complete a filed exploration and laboratory testing program to provide a pavement section design for the proposed site.

#### 3.1. Exploratory Boreholes

3.1.1 Subconsultant will complete 2 borings that will be advanced to a depth of 10 feet below the existing ground surface at the approximate locations shown on the attached proposed plan of borings. The borings will be drilled through the existing roadway and the thickness of the existing pavement structure will be recorded at each location. Bulk samples of the existing subgrade material will be obtained at the approximate location shown on the attached plan of borings to determine the California Bearing Ratio.

- 3.1.2 Subconsultant will mark the locations in the field using handheld GPS which provides an accuracy of approximately 50ft. Surveying of the bore holes is not included in this proposal. Borings will be backfilled with drill cuttings once complete and patched with cold patch.
- 3.1.3 Disturbed soil samples will be obtained in accordance with ASTM D 1586 Standard Test Method for Standard Penetration Test and Split-Barrel Sampling of Soils. A truck mounted drill rig and support vehicle with be utilized to complete the borings and Subconsultant assumes the site will be accessible to both vehicles to complete the field work. Groundwater readings will be taken at the time of drilling, if encountered. Subconsultant will contact Texas 811 to locate existing utilities within the project limits. It is the owner's responsibility to mark any private utilities and Subconsultant will not be responsible for damaging any private utilities that have not been located prior to field work.
- 3.1.4 If any unusual site conditions are encountered during our field investigation, we will immediately notify the owner to discuss if any additional analysis or testing would be required for the successful completion of the project. Should any additional work be required, Subconsultant will come to an agreement with the Consultant prior to proceeding.

#### 3.2. Laboratory Testing

- 3.2.1 Representative samples obtained from the field exploration will be tested in the laboratory to determine the engineering properties of the soil. The samples will be visually classified for color and select samples will be tested for the following:
  - ASTM D 2487 Standard Practice for Classification of Soils for Engineering Purposes;
  - ASTM D 2216 Standard Test Methods for Laboratory Determination of Water (Moisture) Content of Soil and Rock by Mass;
  - ASTM D 4318 Standard Test Methods for Liquid Limit, Plastic Limit, and Plasticity Index of Soils;
  - ASTM D 1140 Standard Test Methods for Determining the Amount of Material Finer than No. 200 Sieve in Soils by Washing; and
  - ASTM D 1883 Standard Test Method for California Bearing Ration (CBR) of Laboratory Compacted Soils.
- 3.2.2 Results of the laboratory testing program will be included on the boring logs or as an attachment to the final report.

#### 3.3. Final Report

- 3.3.1 Results from the field and laboratory testing programs will be analyzed to develop design parameters that will be used to determine the best pavement section for this project. Subconsultant requests that traffic data be provided by the owner but is available to help with assumptions if needed. At this time, a rigid pavement section is contemplated for use on this project. The final report will consist of the following:
  - Site vicinity map, plan of borings and boring logs;
  - Laboratory test results;
  - Discussion of site geology based on USGS Geologic Atlas of Texas;
  - Results and recommendations regarding the potential vertical rise of the soils;
  - General discussion of construction procedures and materials; and,
  - Rigid pavement design.
- 3.3.2 The final report will be sent to the Client for review and comments prior to finalizing. The final report will be submitted electronically unless other requested.

#### 3.4. Exclusions

- 3.4.1 The following services are specifically excluded in the scope of services at this time:
  - All required permitting activities.
  - Site Clearing or All-Terrain-Vehicle (ATV) Drill Rig. Our proposal does not include backhoe services to clear vegetation or mesquite to access bore locations, nor ATV drill rig.
  - Concrete coring of existing pavement prior to soil boring.
  - Private utilities clearance
  - All environmental services or other issues related hazardous materials, if encountered.
  - Any additional boreholes not defined above.
  - Land or elevation surveys.

#### 3.5. Assumptions

- 3.5.1 Required by Client or Consultant:
