#### FIRST AMENDMENT TO AGREEMENT BETWEEN CITY OF WOLFFORTH, TEXAS, AND ROYCE WITTIE

This First Amendment to Agreement between City of Wolfforth, Texas, and Royce Wittie ("First Amendment") is entered into as of the \_\_\_\_ day of February 2024, between **ROYCE WITTIE** ("**Judge**") and the **CITY OF WOLFFORTH, TEXAS,** (the "City").

#### RECITALS

WHEREAS, on August 15, 2023, the City and Judge entered into the Agreement between City of Wolfforth, Texas, and Royce Wittie (the "Agreement") to establish the relationship between the City and Judge regarding the appointment of Judge as the primary judge for the Wolfforth Municipal Court;

WHEREAS, the Agreement established that the 1<sup>st</sup> and 3<sup>rd</sup> Mondays of each month would be the court dates for the Wolfforth Municipal Court; and

WHEREAS, Judge and the Court have determined that Thursdays are better days for municipal court. The parties desire to amend the Agreement in the manner set forth below and subject to the terms and conditions hereof.

#### AGREEMENT

Now, therefore, in consideration of the foregoing recitals and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Section V. Court Schedule is hereby deleted in its entirety to be replaced by the following paragraph:

Section V. Court Schedule

The Judge will set a consistent municipal court schedule at the City of Wolfforth City Hall as follows:

#### **1st Thursday of Each Month**

Announcement and Pre-Trial Dockets.

9 am docket for announcements and pre-trial meetings10 am docket for announcement and pre-trial meetings11 am docket show cause hearings, indigency hearings, and other matters

#### 3rd Thursday each month

9 am docket for announcements and pre-trial meetings (if necessary)10 am docket for announcement and pre-trial meetings (if necessary)11 am docket show cause hearings, indigency hearings, and other matters

#### 4<sup>th</sup> Monday of each month

Capias pick up After Hours 5:00pm – 8:00pm

Judge shall make every effort to maintain the above schedule. If Judge desires to alter the above schedule to accommodate an unforeseen circumstance or a holiday, Judge will coordinate with the City Secretary to find a date or dates that will have minimal impact on the operations of the City of Wolfforth and the Wolfforth Police Department. #### AGREEMENT BY AND BETWEEN CITY OF WOLFFORTH, TEXAS, AND ROYCE WITTIE

This agreement is made by and between ROYCE WITTIE ("Judge") and the CITY OF WOLFFORTH, TEXAS, (the "City"), a general law city acting by and through its duly authorized representative.

WHEREAS, the City has established a municipal court;

WHEREAS, the City has established the office of municipal judge in Code of Ordinances Section 7.01.002;

WHEREAS, the municipal judge is to serve for a period of two (2) years. The term of the judge shall run contemporaneously with the term of the mayor;

WHEREAS, the municipal court takes place and court staff are housed in the Wolfforth City Hall;

WHEREAS, court operations affect City operations because they share portions of City Hall;

WHEREAS, the parties agree that it is important to establish and maintain set, regular court dates for the efficient operation of the Court, for scheduling of court staff and police officers, and for the general good of the City of Wolfforth; and

WHEREAS, the City and Judge desirc to enter into an Agreement to provide services to the Wolfforth Municipal Court.

NOW THEREFORE, City and Judge, in consideration of the mutual covenants and agreements herein contained and other good and valuable consideration, do agree as follows:

Section I. <u>Agent of the City</u>

The Judge shall be named as an agent of the City.

#### Section II. Scope of Services

The Judge shall:

- (a) be responsible for court compliance with the Texas Code of Criminal Procedure and the Judicial Code of Conduct within the City of Wolfforth Municipal Court,
- (b) preside over the municipal court for all Class C misdemeanors, conduct arraignments, pretrial disposition conferences, hearings, jury trials, and non-jury trials in a manner to ensure timely and efficient disposition of cases,

- (c) execute and issue court processes in the form of court orders, warrants for arrest, search warrants, body attachments, subpoenas, complaints, and civil injunctions,
- (d) determine pleas, motions and sentencing issues and authorize collection procedures, decide restitution awards and bond forfeitures,
- (e) set Court policy for routine disposition of cases for implementation by Court Clerks in accordance with the Code of Criminal Procedure and the Judicial Code of Conduct,
- (f) work with Court Administrator and City Manager to ensure smooth association between administrative and judicial departments of the City,
- (g) interpret city, state and federal laws, ordinances, statutes and court decision; analyze evidence presented in open court and apply existing and applicable law with the objective that justice must prevail,
- (h) serve as a representative of the City of Wolfforth demonstrating a positive attitude through display of professionalism, courtesy and appropriate tact and discretion in all interaction with City employees and officials and with the public,
- (i) make every effort to maintain consistent scheduled court dates not less than two days per month, and
- (j) complete other duties as may arise that are appropriate for a municipal court judge.

#### Section III. Training

The Judge shall attend one accredited municipal education training program at a minimum of 12 hours annually. The City will pay for the registration fee and costs to Judge in accordance with its Personnel Manual.

#### Section IV. Compensation

The Judge shall be compensated in the base amount of \$1,000.00 per month. The base amount will compensate the Judge for two scheduled court dates per month as set forth in this Agreement and any additional dates necessary to accomplish the following: show cause hearings, pre-trial hearings, bench trials, jury trials, dangerous dog hearings, juvenile magistrate hearings, TMCEC required training, capias procedures and other court related matters. In the event the Judge is unable to serve for an entire calendar month, the Judge will not receive compensation for that month.

#### Section V. Court Schedule

The Judge will set a consistent municipal court schedule at the City of Wolfforth City Hall as follows:

1st Monday of Each Month

Announcement and Pre-Trial Dockets.

9 am docket for announcements and pre-trial meetings
10 am docket for announcement and pre-trial meetings
11 am docket show cause hearings, indigency hearings, and other matters

#### 3rd Monday each month

9 am docket for announcements and pre-trial meetings (if necessary)10 am docket for announcement and pre-trial meetings (if necessary)11 am docket show cause hearings, indigency hearings, and other matters

#### 4<sup>th</sup> Monday of each month

Capias pick up After Hours 5:00pm – 8:00pm

Judge shall make every effort to maintain the above schedule. If Judge desires to alter the above schedule to accommodate an unforescen circumstance or a holiday, Judge will coordinate with the City Secretary to find a date or dates that will have minimal impact on the operations of the City of Wolfforth and the Wolfforth Police Department. If such requested alteration to the above schedule will be permanent, Judge will notify the City Manager of such desire to alter the above schedule before altering the schedule as such alteration will require an amendment to this Agreement.

Section VI. Term and Termination

The initial term of this Agreement shall begin on August 1, 2022 and shall end on the date of the mayoral election in May 2024. In accordance with Section 29.005 of the Texas Government Code, the Judge shall be reappointed to an additional two-year term in the event the City Council does not take action to not reappoint the Judge by the 91<sup>st</sup> day following the expiration of the initial term.

The Judge may resign his position at any time during the term of this Agreement but must continue to serve until a replacement is appointed by the City Council.

#### Section VII. Right of Ownership

All data, information, books, reports, files, software, equipment, and materials purchased, created or maintained by the City or purchased, created or maintained by the Judge on behalf of the City shall remain the property of the City.

Section VIII. Conflict of Interest

In keeping with Judge's duties to the City, Judge agrees that he shall not, directly or indirectly, become involved in any conflict of interest, or upon discovery thereof, allow such a conflict to continue. Moreover, Judge agrees that he shall promptly disclose to the City any facts which might involve any reasonable possibility of a conflict of interest.

#### Section IX. Amendment or Modification

Except as otherwise provided in this Agreement, this Agreement shall be subject to change, amendment, or modification only upon the written consent of the parties hereto, executed by authorized representatives of both parties to this Agreement.

#### Section X. Miscellaneous

1. <u>Choice of Law and Venue</u>. This Agreement shall be construed and given effect in accordance with the laws of the State of Texas, including all matters of construction, validity, performance, and enforcement. This Agreement is made and entered into in Lubbock County, Texas, and venue for all purposes shall be in Lubbock County, Texas.

2. <u>Entire Agreement</u>. This instrument contains the entire agreement between the parties relating to the rights herein granted and obligations herein assumed. Any oral or written representations or modifications concerning this Agreement shall be of no force or effect except for a subsequent modification in writing signed by all parties thereto.

#### Section XI. <u>Acceptance</u>

This instrument is being executed in two (2) counterpart originals, each of which has the full force and effect of an original.

#### **BACKGROUND:**

The Library has been offering a summer reading program to the community for over 20 years, and each year the program grows and brings in more participants. This program is our largest outreach event that spans two months, June and July, and culminates with an end-of-summer party on the first Thursday of August. In 2023 we had 427 participants in the reading contests and 2,392 participants in the various programs offered in the summer months.

The attached project overview outlines the scope of the program from beginning to end and shows the total cost of the program. We are requesting the use of Hotel Occupancy Tax Funds to cover the cost of 3 presenters from outside the Lubbock area, two of which will be scheduled during regular program dates in June and July and one that will be the main performer at the end of summer party. Programs will be held at the Patterson Park Pavilion or the Community Building, depending on the weather. Additionally, we are requesting the cost of the DJ for the summer party that will be necessary to accommodate the presenter. All the presenters are well-known and have performed at libraries and schools across the country. By bringing in presenters and programs from outside of the Lubbock area, we can bring entertainment opportunities to the community that are unique and will draw people into Wolfforth and add value to the residents. During the summer months, when school is out, there are not many entertainment options that people can participate in, and the Library has regularly taken on the role of hosting programs and events for the community. By specifically bringing in performers vetted through the Texas Commission on Arts touring roster, we are providing enriching programs to both the community and visitors who will come to Wolfforth for the events. Additionally, the three performers all come from outside of Lubbock and will have the opportunity to stay in Wolfforth. The Library will utilize various forms of marketing including, but not limited to, social media, newsletters, flyers, and reaching out to local news stations to reach a larger audience.

## **OVERVIEW**

#### 1. Project Background and Description

The goal of this event is to create fun family programs throughout the summer months in Wolfforth and to create an end of summer community wide event. This event provides a great opportunity to draw people to the City of Wolfforth, especially if we can continue to bring in special guests from outside the Lubbock area. With this event, we (the Library) will be able to increase our reach and provide high-quality, enriching events for the community. We have previously held "summer reading" pool parties, skating rink parties, and parties in the park for the participants of our annual summer reading contest. This has become more expensive over the years, and we are now to a point where we can no longer afford the end-of-summer party in addition to special guests enriches the programs we offer to the community and improves the quality of our services to our participants There would be multiple people involved in this project, depending on availability. These include myself and my director representing the Library, staff members from the City and/or City Council representing the interest of the City, members from the Library Board representing the community's interests, and multiple vendors and forms of entertainment.

#### 2. Project Scope

This project would involve bringing a few different family-friendly entertainers to the Wolfforth area during the summer. For special guest events at the Library, we are looking at local organizations such as the Science Spectrum and Ringtail Ranch Lemur Rescue. Additionally, we are looking at outside individuals from the Texas Commission on the Arts touring roster and have chosen Margaret Clauder's mother goose style puppetry program, Lucas Miller the singing zoologist, and the Laughter League a family-friendly theatrical group. These individuals would perform during the summer months at the Library or the Patterson Park Pavilion, completely free of charge to the community. For the final summer event, we have chosen to bring Jim Gill, a family-friendly singer from Illinois. Jim Gill's songs are regularly used during library programs, and he would be a fantastic performer, and enjoyable for all ages, perfect for a family event. The end-of-summer event would take place at Patterson Park and would be free to attend. There will be food truck vendors for those families that wish to eat out, along with interactive entertainment for children such as yard games purchased by the Library and Big Foot Foam Parties, also paid for with Library dollars. We will utilize staff and volunteers for the events, at no additional expense to the Library.

#### 3. Overall Timeline

- 5/28/2024 Summer Reading Program Sign-Ups begin.
- Various programs offered weekly throughout June and July
- 7/27/2024 Summer Reading Program ends/ Last day to log books.
- 8/1/2024 End of Summer Reading Party at Patterson Park

#### 4. Timeline for the End of Summer Reading Party 8/1/2024

- 4:30 pm Food Truck vendors arrive and set up.
- 5 pm- DJ begins playing music while the crowd arrives and eats.
- 6 pm Big Foot Foam Party and Yard Games
- 7 pm Jim Gill outdoor concert

#### 5. Deliverables

- Entertainment opportunities for Wolfforth residents and the surrounding communities.
- Low-cost family-friendly events that are entertaining and enriching for all ages.
- Advertising for the different entertainment providers drawing positive marketing for Wolfforth.

#### 6. Affected Business Processes or Systems

- Positive partnership with the Library, City officials, and local businesses.
- Higher levels of community engagement.
- Create a positive family environment for the Wolfforth area.
- Draw people into Wolfforth to visit local businesses and stay at the local hotel.

#### 7. Implementation Plan

We would meet with City leaders and/or the City Council to receive approval for the initial project and request financial support. We would like to propose the use of Hotel Occupancy Tax funds to receive funding for the entertainment for programs during the summer and at the end of the summer party. The Library has approved funding for a significant portion of the costs related to summer reading in the current budget. We would contact local vendors and businesses to participate and/ or support the program before summer. If funding is approved for the additional performers, agreements with the presenters will be made and dates scheduled for the events. Finally, we will advertise to the community through the Library website, social media platforms, newsletters, flyers, and local news stations as we can promote the events.

#### 8. High-Level Timeline/Schedule

This project will begin on May 27, 2024, and end on August 1, 2024

- 2) strictly prohibits peace officers employed by the <u>Wolfforth Police Department</u> from engaging in racial profiling;
- 3) implements a process by which an individual may file a complaint with the

   <u>Wolfforth Police Department</u> if the individual believes that a peace officer employed

   by the <u>Wolfforth Police Department</u> has engaged in racial profiling with respect to
   the individual;
- 4) provides public education relating to the agency's complaint process;
- 5) requires appropriate corrective action to be taken against a peace officer employed by the <u>Wolfforth Police Department</u> who, after an investigation, is shown to have engaged in racial profiling in violation of the <u>Wolfforth Police Department</u> policy;
- 6) requires collection of information relating to motor vehicle stops in which a warning or citation is issued and to arrests made as a result of those stops, including information relating to:
  - a. the race or ethnicity of the individual detained;
  - b. whether a search was conducted and, if so, whether the individual detained consented to the search;

- c. whether the peace officer knew the race or ethnicity of the individual detained before detaining that individual;
- d. whether the peace officer used physical force that resulted in bodily injury during the stop;
- e. the location of the stop;
- f. the reason for the stop.
- 7) requires the chief administrator of the agency, regardless of whether the administrator is elected, employed, or appointed, to submit an annual report of the information collected under Subdivision (6) to:
  - a. the Commission on Law Enforcement; and
  - b. the governing body of each county or municipality served by the agency, if the agency is an agency of a county, municipality, or other political subdivision of the state.

The <u>Wolfforth Police Department</u> has satisfied the statutory data audit requirements as prescribed in Article 2.133(c), Code of Criminal Procedure during the reporting period.

#### ORDINANCE NO. 2024-005

AN ORDINANCE OF THE CITY COUNCIL OF WOLFFORTH, TEXAS, CALLING A GENERAL ELECTION TO BE HELD ON MAY 4, 2024, FOR THE PURPOSE OF ELECTING TWO COUNCILMEMBERS AND MAYOR; MAKING PROVISION FOR THE CONDUCT OF SUCH ELECTION ACCORDING TO APPLICABLE PROVISIONS OF LAW; PROVIDING FOR EXECUTION OF AN APPROPRIATE ELECTIONS ORDER AND NOTICE HEREAFTER; AND OTHER PROVISIONS INCIDENT TO AND RELATED TO THE PURPOSE HEREOF.

WHEREAS, the terms of the office for Council Member Place 1, Council Member Place 2 and Mayor will expire on May 4, 2024;

WHEREAS, a general municipal election is necessary to fill these terms of office; NOW THEREFORE;

# BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOLFFORTH AS FOLLOWS:

SECTION 1. THAT a General Municipal Election be held jointly with all cities/schools inside Lubbock County, on the 4<sup>th</sup> day of May 2024 which date is the next succeeding uniform date available for municipal elections for which sufficient time elapses for the holding of an election after passage of this Ordinance. Said election shall be held to determine the successor for the positions of the mayor and four Councilmembers.

SECTION 3. THAT ballots shall be prepared in accordance with the applicable provisions of the Texas Election Code so that voters may cast ballots for the candidates of their choice.

SECTION 4. THAT individuals wishing to run for the office of a Councilmember or Mayor may apply, in person, with the City Secretary during regular office hours, 8:00 a.m. to 5:00 p.m., Monday through Friday, beginning at 8:00 a.m. on Wednesday, January 17, 2024, and ending at 5:00 p.m. on Friday, February 16, 2024.

SECTION 5. THAT the election shall be held at the Vote Centers listed in Exhibit B and all persons qualified to vote in the City of Wolfforth under the election laws of the State of Texas shall be allowed to vote therein. Said General Municipal Election shall be held on May 4, 2024, and the polling places shall be open from 7:00 A.M. to 7:00 P.M.

SECTION 6. THAT notice of the election shall be published in a newspaper of general circulation in the City of Wolfforth by publication of a Notice of Election as required by Chapter 4 of the Texas Election Code at least once not earlier than the 30th day or later than the 10th day before Election Day. In addition, notice of the election shall be posted as required by the Texas Election Code.

SECTION 7. THAT early voting shall commence on the 22nd day of April 2024 and shall conclude on the 30th day of April 2024 and be conducted at the Vote Centers and during the hours listed on Exhibit A; and that the Office of Elections, 1308 Crickets Ave., Lubbock, Texas, serves as the main early voting polling place.

SECTION 8. THAT applications for voting by mail will be accepted until 5:00 p.m. Tuesday, April 23, 2024, and applications are available from:

### **BACKGROUND:**

About a month ago we provided you with a report and update on the status of our damages from the June 2023 hailstorm. Since then we've continued working with our TMLIRP consultant, Tyler Franklin (4T Partnership), and we're very close to finishing up all preliminary work with regard to our roof damages.

We asked Mr. Franklin to provide us with a cost to upgrade any composition roof that wasn't currently a Class 4 roof, which he has. He also provided us with costs to upgrade any wellhouse roof to metal where possible. Please refer to the attached worksheet detailing the costs and different properties. The total cost to upgrade all roofs to Class 4 or metal (as deemed appropriate for the location) is about \$5700, which we recommend. If we can avoid having to go through this again I think it's worth the extra cost.

From this point, if Council agrees, we will work with 4T to schedule the work, and try to have all repairs done as quickly as possible.

The other component to the hailstorm damage was our vehicle fleet. There were a total of 25 vehicles with hail damage. Repairs have been completed on 6 vehicles and there are currently two in the shop being repaired. Unfortunately, repairs have been slow as it is difficult for most departments to be without more than two vehicles for an extended period of time.

### **BACKGROUND:**

The American Rescue Plan Act (ARPA) was signed into law on March 11, 2021 by the US Government in response to the COVID-19 pandemic. The City of Wolfforth received a total of \$1,362,040.24. Under the Act, we have until December 31, 2024 to designate the use of these funds, and until December 31, 2026 to fully expend them. Until now, I've not been ready to recommend how we commit the use of these funds.

Several months ago when we started the Impact Fee discussion, we had commitments for some urgent projects. I believed then, that by the time we reached this point in 2024, we would already have issued the debt necessary to finish some of those projects, specifically the 12" Loop Line project and the Phase 2 Disinfection project. However, as we've discussed, since we still haven't made Impact Fee commitments, we've not been able to issue the debt needed to finish these projects and start new ones. As such, I'm recommending we utilize the ARPA funds to complete those two projects. The total remaining on the 12-inch Loop Line is about \$600,000, and the amount needed to complete the Phase 2 Disinfection project is \$480,375.

When the Final Rule was approved by the Federal Government, it had a clause in it that allowed for up to \$10 million to be utilized for Lost Revenue, and the use of the funds could be generally anything a local government determined was appropriate. Therefore, it is acceptable for us to dedicate these funds to be used for Water System Infrastructure and used for these projects or other necessary projects.

A Resolution has been prepared to this effect and is recommended for approval.

### A RESOLUTION TO ELECT THE STANDARD ALLOWANCE FOR REVENUE LOSS AND TO STATE THE FUNDS BE USED FOR WATER INFRASTRUCTURE FOR THE CITY OF WOLFFORTH, TEXAS ALLOCATION OF LOCAL FISCAL RECOVERY FUNDS THROUGH THE AMERICAN RESCUE PLAN ACT; AND FOR OTHER PURPOSES

WHEREAS, on March 11, 2021, the United States Congress passed the American Rescue Plan Act of 2021 (ARPA), which provides fiscal relief funds to State and Local Governments, and other program areas aimed at mitigating the continuing effects of the COVID-19 Pandemic; and

WHEREAS, ARPA is intended to provide support to local governments in responding to the impact of COVID-19 and in their efforts to contain COVID-19 in their communities, residents, and businesses; and

WHEREAS, ARPA includes State and Local Fiscal Recovery Funds to support urgent COVID response efforts to decrease the spread of the virus; to replace lost public sector revenue to strengthen support for vital public services; to support immediate economic stabilization for households and businesses; and to address systemic public health and economic challenges that have contributed to unequal impacts of the pandemic on certain populations; and

**WHEREAS**, the United States Department of Treasury has adopted the final rule as guidance regarding the use of ARPA Funds; and

**WHEREAS**, the United States Department of Treasury deposited the City of Wolfforth three tranches of funds for a total of \$1,362,040.24; and

**WHEREAS**, that as recipient, the City of Wolfforth has accepted award of Coronavirus Local Fiscal Recovery Funds allocation up to the maximum allowed by the terms and conditions of the ARPA; and

**WHEREAS**, ARPA permits local recipients to expend these funds in the following broad categories:

(1) Expenditure of Lost Revenue on Governmental Services; (2) Public Health Measures to Respond to COVID-19; (3) Water and Sewer Infrastructure (4) Address Negative Economic Impacts of COVID-19; and

**WHEREAS**, this resolution is intended as a statement of intent of the City Council to govern the budgeting and expenditure of the City's ARPA Funds in accordance with Federal Law and to provide guidance, for the current critical needs and establish priorities for which there is consensus as set forth below; and

#### NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WOLFFORTH AS FOLLOWS:

Section 1. Subject to the provisions of Section 4 below, the proper officials of the City of Wolfforth

are authorized to apply for, obtain, or otherwise assure use of ARPA funds as set forth in this resolution.

**Section 2**. The City of Wolfforth affirmatively elects, pursuant to the United States Department of Treasury's Coronavirus State and Local Recovery Funds Final Rule, the standard allowance for revenue loss in the amount of \$1,362,040.24.

**Section 3**. The City Council expresses its intent and authorization to expend a portion of the City's allocated ARPA funds for expenses, which the Council deems eligible, necessary and appropriate, as identified below:

A. Water infrastructure

**Section 4**. Compliance with the American Rescue Plan Act. The City will ensure compliance with prevailing Federal guidance at the time the funds are committed for expenditure.

**Section 5**. Nothing in this resolution shall be construed as taking the place of any action otherwise required by the City Council to approve requisite contracts, exercise its budgetary authority, or establish appropriate programs and regulations in conjunction with preliminary expenditures outlined above.

Section 6. This Resolution shall become effective immediately from and after its passage.

### **BACKGROUND:**

We've received final TCEQ approval for Phase 2 of the disinfection conversion process we started about a year ago in conjunction with the Lubbock water interconnect. As you will recall, we are currently operating our chloramine disinfection system with a semi-automated process (Phase 1). We planned all along to fully automate the process, which is Phase 2. This final phase consists of the installation of a PAX mixing/dosing system along with required tank and piping modifications. We've received a Bid Proposal from UCA for the installation, a copy of which is attached. Their price is \$480,375. We've also received a letter from Kimley Horn recommending the award of this bid, a copy also attached.

We anticipate about 60 days to complete the project.
