#### **REGULAR AGENDA**

1. Discussion and Take Appropriate Action on a Resolution Continuing the Declaration of Disaster for the City of Woodcreek: Severe Freezing Weather and Power Outages

Each Councilmember spoke about their experiences, including communications with neighbors, and preparations. Councilmembers also discussed learning from the experience and ideas for the future. Councilmember Pulley's written statement was read.

City Manager Lewis spoke about responses from PEC and Aqua TX as well as the lack of infrastructure during that time. He said that there will be attending a Hays County follow-up meeting soon.

Mayor Whitehead expressed that Woodcreek handled a very difficult situation well and that the city will be reviewing and assessing emergency readiness.
