CALL TO ORDER

The meeting was called to order at 2:06 PM.

4. Discuss and Take Appropriate Action on a Resolution of the City of Woodcreek Supporting a Woodcreek Neighborhood Watch Program and Neighbor - to - Neighbor Program

Mayor Whitehead read the appointments to the Woodcreek Parks and Recreation Board and thanked the individuals who applied, along with previous members.

5. Presentation and Discussion on the Wimberley Trails Project

Presentation and Discussion on the Wimberley Trails Project was given by Natalia Riusech and Walter Heard of CD&P. A community-wide survey will be conducted from Feb. 25 - Mar. 22, 2021 on WimberleyValleyTrails.com.

A roll call vote was held.

The motion passed with a 5-0-0 vote.


