CALL TO ORDER ROLL CALL AND ESTABLISH QUORUM PUBLIC COMMENTS

Any citizen shall have a reasonable opportunity to be heard at any and all meetings of the Tree Board in regard to: (1) any and all matters to be considered at any such meeting, or (2) any matter a citizen may wish to bring to the Board's attention. No member of the Governing Body may discuss or comment on any citizen public comment, except to make: (1) a statement of specific factual information given in response to the inquiry, or (2) a recitation of existing policy in response to the inquiry. Any deliberation of or decision about the subject of the inquiry shall be limited to a proposal to place the subject on the agenda for a subsequent meeting per Texas Local Government code Sec. 551.042.

Citizen comments will be allowed at the beginning of every meeting, or alternatively, before an item on the agenda on which the citizen wishes to speak is to be considered. All citizens will be allowed to comment for three (3) minutes per person and shall be allowed more time at the Chairperson's discretion. In addition, citizens may pool their allotted speaking time. To pool time, a speaker must present the names of three (3) individuals present in the audience who wish to yield their three minutes. Citizens may present materials regarding any agenda item to the City Secretary at or before a meeting, citizens attending any meeting are requested to complete a form providing their name, address, and agenda item/concern, but are not required to do so before speaking and presenting it to the City Secretary prior to the beginning of such meeting. Comments may only be disallowed and/or limited as per Government Code § 551.007(e).

Submit written comments by email to woodcreek@woodcreektx.gov by noon on the day prior to the meeting. Please include your full name, home or work address, and agenda item number. Written comments will be part of the official written record only. A recording of the meeting will be made and will be available to the public in accordance with the Texas Public Information Act upon written request

List of Items to Consider for RPF for a City Arborist

(Created and shared by Councilmember Hines via Council request and vote.RFP)

There are 3 different roles or jobs identified under the jurisdiction of a City Arborist. It should be determined if the City shall seek one individual or company to serve in all 3 roles or 3 different contracts.

- 1) Regular tree maintenance and care on city owned property (parks, greenspace, right-of-way): includes Right-of-Way trimming, management of diseased and dying trees, removals and pruning, and managing tree health (services could include mulching, fertilizing, ball moss removal, etc.)
- 2) Response to private properties over tree concerns (tree removal, permits, consultations, etc.)
- 3) Oak Wilt specialist to diagnose, remove, and provide mitigation

The City MUST contract a Certified Arborist.

Oak Wilt is a special "qualification" and is required to diagnose Oak Wilt and/or provide mitigation services.

Things to consider when writing the RFP:

- 1) They need to have their own insurance
- 2) Will the City Arborist respond to calls on private property or ONLY deal with City owned trees?
- 3) If they respond to calls on private property, can they accept jobs or provide bids to residents as a result of this interaction?
- 4) Establish clear guidelines for a City Arborist's role regarding citizen interactions
- 5) Shall they review tree trimming and removal permits inspecting the trees?

The fees for services such as diagnosis or consultation vary significantly from the more labor-intensive work of maintenance, removal, trimming, etc. This fact should be considered when establishing the contract and budget for the different t
