It is anticipated that members of other City Boards, Commissions, Panels and/or Committees may attend the meeting in numbers that may constitute a quorum of the other City Boards, Commissions, Panels and/or Committees. Notice is hereby given that this meeting, to the extent required by law, is also noticed as a meeting of the other City Boards, Commissions, Panels and/or Committees of the City, whose members may be in attendance. The members of the City Boards, Commissions, Panels and/or Committees may participate in discussions on the items listed on this agenda, which occur at this meeting, but <u>no action</u> will be taken by those in attendance unless such action item is specifically listed on an agenda during a regular or special meeting for the respective Board, Commission, Panel and/or Committee subject to the Texas Open Meetings Act.

The City Council may retire to Executive Session any time during this meeting, under Texas Government Code, Subchapter D. Action, if any, will be taken in open session.

This agenda has been reviewed and approved by the City's legal counsel and the presence of any subject in any Executive Session portion of the agenda constitutes a written interpretation of Texas Government Code Chapter 551 by legal counsel for the governmental body and constitutes an opinion by the attorney that the items discussed therein may be legally discussed in the closed portion of the meeting considering available opinions of a court of record and opinions of the Texas Attorney General known to the attorney. This provision has been added to this agenda with the intent to meet all elements necessary to satisfy Texas Government Code Chapter 551.144(c) and the meeting is conducted by all participants in reliance on this opinion.

Any citizen shall have a reasonable opportunity to be heard at any and all meetings of the Governing Body in regard to: (1) any and all matters to be considered at any such meeting, or (2) any matter a citizen may wish to bring to the Governing Body's attention. No member of the Governing Body may discuss or comment on any citizen public comment, except to make: (1) a statement of specific, factual information given in response to the inquiry, or (2) a recitation of existing policy in response to the inquiry. Any deliberation of or decision about the subject of the inquiry shall be limited to a proposal to place the subject on the agenda for a subsequent meeting per Texas Local Government code Sec. 551.042

Citizen comments will be allowed at the beginning of every meeting, or alternatively, before an item on the agenda upon which the citizen wishes to speak is to be considered. All citizens will be allowed to comment for **three (3) minutes** per person and shall be allowed more time at the Mayor or Chair's discretion. In addition, citizens may pool their allotted speaking time. To pool time, a speaker must present the names individuals present in the audience who wish to yield their three(3) minutes. Citizens may present materials regarding any agenda item to the City Secretary at or before a meeting, citizens attending any meeting are requested to complete a form providing their name, address, and agenda item/concern, but are not required to do so before speaking and presenting it to the City Secretary prior to the beginning of such meeting. Comments may only be disallowed and/or limited as per Government Code § 551.007(e).



RE: Traffic Schedule Ordinance Review

Dear Mr. Rule:

Freeland Turk has reviewed the attached Traffic Schedule Ordinance, which calls for the placement, installation, and erection of traffic control signs and devices throughout the City of Woodcreek. We concur with traffic control sign installations listed in this ordinance, except for the locations discussed below.

Brookhollow Dr. – Augusta – Jack Miller Dr. Intersections

The ordinance calls for a stop sign at the northwest approach to the Brookhollow Dr. and Augusta Dr. three-way intersection. The ordinance also calls for a stop sign at the southeast approach to the Brookhollow Dr. and Jack Miller Dr. three-way intersection.

Based on the guidance provided in the Texas Manual on Uniform Traffic Control Devices (TMUTCD), we recommend <u>against</u> the installation of stop signs at these two locations for the following reasons:

- The observed combined volume of vehicles, bicycles, and pedestrians is low.
- The approach angles to the intersections are 90 or near 90 degrees.
- The approach speed limits are low (25 mph).
- The sight distance available at each approach is good, with no notable obstructions.
- There are no potential conflicts with established pedestrian crossing or school walking route.
- Stop signs should be placed on opposing approaches to an intersection, creating a multiway (all) stop condition at two intersections, approximately 200' apart. Given the low combined volume of vehicles, bicycles, and pedestrians, these intersections do not meet the guidance criteria for multi-way stop intersections.

Woodcreek Drive - Pro Lane - Brookhollow Dr. Intersections

Stop signs exist on all three approaches to these intersections, making them multi-way (all-stop) intersections. Based on our observations, these intersections probably do not meet guidance criteria for multi-way stop applications (see below).

- Installation of multi-way stop control should be based on an engineering study. Freeland Turk is not aware of any prior engineering study for these intersections.
- Multi-way stop control can be used as an interim measure to accommodate traffic control signals, which do not apply at these intersections.
- Multi-way stop intersections should be considered if 5 for more reported crashes in a 12-month period. Freeland Turk is not aware of any crashes that have been reported at this location.
- Multi-way stop intersections should be considered if the vehicular traffic entering them averages at least 300 v/hr for 8 hours on an average day. Based on our observations, the traffic volume at these intersections is probably below the averages cited in this criteria.
- Multi-way stop intersections should be considered if combined vehicular, pedestrian, and bicycle volume averages at least 200 units for the same hours. Based on our observations, the combined vehicular, pedestrian, and bicycle traffic volume at these intersections is probably below the averages cited in this criteria.

The stop signs on the Woodcreek Dr. approaches at these two intersections may be considered for removal.

AMENDMENT TO CHAPTER 70 OF THE CODE OF ORDINANCES TRAFFIC SCHEDULES ORDINANCE

AN ORDINANCE AMENDING THE CITY OF WOODCREEK CODE OF ORDINANCES AT TITLE VII ("TRAFFIC CODE"), CHAPTER 70 ("TRAFFIC SCHEDULES"), SCHEDULE II ("STOP AND YIELD INTERSECTIONS"); PROVIDING FOR ENACTMENT, REPEALER, SEVERABILITY, CODIFICATION, AND EFFECTIVE DATE, AND FINDING PROPER NOTICE AND MEETING.

- **WHEREAS,** pursuant to Texas Local Government Code Section 311.002, a municipality has exclusive control over highways, streets and alleys of the municipality and may regulate a street; and
- **WHEREAS,** pursuant to Texas Transportation Code 544.002, municipalities have the authority to place and maintain traffic control devices on streets under their jurisdiction; and
- **WHEREAS,** the City Council finds that controlling and managing the flow of traffic on its major through streets protects the welfare and safety of its citizens and their personal property and that this regulatory behavior is for good government and order of the City.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Woodcreek:

1. FINDINGS OF FACT

The foregoing recitals are incorporated into this Ordinance by reference as findings of fact as if expressly set forth herein.

2. ENACTMENT

Chapter 70 ("TRAFFIC SCHEDULES") of the Code of Ordinances of the City of Woodcreek is amended at Schedule II.-Stop and Yield Intersections so as to read in accordance with Attachment A, which are attached hereto and incorporated into this Ordinance for all intents and purposes.

3. REPEALER

All ordinances, resolutions, or parts thereof, that are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters regulated, herein.

4. SEVERABILITY

Should any of the clauses, sentences, paragraphs, sections or parts of this Ordinance be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with jurisdiction over the matter, such action shall not be construed to affect any other valid portion of this Ordinance.

5. CODIFICATION

The City Secretary is hereby authorized and directed to record and publish the language of Title VII, Chapter 70, Schedule II as amended by this Ordinance, in the City's Code of Ordinances.

6. EFFECTIVE DATE

This Ordinance shall be effective immediately upon its passage and the publication of caption of this ordinance as provided by law.

7. PROPER NOTICE & MEETING

It is hereby officially found and determined that the meeting at which this Ordinance was passed was attended by a quorum of the City Council, was open to the public, and that public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act, Texas Government Code, Chapter 551. 27

(B) Violations and penalties. It is a violation of this schedule to enter a location controlled by a stop or yield sign from a street controlled by a stop or yield sign without stopping or yielding right-of-way as required. Any person, who tampers with, alters, removes, destroys or covers or hinders the visibility of any traffic-control device of the City in a manner which is inconsistent with its use as a traffic-control device violates this schedule. This schedule shall also apply to the taping of signs on the post portion of the stop or yield sign that does not hinder or affect the visibility of the sign itself or the intersection. Any person who violates this schedule or part thereof shall be guilty of a misdemeanor and, upon conviction thereof, shall be punished by a fine of not less than \$1.00 and not to exceed \$200.00. Each incident of violation of this schedule shall constitute a separate offense.

Dear Mr. Rule:

As requested, Freeland Turk has reviewed the Proposed Plan for the Purchase and Placement of Semi-Permanent Speed Cushions to Address Traffic Calming on Residential Streets. The plan recommends installing traffic calming devices in phases throughout the City of Woodcreek. This letter report only addresses the high-priority (red phase) locations on the Placement Map.

The City of Woodcreek does not currently have a traffic calming policy. Therefore, Freeland Turk reviewed traffic calming policies from the Cities of Dripping Springs, Buda, and San Marcos to establish regional practices for evaluating Woodcreek's recommendations. The proposed placement of speed cushions appears to meet regionally acceptable practices. Therefore, Freeland Turk has no objections to installing traffic cushions at the high-priority locations on the Placement Map. Please refer to the attachment.

However, we suggest the City of Woodcreek install digital speed indicator signs at the proposed locations before installing the traffic cushions. These sign types have proven traffic-calming qualities and may be more acceptable to the traveling public. Once installed, vehicle speeds in these locations should be monitored for traffic calming effectiveness. The traffic cushions should be installed only if the impact of the speed signs is unsatisfactory.




