PUBLIC COMMENTS

Any citizen shall have a reasonable opportunity to be heard at any and all meetings of this Governing Body in regard to: (1) any and all matters to be considered at any such meeting, or (2) any matter a citizen may wish to bring to the Council's attention. No member of the Governing Body may discuss or comment on any citizen public comment, except to make: (1) a statement of specific factual information given in response to the inquiry, or (2) a recitation of existing policy in response to the inquiry. Any deliberation of or decision about the subject of the inquiry shall be limited to a proposal to place the subject on the agenda for a subsequent meeting per Texas Local Government code Sec. 551.042.

Citizen comments will be allowed at the beginning of every meeting, or alternatively, before an item on the agenda on which the citizen wishes to speak is to be considered. All citizens will be allowed to comment for three (3) minutes per person and shall be allowed more time at the Mayor's discretion. In addition, citizens may pool their allotted speaking time. To pool time, a speaker must present the names of three (3) individuals present in the audience who wish to yield their three minutes. Citizens may present materials regarding any agenda item to the City Secretary at or before a meeting, citizens attending any meeting are requested to complete a form providing their name, address, and agenda item/concern, but are not required to do so before speaking and presenting it to the City Secretary prior to the beginning of such meeting. Comments may only be disallowed and/or limited as per Government Code § 551.007(e).

Submit written comments by email to woodcreek@woodcreektx.gov by noon on the day prior to the meeting. Please include your full name, home or work address, and agenda item number. Written comments will be part of the official written record only. A recording of the meeting will be made and will be available to the public in accordance with the Texas Public Information Act upon written request

1. Approval of Comprehensive Plan Advisory Workgroup Meeting Minutes from April 19, 2022

A motion was made by Member Johns to approve the meeting minutes from April 19, 2022. The motion was seconded by Member Moore.

A voice vote was held with all participants indicating "Aye" with no "Nays."

2. Focus Group Reports:

No report was given by the Natural Systems Group or the Physical Systems Group.

Fiscal Systems Group reported that they had a short meeting but are waiting for budget and survey results and that they will be ready when those are provided. The Land Use Group consisting of Co-Chair Hines, Member Johns, and Brandon Melland of K. Friese + Associates met and reported that K. Friese will make future Land Use maps. Co-Chair Hines has written some of the Land Use section and will have everyone review it. K. Friese will provide the Land Use Group with the rules and regulations of the ExtraTerritorial Jurisdiction (ETJ).

3. Introduce the Concept of a Future Land Use Workshop

Co-Chair Hines recommended this workshop and stated that approximately 50% of the Comprehensive Plans she referenced have had a similar workshop. The workshop will allow for decision of the future land use of the ETJ. This may be planned to get resident input as well.

Member Posey made a motion to hold the Future Land Use workshop as soon as possible. The motion was seconded by Member Johns.

A roll call vote was held.

Voting Yea: Co-Chair LeBrun, Co-Chair Hines, Member Camp, Member Johns, Member Moore, Member Posey, Member Tarwater

The motion carried with a 7-0-0 vote.

4. Consider and Discuss Future Survey Options

At discussion, there was a consensus that no survey will be requested until after the Future Land Use Workshop and that one larger survey will be conducted versus several smaller surveys.

5. Discuss Minor Edits of Full Working Draft of Sections: Vision Statement, Background, Basic Outline, Introduction, Overview, Demographics, and Citizen Survey Results

Minor edits were reviewed and suggestions of other minor revisions were incorporated.

6. Discuss Format and Layout

Member Johns volunteered to create a more polished presentation for the document. She will work on several mock-ups.

7. Discuss an Acknowledgements Page

Co-Chair Hines presented a sample acknowledgements page and after discussion the general consensus was to include an acknowledgements page for historical sake. Member Johns will create an example of this page.

8. Discuss Graphs: What More Do We Want to Graph

After discussion, it was agreed that several additional graphs may be included in the plan based on the K. Friese data collection. Such graphs as household income and average home value were considered and a request was made to email Member Camp with additional graph suggestions.

 First Review, Discussion, and Possible Edits of the Following Sections: Environmental Analysis, Land Use (Phase 1), Implementation (Phase 1), Woodcreek and the Wimberley Valley

At discussion, 1) the Environmental Analysis section is waiting for professional maps that Co-Chair Hines is acquiring and getting permission to use, 2) Land Use for the ETJ is coming from K Friese and they are providing a percentage "built-out," 3) Implementation - a consensus to create a timeline of implementation should be included in the Comprehensive

Plan. Suggestions for this timeline can be contributed at this time to Co-Chair LeBrun as she is working on a rough draft.

Co-Chair LeBrun will also be identifying "goals and objectives" for each subgroup.

Comprehensive Plan objectives include:

- a target of 1 acre parkland per 100 people is desired
- creating an economic development plan
- updating the master park plan
- capitol planning policy process all capitol improvements desired and plan for them
- in a Land Use graph compare parkland percentage vs. future goal

<u>Platinum Panel + Comprehensive Plan Advisory Workgroup</u>

Platinum Panel:

DUTIES AS OUTLINED IN THE ORDINANCE: The Platinum Panel shall meet to consider roads, traffic, drainage, and funding sources related to all transportation, including alternative forms with the goal of creating a Master Transportation Plan for the Comprehensive Plan and to establish a timeline and funding choice for road improvements. To accomplish these tasks, the Platinum Panel shall study, investigate, and develop a recommendation or plan to present to Council for approval. This may occur in stages and shall be completed in accordance with any deadlines established by the City Council. The Platinum Panel should be prepared to provide monthly reports at regular meetings of the City Council.

Comprehensive Plan Advisory Workgroup (CPAW):

Tasked with writing the Comprehensive Plan Draft to send to P&Z for review and then ultimately to City Council for approval and adoption into law.

Identified Physical Systems as a Focus Group area for the Comprehensive Plan.

Will rely on a report from the Platinum Panel on this topic to generate this portion of the Comprehensive Plan since their work directly overlaps with this part of the Comprehensive Plan.

This report should include a description of what exists and outline objectives for the city based on the Comprehensive Plan Survey results and existing road studies.
