The members of the City Boards, Commissions, Panels and/or Committees may participate in discussions on the items listed on this agenda, which occur at this meeting, but no action will be taken by those in attendance unless such action item is specifically listed on an agenda during a regular or special meeting for the respective Board, Commission, Panel and/or Committee subject to the Texas Open Meetings Act.

The Commission may retire to Executive Session any time during this meeting, under Texas Government Code, Subchapter D. Action, if any, will be taken in open session.

This agenda has been reviewed and approved by the City's legal counsel and the presence of any subject in any Executive Session portion of the agenda constitutes a written interpretation of Texas Government Code Chapter 551 by legal counsel for the governmental body and constitutes an opinion by the attorney that the items discussed therein may be legally discussed in the closed portion of the meeting considering available opinions of a court of record and opinions of the Texas Attorney General known to the attorney. This provision has been added to this agenda with the intent to meet all elements necessary to satisfy Texas Government Code Chapter 551.144(c) and the meeting is conducted by all participants in reliance on this opinion.

Any citizen shall have a reasonable opportunity to be heard at any and all meetings of the Governing Body in regard to: (1) any and all matters to be considered at any such meeting, or (2) any matter a citizen may wish to bring to the Governing Body's attention. No member of the Governing Body may discuss or comment on any citizen public comment, except to make: (1) a statement of specific, factual information given in response to the inquiry, or (2) a recitation of existing policy in response to the inquiry. Any deliberation of or decision about the subject of the inquiry shall be limited to a proposal to place the subject on the agenda for a subsequent meeting per Texas Local Government code Sec. 551.042

Citizen comments will be allowed at the beginning of every meeting, or alternatively, before an item on the agenda upon which the citizen wishes to speak is to be considered. All citizens will be allowed to comment for **three (3)** minutes per person and shall be allowed more time at the Mayor or Chair's discretion. In addition, citizens may pool their allotted speaking time. To pool time, a speaker must present the names individuals present in the audience who wish to yield their three(3) minutes. Citizens may present materials regarding any agenda item to the City Secretary at or before a meeting, citizens attending any meeting are requested to complete a form providing their name, address, and agenda item/concern, but are not required to do so before speaking and presenting it to the City Secretary prior to the beginning of such meeting. Comments may only be disallowed and/or limited as per Government Code § 551.007(e).

# MINUTES

## CALL TO ORDER

Chair Davenport called the meeting to order at 5:05 P.M.

# **PUBLIC COMMENTS**

No Public Comments were offered.

## **CONSENT CALENDAR**

#### 1. Approval of Regular Planning and Zoning Meeting Minutes from December 7, 2022.

Chair Davenport introduced and welcomed Roger Gordon as Interim City Attorney to the Commissioners in attendance.

A motion was made by Vice-Chair Johns to approve the minutes from December 7th. (2:10) The motion was seconded by Commissioner Sonnier.

A roll call vote was held.

Voting Yea: Vice-Chair Johns, Commissioner Palm, Commissioner Sonnier, Chair Davenport. The motion passed with a 4-0-0 vote.

### REPORTS FROM OFFICERS AND COUNCIL LIAISON

#### Report by City Manager.

City Manager Rule mentioned that the Ordinance Review Committee met the previous evening and he was tasked with presenting their findings, post review of the Short-Term Rental documents to Planning and Zoning.

The Ordinance Review Committee was charged with looking for inconsistencies or duplications and came up with four(4) items:

- 1. §156.009 STR definition and make sure it is updated with future Ordinances;
- 2. §110.002 "Bed and Breakfasts" are defined as hotels, not short-term rentals;
- 3. HOT applicability to STRs; and
- 4. There is not a "#1" on the next to last page.

City Manager Rule offered to email the list of items from the Ordinance Review Committee to the Planning and Zoning Commissioners.

### Report by Ordinance Review Committee Liaison.

#### Report by Planning and Zoning Commission Liaison.

Council Liaison Hambrick introduced himself and his history with previous development plans (i.e. Tiny House Development). Stated he is here to listen and learn.

### **NEW BUSINESS**

#### 1. Workshop to Review the DRAFT Short-Term Rental Documents.

Chairperson Davenport opened the Workshop at 5:14PM.

He stated that the documents have not changed since the last meeting. He will update the documents with the recommendations and add a revision date.

Chair Davenport requested that Roger Gordon review the STR documents and provide a legal opinion, City Manager Rule approved. Mr. Gordon also offered to send out two(2) legal opinions regarding STRs that could be used as a roadmap for established regulations.

Mr. Gordon stated that the takeaway from these 100+ page caselaw opinions is that courts consider property owners to have a "fundamental and settled property right to lease one's real estate under the most desirable terms". Any efforts to create a blanket prohibition of STRs would be subject to strict scrutiny and would require showing a need to do so. That does not mean that they cannot be regulated.

Key to regulations is not to ban, but to enforce. Tools to enforce regulations may already be built into the City's Ordinances. For example, regulations on Parking and Noise already exist in the City's Ordinances.

He believes that a good framework exists, but he will provide feedback on the documents at the next meeting. Suggested the use of City Manager Rule as a conduit in all communications.

Chairperson Davenport closed the Workshop at 6:25PM.

## 2. Discuss and Take Appropriate Action on Revising the Short-Term Rental Documents.

A motion was made by Vice-Chair Johns to make a request to Council to fund a Public Hearing to review the Short-Term Rental documents pending the final draft approval by Planning and Zoning. Motion was seconded by by Commissioner Sonnier.

A roll call vote was held.

Voting Yea: Commissioner Palm, Commissioner Sonnier, Chair Davenport, Vice-Chair Johns

The motion passed with a 4-0-0 vote.

A motion was made by Vice-Chair Johns to table the revision of the Short-Term Rental documents pending a legal review. (1:22) The motion was seconded by Commissioner Sonnier.

A roll call vote was held.

The motion passed with a 4-0-0 vote.

OFFICE OF THE CITY ATTORNEY **Memorandum to P&Z/City Council** Zoning Revision Public Notice/Hearings

MEETING DATES: (Planning & Zoning) Feb. 1, 2023 / (City Council) Feb. 8, 2023

#### **SUMMARY:**

Chapter 211 of the Texas Local Government Code ("LGC") sets forth the statutory requirements of public notice, submittal of final report, and public hearings required before the governing body may enact substantive regulatory or boundary changes to the City's zoning regulations. Pursuant to instructions by the Planning & Zoning (P&Z) Commission and City Council, the City Attorney submits this memorandum outlining the deadlines, public notice, & public hearing requirements.

#### **PROCEDURE**:

The P&Z Commission shall make a preliminary report to the City Council and hold public hearings on that report before submitting a final report to the City Council containing its recommendations on proposed regulatory or boundary changes. Before the 10<sup>th</sup> day before the hearing date, written notice shall be sent to all affected property owners, as indicated by the most recent tax roll, informing them of the proposed changes and scheduled dates for public hearing(s).

## **PROPOSED NOTICE:**

Assuming public hearings to occur beginning March 1, 2023 (P&Z), and a future date thereafter as shall be determined by the City Council, the City Attorney recommends that staff mail public notice of the proposed zoning ordinance amendments containing public hearing date(s) to affected owners of the City of Woodcreek, Texas, *on or before* <u>FEBRUARY 16, 2023</u>. Such notices should include sufficient description of the proposed amendments at issue, along with the date of public hearings to be held by the Commission and City Council, and information on submitting comments for consideration.

#### **PROPOSED MEETING DATES:**
