All 25 trees bought for Tree Giveaway have been claimed. 11 more people are currently on the waitlist. Krista putting on next City council agenda to purchase additional trees cost \$250. Iris will reach out to We Love Trees to see if they will plant the tree and be available for questions. Plan B would be to have Becket Land Improvement plant the tree. Cheryl Mills would like to purchase a banner for Tree Give-Away at a cost of \$153. Communication with Parks Board as to where tree should be planted at Augusta Park. Arrive at 8:00 AM on event date for set up.

Motion was made by Iris Ramos to request from City council additional money to purchase 25 more trees for give-away and seconded by Terri Burney-Bisett.

A vote by show of hands was called motion passed 4-0-0

- 4. Discuss status and implementation of tree care management plan committee regarding collaboration and interviewing with certified arborist (We Love Trees) for select trees (i.e.: removing dead trees and replacing with potential new plantings. (Ramos) The management committee is looking into removal of dead trees and replacing with new after removal. They will also look into the cost estimate of trees, no oaks. Wants to clean up islands on Brookmeadow. Oak wilt assessments by we love trees., and coordination with Jim Burdon of city hall.
- **5.** Status report regarding giveaway saplings' health with discussion re ongoing needs and maintenance. (McElroy)

  Cheryl Mills will contact Jacob McElroy about sapling health
- **6.** Status and Discussion re plans for seasonal community education—posters for Oak Wilt and Tree Trimming; reviewing and refreshing educational materials in shed bin. (Newton, Burne-Bissett)
  - Discussion on purchasing community posters for Oak wilt and tree trimming. Terri Burney-Bisett and Judy Newton are going to try and get new materials for give-away.
