Notice is hereby given that this meeting, to the extent required by law, is also noticed as a meeting of the other City Boards, Commissions, Panels and/or Committees and/or Committees of the City, whose members may be in attendance. The members of the City Boards, Commissions, Panels and/or Committees may participate in discussions on the items listed on this agenda, which occur at this meeting, but <u>no action</u> will be taken by those in attendance unless such action item is specifically listed on an agenda during a regular or special meeting for the respective Board, Commission, Panel and/or Committee subject to the Texas Open Meetings Act.

The Panel may retire to Executive Session any time during this meeting, under Texas Government Code, Subchapter D. Action, if any, will be taken in open session.

This agenda has been reviewed and approved by the City's legal counsel and the presence of any subject in any Executive Session portion of the agenda constitutes a written interpretation of Texas Government Code Chapter 551 by legal counsel for the governmental body and constitutes an opinion by the attorney that the items discussed therein may be legally discussed in the closed portion of the meeting considering available opinions of a court of record and opinions of the Texas Attorney General known to the attorney. This provision has been added to this agenda with the intent to meet all elements necessary to satisfy Texas Government Code Chapter 551.144(c) and the meeting is conducted by all participants in reliance on this opinion.

Any citizen shall have a reasonable opportunity to be heard at any and all meetings of the Governing Body in regard to: (1) any and all matters to be considered at any such meeting, or (2) any matter a citizen may wish to bring to the Governing Body's attention. No member of the Governing Body may discuss or comment on any citizen public comment, except to make: (1) a statement of specific, factual information given in response to the inquiry, or (2) a recitation of existing policy in response to the inquiry. Any deliberation of or decision about the subject of the inquiry shall be limited to a proposal to place the subject on the agenda for a subsequent meeting per Texas Local Government code Sec. 551.042

Citizen comments will be allowed at the beginning of every meeting, or alternatively, before an item on the agenda upon which the citizen wishes to speak is to be considered. All citizens will be allowed to comment for **three (3)** minutes per person and shall be allowed more time at the Mayor or Chair's discretion. In addition, citizens may pool their allotted speaking time. To pool time, a speaker must present the names individuals present in the audience who wish to yield their three(3) minutes. Citizens may present materials regarding any agenda item to the City Secretary at or before a meeting, citizens attending any meeting are requested to complete a form providing their name, address, and agenda item/concern, but are not required to do so before speaking and presenting it to the City Secretary prior to the beginning of such meeting. Comments may only be disallowed and/or limited as per Government Code § 551.007(e).

THE CITY OF WOODCREEK **ORDINANCE NO. 24-332**

4 AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF WOODCREEK, TEXAS, AMENDING THE CITY OF 5 WOODCREEK CODE OF ORDINANCES AT TITLE III ("ADMINISTRATION"), CHAPTER 30 ("OFFICIALS, EMPLOYEES 6 AND ORGANIZATIONS"); PROVIDING FOR THE CREATION OF THE INFRASTRUCTURE AND MOBILITY PANEL. 7

- 8 WHEREAS the City of Woodcreek ("City") is a Texas General Law Municipality operating 9 under the laws of the State of Texas; and
- 10 WHEREAS City Council has previously created a Platinum Panel to (1) advise the City Council on 11 roads, traffic, drainage and funding sources related to all transportation, including 12 alternative forms; (2) secure public input in this process; and (3) promote transparency 13 in the process of creating a Master Transportation Plan and assist in advising on 14 decisions to secure funding for road improvements. The Platinum Panel shall be viewed 15 as an independent body; and
- 16 WHEREAS the City Council finds and determines it in the best interests of the City to revise the 17 scope of work, structure of said Panel and to rename it; and
- 18 WHEREAS the City Council of the City of Woodcreek, Texas finds that these amendments to the 19 Code of Ordinances follow state law.

21 NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOODCREEK, TEXAS, THAT:

- 23 The foregoing recitals are found to be true and correct and are hereby adopted by the City Section 1. Council and made a part hereof for all purposes and findings of fact.
- 25 Section 2. The City Code of Ordinances at Title III, Chapter 30 ("the "Code"), is hereby amended to repeal sections 30.80 to read as follows: 26
- 28
 - § 30.80 Popular Name
 - This subchapter shall be commonly cited as the "Infrastructure and Mobility Panel".
- 31 § 30.81 Purpose
- 32 (A) This subchapter creates an Infrastructure and Mobility Panel ("I&M Panel") whose purpose 33 shall be to make recommendations on road maintenance, traffic safety, drainage and 34 funding sources related to all transportation. To accomplish these tasks, the I&M Panel shall 35 study, investigate and develop plans and recommendations to Council for approval. The I&M 36 Panel should be prepared to provide monthly reports at regular City Council meetings.

38	The scope of the I&M Panel shall include, but not be limited to, the following:
39	i. A Road Maintenance Plan to strategically outline a schedule for the funding and
40	performance of regular road maintenance within the City limits of the City of
41	Woodcreek.
42	ii. A Fiscal Capacity Plan to anticipate and plan for future improvements to existing and
43	proposed infrastructure. This may include, but is not limited to, the following:
44	a) acquisition of new land for the installation of additional parks, trails and
45	other public greenspaces;
46	b) acquisition of new land for the construction of a community meeting place,
47	the expansion of City Hall, or other such governmental properties; and
48	c) physical improvements upon existing public lands, such as parks,
49	greenspaces and other government properties.

51 52	iii. A Drainage and Flooding Mitigation Plan which may include, but is not limited
53	to, the following: a) conduct a study to identify key projects;

	b) seek potentials for outside funding;
55 56	c) create a plan of action, listing a prioritization of proposed projects; and
57	 advise Council on solutions utilizing engineering input and feasibility
58	analysis.
59	iv. A Pedestrian Mobility Plan to address ADA Compliant pedestrian pathways to

62	Territorial Jurisdiction ("ETJ"); and provide for an expansion of trails for the

- (B) The I&M Panel shall be viewed as an independent Advisory Body to the City Council and is hereby given explicit permission to work directly with the City of Woodcreek's contracted City Engineering Firm, through the City Manager, to develop and review plans under their purview, as stated in Section 30.81(A).
 - (C) The I&M Panel shall conduct a biennial review of the plans under their purview, as stated in Section 30.81(A) and provide regular reports to the City Council.
- (D) To conduct this work, the I&M Panel shall seek public input through surveys and Town Halls. Any public survey or Town Hall presentation generated shall be reviewed and must be approved by City Council.
 - (E) The I&M Panel shall promote transparency in their processes.

- (A) <u>Membership</u>: The I&M Panel shall consist of seven(7) Panel Members; five(5) Regular
 Panel Members and two(2) Alternate Panel Members. No member of the I&M Panel may be
 a member of the City Council.
 - (B) <u>Appointment</u>: Each of Woodcreek's five(5) Council Members shall make one(1) Regular Panel Member nomination and the Mayor shall make two(2) Alternate Panel Member nominations, specifically a First and Second Alternate Panel Member. All nominations shall be confirmed by a majority vote of the City Council. In the event that any Council Members, or the Mayor, refuses, or is unable, to make a nomination, the vacancy may be filled by the majority vote of the remaining members of the City Council.
 - (C) <u>Alternate Members</u>: Alternate Members shall sit in the place of an absent Regular Panel Member, with selection being in order of their alternate designation. Alternate Panel Members are encouraged, but not required, to attend all meetings and may participate in all discussions, when present. However, Alternate Panel Members may only vote when sitting in the place of an absent Regular Panel Member.
 - § 30.83 Terms, Resignation, Vacancy & Removal
- (A) The terms of Regular and Alternate Panel Members shall coincide with the term of the Council Member and Mayor who nominated the Panel Member and will expire upon the Nominating Officer's term of office ending. In even numbered years, three(3) newly elected members of Council shall make a nomination for a Regular Panel Member. In odd numbered years, two(2) newly elected members of Council shall make a nomination for a Regular Panel Member and the newly elected Mayor shall make a nomination for two(2) Alternate Panel Members.
- 119(B) Any Panel Member may resign by submitting written notice to the City Secretary, as the120Records Management Officer for the City. Resignations will be effective when received.121Upon receipt of resignation, the City Secretary shall as soon as administratively possible,122send such resignation to the Chairperson, The Mayor and the Panel Liaison.

123 (C) All vacancies shall be filled on a nomination from the Council Member who nominated the Resigning Panel Member. Upon confirmation by a majority vote of Council, the newly 124 125 appointed Panel Member shall fill the unexpired term of the vacated seat. 126 (D) Members may be removed from the I&M Panel by a majority vote of the Council Members. 127 By a majority vote, the I&M Panel may make a recommendation to the Council regarding the 128 removal of a member of their Panel. 129 (E) Members of the I&M Panel shall continue to serve on the Panel until their replacement has 130 been appointed by Council, unless the Panel Member submits a letter of resignation, in 131 which case, the Panel Member shall have no further authority, duties or obligations in regard 132 to the Panel. 133 (F) To be considered for appointment or re-appointment to the I&M Panel, a Volunteer 134 Application must be completed and submitted to the City Secretary, as the Records 135 Management Officer for the City. City Staff shall present all completed Volunteer 136 Applications to the Council for their consideration of I&M Panel appointments. 137 § 30.84 Duties & Meetings 138 (A) The I&M Panel shall meet at such regular and special times as necessary to efficiently carry 139 out the Panel's purpose. Regular meetings are to be set by order of the Panel and Special 140 Meetings are to be called by the Chairperson. At a minimum, there shall be two(2) meetings 141 per year. 142 (B) Any recommendation of the I&M Panel shall result from a majority vote of the Regular Panel 143 Members. However, any recommendation is merely a recommendation and is not binding 144 on the City Council. Any final decision on topics for which the I&M Panel has made a recommendation rest with the City Council. 145 146 § 30.85 Officers 147 (A) The I&M Panel shall choose its own Officers from among its Regular Panel Members. Officers 148 shall be elected for terms of one(1) year by majority vote of all its membership present and 149 voting, including Alternates Panel Members. Officers shall include Chairperson, Vice-150 Chairperson and a Secretary. 151 (B) The Chairperson's sole duty shall be to preside over all meetings in accordance with any 152 rules the I&M Panel may establish. The Chairperson may vote. If the Chairperson fails or 153 refuses to act, the Vice-Chairperson shall perform the duties of the Chairperson. If the 154 Chairperson and Vice- Chairperson are absent, any Panel Member may be appointed by the 155 Panel to preside over the meeting. The Panel shall keep minutes of its proceedings. A 156 majority of the Regular Panel Members shall be a quorum for the transaction of business. (C) The Secretary's sole duty shall be to record the minutes of the meetings. Minutes are to be 157 158 held by the City. 159 § 30.86 Open Meetings Act 160 The Infrastructure and Mobility Panel shall comply with the Texas Open Meetings Act. The agenda will include a Public Comments Section, allowing the Public the right to speak. 161 162 163

164 **SEVERABILITY CLAUSE**: Should any of the clauses, sentences, paragraphs, sections or parts of this 165 Ordinance be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with 166 jurisdiction over the matter, such action shall not be construed to affect any other valid portion of this Ordinance. 167 All provisions of this Ordinance are declared severable.

168 **CUMULATIVE CLAUSE**: This Ordinance shall be cumulative of all provisions of ordinances of the City 169 except where provisions of this Ordinance are in direct conflict with the provisions of such ordinances, in which 170 event the conflicting provisions of such ordinances are hereby repealed.

171 **REPEALER CLAUSE**: All Ordinances, Resolutions, or parts thereof, that are in conflict or inconsistent with any
 172 provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance
 173 shall be and remain controlling as to the matters regulated, herein.

174 **SAVINGS CLAUSE:** The repeal or amendment of any ordinance or part of ordinances effectuated by the 175 enactment of this ordinance shall not be construed as abandoning any action now pending under or by virtue of 176 such ordinance or as discontinuing, abating, modifying, or altering any penalty accruing or to accrue or as affecting 177 any right of the City of Woodcreek under any section or provisions of any ordinances in effect at the time of the 178 passage of this Ordinance.

PROPER NOTICE AND MEETING: It is hereby officially found and determined that the meeting at which this
 Ordinance was passed was open to the public as required and that public notice of the time, place and purpose of
 said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code. Notice
 was also provided as required by Chapter 52 of the Texas Local Government Code.

183 ENACTMENT: This Ordinance shall be in full force and effect after its final passage and approval, as required by184 law.
