#### **RECOMMENDATION MOTION:**

Insurance

Move to Approve Purchase of a New Ambulance with Power Load/Cot System from Braun NW, Inc. in the Amount of \$205,871.

#### **SUMMARY STATEMENT:**

The Wrangell Fire Department is seeking to purchase a new F-350 Ford Braun Ambulance. The vehicle sought is nearly identical to the two existing City ambulances, allowing for seamless integration to the EMS line serving the community.

Health and wellbeing of our community remains of utmost importance. The current SARS CoV2 (COVID-19) Pandemic has highlighted many gaps in the healthcare industry, not only globally but also here on a local level. One of these identified has been the need for another transport vehicle. If at any time the ambulance that is used for COVID "screened positive" or confirmed positive patients, it will be out of service for upwards of 3 hours for the cleaning process alone. If there are maintenance needs for an ambulance, or it is involved in another call, the response will be delayed. In a community with no other EMS provider, this is unacceptable.

Here is bit of an overview of the steps and procedures that we have taken to make it possible to transport a potential COVID-19 patient:

- It starts with the 911 call where the dispatcher is screening patients. The recommended questions are asked about symptoms, including flu-like symptoms, fever, diarrhea, change in taste or smell, whether the patient has traveled recently or had contact with anyone who has tested positive for COVID-19. A yes answer to any of the screening questions requires this person to be categorized as "positive screen." When it cannot be determined (because the patient is unresponsive, inebriated or cannot speak or the caller does not know) it is also treated as a positive screen.
- Ambulance responds with only 2-3 EMT's to reduce potential for exposure and keep PPE use to a minimum.
- When the ambulance arrives, only one EMT will approach the patient, and they repeat the series of questions and assess the patient, rather than the whole crew entering the home.
- The EMT's will be wearing PPE which include mask, eye protection and gloves. Answers from the initial 911 or from the secondary screening could also require the EMT's to don gowns and full-face shields, and N95 masks. A procedural mask is given to the patient as well.

Due to the contagious nature of this virus, changes were made to the interior of the patient compartment of the ambulance used for positive screen calls:

- Plexiglass was installed between open compartments and the front access space.
- Supplies were minimized to accommodate a single patient and all items have been placed into Ziplock® bags.
- Blankets and sheets have been removed, along with any permeable coverings and medical bags. Only wipeable surfaces are exposed.
- The vent remains on to help exhaust the compartment during transport.

#### Arrival at the ER:

• Upon arrival at the ER, for a stable patient, who screens positive for COVID-19, the nurse assesses the patient inside the ambulance, and makes the decision to move the patient into the hospital or wait for the physician to examine the patient. (This helps reduce PPE used

- by the EMS and nursing staff. Moving the patient into the hospital requires all EMS to doff their PPE upon exit and re-don PPE to clean and decontaminate the ambulance.)
- An unstable patient, regardless of the screening determination will be brought into the ER immediately upon arrival.

Following a "positive screen" patient transfer to the hospital:

- Ambulance goes through full "front to back" cleaning and decontamination routine including the driver's compartment.
- All items are removed, surfaces are wiped down to clean any large, grossly contaminated areas.
- Following this, a bleach solution is sprayed on all surfaces including the ceiling, compartments, handles and drawers.
- This full cycle takes anywhere from 2 ½ 3 ½ hours.

As you can see, this ambulance will be out of service for some time.

Our additional ambulance, #1 Ambulance, has been reserved for any "negative screen" patients and is arranged in such a way that would be difficult and a potential costly burden if used for a "positive screen" or COVID positive patient. What costly burden means is - if a patient who is determined to be infected with the SARS CoV2 virus is transported in an ambulance, as is indicated above, all surfaces need to be properly cleaned and decontaminated. #1 Ambulance has many medical, oxygen, trauma kits, and supplies that are soft sided, permeable surfaces. These would all need to be taken out of service, and may not be able to return to service, depending on the ability to decontaminate them.

Research for the SARS CoV2 strain are ongoing, however other Human Coronaviruses have been researched and as the Journal of Hospital Infections reports, "On different types of materials, it can remain infectious for from 2 hours up to 9 days." The unknown for this virus require our EMS crew to remain diligent in their cleaning and decontamination processes and procedures. Not only for the next patient that this ambulance will be transporting, but also for their own protection during this process and future responses.

Should either of our ambulances need to have maintenance completed and be out of service, this will also place EMS in a challenging position. Every vehicle needs ongoing preventative maintenance. This can be scheduled; however, illness and injuries happen at any time.

One specific event which took place on Sunday, May 17th, 2020 also made this need apparent. On this afternoon, there were 4 calls all together in a short timeframe. One a medical call for patient with difficulty breathing and other cardiac related issues. The next was a medevac which require EMS to assist from the hospital to the airport and assist onto the awaiting aircraft. During this second call, a third call for a trauma patient was received. The #1 Ambulance was in use transporting a patient, so the option was to use the COVID ambulance, #2, which has limited resources as noted above. During the treatment of this patient, it was identified that this person was seriously injured and required more supplies. The #1 Ambulance rapidly loaded the patient onto the aircraft and responded to the scene of the second call. EMS responders were in and out of both ambulances to obtain supplies and then further the patient was transported with #1

ambulance. Following this, there was another medevac call. Should any of the patients this day been determined to be positive for SARS CoV2 (COVID-19), this would have hindered the response substantially, removing ambulances and crews from service.

We cannot be afraid of SARS CoV2 (COVID-19). We need to be informed, educated and prepared. It is through this preparation and information gathering the need for an additional transport vehicle has been made very apparent in the light of the SARS CoV2 Pandemic.

Wrangell is fortunate to have a great group of volunteers who are dedicated to the community and their crew. With no specific immunization developed for this virus, it is crucial that prevention strategies and early containment practices and are followed to stop future spread. We believe that part of this prevention will be to have dedicated ambulances ready to help EMS respond effectively and safely.

It is critical this third ambulance be in place soon as Wrangell continues to open up and more seasonal workers and visitors are in the community. To get an ambulance into the fleet in a short time period one must be purchased "off the lot" rather than pre-ordered to certain specifications. Quotes were obtained for two rigs available for purchase now. The one proposed for purchase from Braun NW is an F-350 with the same chassis as our existing ambulances. The Braun vehicle is also offered at a price pre-negotiated under a competitive government contract. The other quote is for an F-450 rig at a substantially higher price (\$199,856).

Included in the package is a power cot and load system. The necessity for this equipment is that it allows for minimal staffing to load a patient into a transport vehicle – reducing the number of people on a call to 2-3 – rather than several necessary to manually lift a patient into the back of a rig. There is only one manufacturer of the power load system, so it will be the same cost in any vehicle. In this instance, Braun will acquire and install the system in the ambulance before it is shipped north.

As you can see, this ambulance will be out of service for some time.

Stryker Medical certifies that we are the sole manufacturer of the Stryker EMS Power-LOAD cot fastener (Model 6390). This correspondence is to inform you of the characteristics of the Power-LOAD Cot Fastener. These characteristics can be broken down into two primary categories: Independent Qualification and Ease of Use.

The Stryker EMS Power-LOAD (Model 6390) cot fastening system is mounted within the patient compartment and is intended to aid in the loading/unloading of patients. The Stryker Power-LOAD is the only powered cot fastening system that meets the following:

#### **Independent Qualification**

- IPX6: The system is tested to withstand powerful water jets.
- IEC 60601-1 and IEC 60601-1-2: The Power-LOAD cot fastener conforms to industry standards for mechanical and electrical safety for medical electrical devices, as well as electromagnetic compatibility and immunity.
- BS EN-1789:2007, clause 4.5.9 when used with Power-PRO cot and X-Restraints: This is a European dynamic crash test which subjects a 50<sup>th</sup> percentile dummy to nominal 10g deceleration for a minimum of 50ms. Following the test there shall be no sharp edges or danger to the safety of persons in the road ambulance.
- SAE J3027 compliant when used with a Stryker Power-PRO cot and X-Restraints

#### Ease of Use

- Device must provide a linear guide when loading and unloading the cot.
- Device must allow for remote actuation from Power-PRO foot end controls.
- Device must engage to the cot during loading and unloading, providing a means of lifting and lowering.
- Device must have a safe working load of 870 lbs. and be capable of lifting patients weighing up to 700 lbs.
- Device must be mounted inside the patient compartment to prevent environmental exposure and corrosion.
- Device must be power washable.
- Device must be capable of inductively charging the Stryker SMRT cot battery.
