Minutes of Special Emergency Assembly Meeting Held on March 22, 2020

Mayor Stephen Prysunka called the Special Emergency Assembly meeting to order at 3:00 p.m., March 22, 2020, in the Borough Assembly Chambers.

PRESENT (by teleconference): PRYSUNKA, GILBERT, LARRABEE, DELONG (joined at 3:30 p.m.), POWELL, DECKER, MORRISON

ABSENT:

Borough Manager Von Bargen, Borough Clerk Lane, and Dr. Lynn Prysunka were also in attendance.

CONFLICT OF INTEREST – None.

PERSONS TO BE HEARD

Rocky Constantino, Sea Level Seafoods, commented that they would be following the set guidelines that the City sets up.

Diana Nore, resident, stated that she believed that we could be more stringent in socially isolating; concerned about grocery store social distancing.

John Taylor, resident, questioned if the City goes into total shutdown, could he still go to his shop.

Joan Sargent, resident, encouraged anyone who has friends or neighbors coming in, to do their 14-day quarantine; questioned if the City could mandate people to quarantine for 14 days.

Angela Allen, resident, stated that for the community to issue a Shelter in Place order was premature and that people should take responsibility for their own actions that they make when traveling; not being able to do anything recreational seems like it's a little too much at this point.

ITEM(s) OF BUSINESS

13a Consideration of Factors (Shelter in Place Emergency Order)

Von Bargen gave an administrative explanation of what this Order means; Capacity of our hospital could be very quickly overwhelmed; imperative that we try and get in front of this; several other Alaska Communities are issuing similar orders.

Von Bargen went through each of the twelve steps that were outlined in the proposed order.

Prysunka stated that this order at this point, does not restrict people in the community from getting outside and recreating; this keeps stores and hardware stores open as well.

Prysunka asked if we could get rid of the wording "as much as possible"; the Assembly had not objections to removing this language.

At the request of EMS Captain Dorianne Sprehe, the Clinic's phone number be added to number 11.

Prysunka stated that the City is asking Sealevel, the Crossings Program and the Forest Service to curtail all of their staffing increases and/or bringing clients to the island, until May 1, 2020 with a review on April 15, 2020; doing out best to make sure that we can take care of our citizens that are here now.

Decker asked that number 2 in the Order, that we add other things that the Governor had determined to be critical Workforce Infrastructure in his order issued on March 12, 2020 (attachment A), such as fishing and fish processing being one of those critical items since those are part of the food supply industry.

Von Bargen said that she would review and add that to the order.

Decker asked if number 9 could be amended to clarify distancing requirements. Von Bargen stated that she would make the amendment.

Dr. Prysunka stated that there were currently no confirmed cases of COVID-19 in Wrangell; screening is occurring at all SEARHC facilities to reduce risk; taking steps to protect the vulnerable by looking into video calling as a visiting option, possibly doing house calls when necessary, and postponing routine visits. At this time, State is not recommending that if you are a close contact of a person who is being investigated for the virus, that you be taken out of the workforce; would devastate our workforce; able to recommend this since there is increased testing.

Gilbert suggested that for number 13, that wording be added that citizens either call or email the elderly, or their neighbors, to check on their health, concerns, or their needs; some of our community members live by themselves or are elderly and may need assistance.

Tom Rolland, resident and business owner stated that they were planning on going to the online only ordering system and encouraged other grocery stores to do this also.

In response to Decker on the effective date and distribution of this order, Von Bargen stated that the effective date would be today, March 22, 2020 at 6:00 p.m. and we would send this to the media and post. Decker asked if we also get it to the stores around town as well.

M/S: Decker/Morrison to approve Emergency Order 03-22-20.

Larrabee asked how this order would be enforced.

Prysunka stated we could not create a law and put people in jail for not following the order; Police could issue a warning; this is a strong recommendation and not a mandate; not following this order is putting the community at risk.

Motion approved unanimously by polled vote.

Minutes of Regular Assembly Meeting Held on March 24, 2020

Mayor Prysunka called the telephonically held Regular Assembly meeting to order at 6:12 p.m., March 24, 2020. The pledge was led by Assembly Member Gilbert and the roll was called.

PRESENT BY TELECONFERENCE: POWELL, DECKER, GILBERT, LARRABEE, DELONG, PRYSUNKA, MORRISON

ABSENT:

Borough Manager Von Bargen and Borough Clerk Lane were also in attendance via telephone.

CEREMONIAL MATTERS

The Wrangell Public School District's FY2021 Annual Budget was presented.

PERSONS TO BE HEARD

M/S: Gilbert/Powell to remove Agenda Item 15a (Executive Session) from the Agenda. Motion approved unanimously by polled vote.

M/S: Decker/Gilbert to approve the Consent Agenda, as presented. Motion approved unanimously by polled vote.

Mayor Prysunka asked the following community leaders to provide a report:

Leatha Merculieff, Wrangell Medical Center CEO reported on several items including: planning for alternate care sites; long-term care patients relocation, if needed; Wrangell Medical Center and the Long-term care units are on complete lock-down at the moment; asking the community to go directly through the Emergency Room so that you can be pre-screened; all elective procedures have been canceled; Health Fair has been canceled; Appreciates the donation of PPE equipment from community members/businesses; about 100 tests have been performed throughout SEARHC, as a whole; cannot specifically give out the total numbers in Wrangell, due to patient and provider protection; no positive cases currently in Wrangell; supplies here in Wrangell at this time, are adequate; drive-up COVID-19 trailer is up and running; asking residents to call the clinic first and not to simply drive-up to the trailer to be tested; trying to put out weekly press releases (typically Thursday or Friday morning).

Dorianne Sprehe, EMS Captain reported on Command Center Operations with EMS and Fire Response; main goal for the Fire Department is making sure that the Fire and EMS are trained and up to date on all of the new and ever changing protocols; safe and ensuring minimal exposure; utilizing telephonic measures; keeping on top of EOC; NIXLE working very well; reminded the public of the State Mandate with anyone coming from out of state, that they are required to quarantine for 14 days; thanked the grocery stores for creating time for the elders to shop.

Tom Radke, Wrangell Police Chief reported on mandatory travel; taking on educational role at the airport; some people not understanding the rules; reaching out to some people; encouraging people to stay home as much as possible; reported on the mandated order from the Governor.

BOROUGH MANAGER'S REPORT

Von Bargen provided updates on the following:

- Working tirelessly to keep our Community safe
- SEAPA Annual Spring maintenance has been postponed to the Fall due to the COVID-19
- · Working on issues dealing with access to the community
- Finance Director working to get the Budget numbers gathered
- Looking at postponing the Board of Equalization process
- Working on temporary alternate staffing schedules

Decker quested if we could investigate having the local surveyor who works for R&M do the survey for the Institute Property. Von Bargen stated that yes, she could investigate that.

BOROUGH CLERK'S FILE

No report.

MAYOR AND ASSEMBLY BUSINESS

DeLong stated that this was a good time for people to look at our Website at the businesses; thanked Carol for keeping this up.

Morrison suggested that we keep an eye on what's coming out of Washington; might have funding opportunities.

Gilbert reported that the IFA was deemed a critical infrastructure by the Governor and if needed, will run to provide supply services and possibly other emergency service operations.

Decker reported that she spearheaded an initial conversation between Southeast Conference, Southwest Municipal Southwest Association, and Pacific Seafoods Association regarding fish processing and what maybe can happen, working through these difficult times; a lot of upcoming meetings and discussions are forthcoming.

Prysunka spoke about the limitations with our hospital; will be having a joint meeting with Sealevel Seafoods, Alaska Crossings Program, and the Forest Service on April 15, 2020 to discuss how the community and more importantly, the hospital with its limited capacity, would be

impacted with bringing additional people to town to work; will make sure to report to the Assembly.

Prysunka and Von Bargen spoke extensively on the current situation of COVID-19; trying to come up with some state-level strategies; attending numerous teleconferences a day; been in contact with some legislators about concerns that might be coming our way; have to have plans in play, just in case; appreciative to the Governor for giving "teeth" to incoming travelers with regard to traveler requirements.

Minutes of Special Emergency Assembly Meeting Held on April 6, 2020

Mayor Stephen Prysunka called the Special Emergency Assembly meeting to order at 5:30 p.m., April 6, 2020, in the Borough Assembly Chambers.

PRESENT (by teleconference): PRYSUNKA, GILBERT, LARRABEE, DELONG, POWELL,

DECKER, MORRISON

ABSENT:

Borough Manager Von Bargen and Borough Clerk Lane were also in attendance.

CONFLICT OF INTEREST

Prysunka declared a potential Conflict of Interest due to his son owning a Fishing Vessel and he and his wife being shareholders in that business; this action might affect his business. Vice-Mayor Gilbert stated that she did not see a Conflict of Interest; there were no objections from the Assembly.

Decker declared a potential Conflict of Interest due to her family owning a fishing boat operation; Mayor Prysunka declared that she did not see a Conflict of Interest; there were no objections from the Assembly.

DeLong declared a potential Conflict of Interest due to her family having income from the fishing industry; Mayor Prysunka declared that she did not see a Conflict of Interest; there were no objections from the Assembly.

ITEM(s) OF BUSINESS

6a EMERGENCY ORDINANCE No. 977 OF THE ASSEMBLY OF THE CITY AND BOROUGH OF WRANGELL, ALASKA INSTITUTING THREE LOCAL HEALTH MANDATES RELATED TO THE COVID-19 PANDEMIC EMERGENCY: 1) 14-DAY SELF QUARANTINE REQUIRED FOR INTRASTATE TRAVELERS; 2) MODIFIED QUARANTINE IS PERMITTED FOR CRITICAL WORKFORCE INFRASTRUCTURE; AND 3) REQUIREMENT THAT TRAVEL SAFETY AND MODIFIED QUARANTINE PLANS FOR CRITICAL WORKFORCE INFRASTRUCTURE BE SUBMITTED TO THE CITY AND BOROUGH OF WRANGELL FOR APPROVAL, PRIOR TO TRAVEL

Von Bargen gave an administrative explanation of what this Mandate would mean

M/S: Gilbert/Powell to approve Emergency Ordinance No. 977.

Von Bargen provided an administrative report on the proposed Ordinance. Von Bargen stated that the purpose of this Ordinance was to put some safety measures in place that would protect Wrangell while still allowing for commerce in the community.

There were extensive questions from the Assembly which were answered by Von Bargen.

Von Bargen stated that she had received email notification today from SEARHC, that Dr. Bruhl had emailed them to say that SEARHC has one Hub Hospital, which is in Sitka (Mount Edgecumbe Medical Center).

Decker thanked Von Bargen for the information on the HUB Hospital determination but would still like confirmation from the State on if Wrangell Medical Center was considered a HUB Hospital or not.

In response to Decker on who would be receiving the plans and what criteria would be followed, Von Bargen stated that our Parks & Recreation Director as well as Dorianne Sprehe, Police Chief Radke and Harbormaster Meissner would be the initial reviewers.

Von Bargen further stated that we are not looking for anything more complex than what the State is asking for; looking to review and ask the submitter to make modifications, if needed; not looking to create hurdles or roadblocks, just making sure that folks are following guidelines.

M/S: Gilbert/Morrison to amend the ordinance to add the words "or travelers" in Section 7 and after ".... Plan are requested by Borough".

After extensive discussion and clarification by Von Bargen, Gilbert withdrew her amendment to the motion. There were no objections from the Assembly on the withdrawal of the amendment.

M/S: Gilbert/Morrison to amend the Ordinance to approve Manager Von Bargen inserting a sentence in Section 7 that addresses the traveler submitting a modified travel plan or amendment, to be reviewed within 24 hours by the Borough. Amendment to the motion was approved with Gilbert, Larrabee, Morrison, Decker, Powell and Prysunka voting yes; DeLong was not on the line to vote on the amendment.

Hearing no objections from the Assembly, Von Bargen stated that she would additionally add language to Section 8 to allow for Emergency travel situations that need immediate review and approval that would take place immediately and not fall under the 48-hour window. There were no objections to having Manager Von Bargen add the emergency language.

After more extensive information was given and questions answered, the following Persons to be Heard were invited to speak.

PERSONS TO BE HEARD

Brennon Eagle, Fisherman stated that he didn't believe this was something that the Assembly should be trying to demonstrate expertise on; believed that the language in the Ordinance had medical expertise requirements and wasn't comfortable that the Assembly had that expertise. Mr. Eagle stated that in the Ordinance, there were several things that were lacking; among those were the definition of travel relating to what is defined as travel and the sunset date being 6 months in the future seemed too long and should be maybe two or three months.

Chris Guggenbickler, Resident and Fisherman stated that the fishing industry was working on a comprehensive plan; no way intending to increase the liability to the community; stated that he was working on a plan now that would be submitted to the State and the City and would hopefully go through the summer.

Von Bargen stated that with regard to the Sunset Date, it's the same Sunset Date that was used in the Shelter in Place Order; allows for the mandate to be shorter if this is no longer considered a federal or local emergency; Borough would be flexible and work with people on plans to the maximum ability possible; trusting people to do the right thing; asking that people will not "raft up" with other vessels.

Decker commented on what Cordova is requiring; not sure if Cordova was actually reviewing plans, and requesting changes be made.

M/S: Decker/Gilbert amended the Ordinance to have the effective date section read: this ordinance shall be effective on Wednesday, April 8, 2020 at 5:00 p.m.

Decker stated that this would allow for the answer from the State to come in on if Wrangell qualified as a "Small Community"; also there is a meeting tomorrow with Fishing Community Stakeholders, Manager, Mayor and Decker to talk through some details on how to implement this.

Amendment to change the effective date on the Ordinance was approved unanimously by polled vote.

M/S: Powell/Morrison to recess meeting and reconvene on Wednesday, April 8, 2020 at 5:30 p.m. Motion approved unanimously by polled vote.

Special Emergency Assembly meeting **recessed** at 6:59 p.m.

Mayor Stephen Prysunka **reconvened** the Special Emergency Assembly meeting at **5:30 p.m., April 6, 2020**, in the Borough Assembly Chambers.

PRESENT (by teleconference): PRYSUNKA, GILBERT, LARRABEE, DELONG, POWELL, DECKER, MORRISON

ABSENT:

Borough Manager Von Bargen and Borough Clerk Lane were also in attendance.

Prysunka read the motion on the floor: to approve Emergency Ordinance No. 977, amended to approve Manager Von Bargen inserting a sentence in Section 7 that addresses the traveler submitting a modified travel plan or amendment, to be reviewed within 24 hours by the Borough and to have the effective date read: this Ordinance shall be effective on Wednesday, April 8, 2020 at 5:00 p.m.

Von Bargen reported that she had received email confirmation Alaska State Hospital and Nursing Home Association, and they stated that Wrangell does meet the criteria for what the State defines as a Hub Hospital; with this information, Wrangell no longer qualifies as a "Small Community", to enact more stringent travel restrictions for Wrangell; have no choice but to appeal to the Governor to ask that they allow Wrangell to adopt travel restrictions that are more stringent than what the State has in place; Cordova has put measures in place so that their fishing fleet submits a travel plan to the City for approval.

Prysunka stated that since this was an Emergency Meeting to adopt an Emergency Ordinance, he was not comfortable with moving forward with the Ordinance; asked Clerk Lane for guidance on how to move forward.

Lane stated that since we advertised for the Emergency Ordinance and not for a discussion on possibly going to the Governor to ask for more stringent measures, may be others community members who might want to comment on that discussion.

Prysunka stated that he was concerned with transparency and complying with the open meetings act.

Decker stated that she wanted to still have discussion on the motion because they it was important in moving forward; new information has come forward with meetings that were held today from the by the State.

Prysunka asked that the Assembly have a procedural vote on if to move forward on the discussion or not; since this was an Emergency Meeting to take action, not comfortable in moving forward to have a discussion.

Lane stated that she believed that the cleanest way to handle this was for the maker of the motion (Gilbert) to request that her motion be withdrawn; could call a Work Session for tomorrow evening, if need be, to discuss the options with the Assembly and Manager Von Bargen.

Powell stated that he wanted to know why we couldn't take action; not understanding why we are not moving forward with this action just because someone from the State said that our hospital was considered a Hub Hospital; still feels that this is critical to the safety of our community.

Prysunka stated that we had been told by SEARHC that our medical center was not a Hub Hospital; we are being told now that it is considered a Hub Hospital; so the communities ability to take more restrictive action is based on that criteria; we do not meet that criteria now and if we still take that more restrictive action, we open ourselves to legal action; would like to proceed in a more deliberative manner.

Gilbert stated that she did agree with Powell however if it was the Assembly's wished, she would withdraw her motion.

<u>LOCATION</u>: The project site is located at Latitude 56.4609 ° N., Longitude 132.3776 ° W.; 1064 Zimovia Hwy, Wrangell, Alaska.

<u>PURPOSE</u>: The applicant's stated purpose is to provide employee housing due to the construction of a new hospital in Wrangell.

PROPOSED WORK: Discharge 5,400 cubic yards of shot rock and 675 cubic yards of Drock into 0.84-acre of forested wetlands to construct an access road and a building pad for employee housing. The access road would be 24 feet wide at the top of the road (32 feet at the toe of the slope) and 676 feet long leading to a cul-de-sac. The pad would support six duplexes with parking. The southern end of the pad would have a width of 222 feet and the east side of the pad would have an approximate length of 710 feet. There would be no stream impacts. All work would be performed in accordance with the enclosed plan (sheets 1-5), dated March 2020.

<u>APPLICANT PROPOSED MITIGATION</u>: The applicant proposes the following mitigation measures to avoid, minimize, and compensate for impacts to waters of the U.S. from activities involving discharges of dredged or fill material.

- a. Avoidance: The applicant states, "The availability of sites able to accommodate new housing in the community of Wrangell is limited and all of the sites looked at contain forested wetlands. This site was better than most as much of the site contained uplands and the small stream on the site could be avoided by limiting development to the south side of the property."
- b. Minimization: The applicant states, "Minimization was achieved by sharing access and parking between the proposed structures and locating the improvements on the south side of the property away from the small steam on the north. The access road will have the minimum dimensions for emergency vehicle access."
- c. Compensatory Mitigation: The applicant states, "SEARHC proposes to work with the Southeast Alaska Land Trust (SEAL) for compensatory mitigation for the project."

The following alternatives were also assessed by the applicant:

- 1) City of Wrangell Property located within the City's Industrial Park. This property is 100% wetlands and also a bit further than desirable for a suitable walking distance. Also the depth of the muskeg was estimated in excess of 30 feet and very expensive to develop. Site No. 1 was not selected due to its location adjacent to an industrial property and high costs to develop due to wetlands.
- 2) City of Wrangell Property located near the USFS administration building. This property is also 100% wetlands with deep muskeg to excavate. Site No. 2 was not selected due to high cost to develop and wetlands.
- 3) Etolin Avenue. This property was a good location but contained 100% wetlands. Site No. 3 was a good location but did contain wetlands so it was not selected.
- 4) City of Wrangell Institute Property. This property was well out of town and required the City and Borough of Wrangell to perform a subdivision and install utilities which are several years out yet. Site No. 4 is a good long range plan for future housing but not yet available.

5) Applicant's preferred alternative. The site selected contained only partial wetlands. To topography of all of the sites are similar to that of the selected site. Impacts to wetlands of the sites would have been much higher due to the fact that there was no existing development. The preferred site was selected because of the limited impact to wetlands due to the existing building and also considerable uplands within the property.

<u>WATER QUALITY CERTIFICATION</u>: A permit for the described work will not be issued until a certification or waiver of certification, as required under Section 401 of the Clean Water Act (Public Law 95-217), has been received from the Alaska Department of Environmental Conservation.

<u>CULTURAL RESOURCES</u>: The latest published version of the Alaska Heritage Resources Survey (AHRS) has been consulted for the presence or absence of historic properties, including those listed in or eligible for inclusion in the National Register of Historic Places. There are cultural resources in the permit area or within the vicinity of the permit area. The permit area has been determined to be the direct footprint of the fill in waters of the U.S. and in uplands on the lot. Consultation of the AHRS constitutes the extent of cultural resource investigations by the Corps of Engineers (Corps) at this time, and we are otherwise unaware of the presence of such resources. The Corps has made a No Historic Properties Affected (No Effect) determination for the proposed project. This application is being coordinated with the State Historic Preservation Office (SHPO). Any comments SHPO may have concerning presently unknown archeological or historic data that may be lost or destroyed by work under the requested permit will be considered in our final assessment of the described work. The Corps is requesting the SHPO's concurrence with this determination.

<u>ENDANGERED SPECIES</u>: No threatened or endangered species are known to use the project area. We have determined the described activity would have no effect on any listed or proposed threatened or endangered species, and would have no effect on any designated or proposed critical habitat, under the Endangered Species Act of 1973 (87 Stat. 844). Therefore, no consultation with the U.S. Fish and Wildlife Service or the National Marine Fisheries Service (NMFS) is required. However, any comments they may have concerning endangered or threatened wildlife or plants or their critical habitat will be considered in our final assessment of the described work.

<u>ESSENTIAL FISH HABITAT</u>: The Magnuson-Stevens Fishery Conservation and Management Act, as amended by the Sustainable Fisheries Act of 1996, requires all Federal agencies to consult with the NMFS on all actions, or proposed actions, permitted, funded, or undertaken by the agency, that may adversely affect Essential Fish Habitat (EFH).

No EFH species are known to use the project area. We have determined the described activity would not adversely affect EFH in the project area.

TRIBAL CONSULTATION: The Alaska District fully supports tribal self-governance and government-to-government relations between Federally recognized Tribes and the Federal

government. Tribes with protected rights or resources that could be significantly affected proposed Federal action (e.g., a permit decision) have the right to consult with the Alaska District on a government-to-government basis. Views of each Tribe regarding protected rights and resources will be accorded due consideration in this process. This PN serves as notification to the Tribes within the area potentially affected by the proposed work and invites their participation in the Federal decision-making process regarding the protected Tribal right or resource. Consultation may be initiated by the affected Tribe upon written request to the District Commander during the public comment period.

<u>PUBLIC HEARING</u>: Any person may request, in writing, within the comment period specified in this notice, that a public hearing be held to consider this application. Requests for public hearings shall state, with particularity, reasons for holding a public hearing.

EVALUATION: The decision whether to issue a permit will be based on an evaluation of the probable impacts, including cumulative impacts of the proposed activity and its intended use on the public interest. Evaluation of the probable impacts, which the proposed activity may have on the public interest, requires a careful weighing of all the factors that become relevant in each particular case. The benefits, which reasonably may be expected to accrue from the proposal, must be balanced against its reasonably foreseeable detriments. The outcome of the general balancing process would determine whether to authorize a proposal, and if so, the conditions under which it will be allowed to occur. The decision should reflect the national concern for both protection and utilization of important resources. All factors, which may be relevant to the proposal, must be considered including the cumulative effects thereof. Among those are conservation, economics, aesthetics, general environmental concerns, wetlands, cultural values, fish and wildlife values, flood hazards, floodplain values, land use, navigation, shore erosion and accretion, recreation, water supply and conservation, water quality, energy needs, safety, food and fiber production, mineral needs, considerations of property ownership, and, in general, the needs and welfare of the people. For activities involving 404 discharges, a permit will be denied if the discharge that would be authorized by such permit would not comply with the Environmental Protection Agency's 404(b)(I) guidelines. Subject to the preceding sentence and any other applicable guidelines or criteria (see Sections 320.2 and 320.3), a permit will be granted unless the District Commander determines that it would be contrary to the public interest.

The Corps is soliciting comments from the public; Federal, State, and local agencies and officials; Indian Tribes; and other interested parties in order to consider and evaluate the impacts of this proposed activity. Any comments received will be considered by the Corps to determine whether to issue, modify, condition or deny a permit for this proposal. To make this decision, comments are used to assess impacts on endangered species, historic properties, water quality, general environmental effects, and the other public interest factors listed above. Comments are used in the preparation of an Environmental Assessment and/or an Environmental Impact Statement pursuant to the National Environmental Policy Act. 



VICINITY MAP


















A Legacy of Stitches is what we leave behind; the imprint of our very soul that lasts beyond our time.

The heart that quilts knows, oh, so well the peace that can be found, as needle meets with fabric, for there is no sweeter sound.

Whether quiet piecing done by hand or on our sewing machine, there's rhythm to our stitches as we sew along each seam.

Those stitches tell the story of our lives as they unfold as we think of quilts that Grandma made with stories left untold.

The humdrum of our daily lives grows elegant and grand, when we start to cut the pieces, then stitch the fabric in our hands.

And whatever is the reason for the guilts we piece and sew, and whoever is the maker, there is one thing that we know.


Each quilt is full of memories, and is a treasured thing. If quilts could talk, imagine how some quilts would surely sing!

For some quilts are sewn in happy times and others when we're sad, and some are sewn in laughter and others when we're mad.

Some are sewn to warm us, and some sewn just for fun, and some are "works in progress" that never quite get done!

Some quilts are sewn for beauty, a quilt made just for "show" but the heart of the true quilter is the one who really knows.

That no matter how the guilt is stitched, we leave our mark in time. This Legacy of Stitches is what we leave behind.























Japanese Samurai Helmet

Our spotlight falls on an amazing item in the collection, a full-sized Japanese Samurai warriors helmet. It is made of shining brass and features sword shaped crests mounted in front. Angry looking tigers guard panels on each side of the visor. Large colorful tassels and elaborately painted designs help complete the bold statement. So why is it part of the Wrangell Museum collection? Like every museum object, background makes all the difference.

The story goes back to Oct 8, 1977. That night the Wrangell Lions Club was presented with this helmet on behalf of the Lions Club of Akihabara, Japan. The gift from across the ocean followed a 12-15 foot totem pole carved by Tom Ukas of Wrangell. It had been sent to the 1960's Tokyo Lions convention on behalf of the 49th (Alaska) Lions district. The totem pole and its story was transported on a lumber ship which had taken on cargo at the Wrangell mill. It was placed on permanent display in a Tokyo children's park. The Samurai helmet was presented to President Mike Bell and other Lions members at a dinner at the Stikine Inn. It is now on permanent loan in our museum. Many Japanese gifts can be seen displayed around Wrangell today, remembering the bonds made when our Wrangell sawmill made regular shipments to Japan.



Wrangell Garnet Ledge

Garnet Ledge is a vein of almandine in mica schist, featuring partially formed, and sometimes complete 36 sided garnets. The property is located a few miles northeast of Wrangell Island near the mouth of the Stikine River. The first recorded mining claim for the deposit was filed in 1881. In 1907 an all woman development company operated the site. This company named Alaska Garnet Mining and Manufacturing marketed such things as garnet hat pins and watch fobs, remaining somewhat active until the 1930s. Wrangell garnets are generally not gemstone quality, they fracture easily. Garnet sand or "dust" has been most widely marketed as an abrasive for sandpaper and as a parting compound for foundry work. Today the deposit is owned by the children of Wrangell because of the generous donation in 1962 by then-owner Fred Hanford. It is held in trust by the First Presbyterian Church with the intention that only the children of Wrangell can profit from garnet sales. Their sale booths can be seen near ferry and tour boat docks every summer.



Making Alaska Better... For All

Martin Luther King Day and Elizabeth Peratrovich Day was inspiration for a new exhibit that rolled out in February. It focused on Alaskan civil rights leaders, their issues, and their accomplishments. Founders of important Native Alaskan programs such as health care, housing, language studies, and environmental protection rules were also acknowledged. History of the principal Native Alaskan organizations behind the civil rights movement was examined. Alaska Native Brotherhood (ANB) and Alaska Native Sisterhood (ANS) have successfully lobbied the legislature since their formation in 1912 and 1914. Their achievments in racial equality, desegregation, antidiscrimination, and land settlement compensation built the Alaska we all enjoy today. The display included images of the Elizabeth Peratrovich \$1 coin to become available later this year, the book "Fighter in Velvet Gloves" by Annie Boochever, and a copy of the inspiring poster "We Can Do It!" by Dillingham artist Apayo Moore.



Old Calendars & Polar Bears


We started the new year with a display appropriately called, Old Calendars and Polar Bears- It's A Wrangell Thing...! With featured calendars from our collection, we remember exclusively Wrangell businesses or local fundraiser calendar projects starting in 1912 to the most recent 2010 example. Many have vividly colorful photos that generate a lot of interest with our local community. Two examples are from the 1970's lumber and pulp mill. It was a major economic engine of the time, and completely gone today. A more recent calendar is called Men of Wrangell, a fun look at various guys from around town hard at work (and play). Each New Year's Day the informal and daring Wrangell Polar Bears wade out into Shoemaker Harbor for a 1 minute dip. An enthusiastic support group waits on shore with warming fires and plenty of hot chocolate. Some photos from these times past are sprinkled among the old calendars to add a bit of cool comedy.




Celebrating Iditarod 2020



The Iditarod Trail Sled Dog race might be a distance away from Wrangell but not its appeal. Followers here eagerly look forward to March each year for the big event and stay tuned to daily progress reports. This is a great time to bring out a display of Wrangell Museum's large collection of Iditarod posters by artist Jon Van Zyle. Our antique exhibit case has just enough space for the 5 featured examples. The display includes the Mushers roster and this year's Anchorage to Nome trail route, then somehow a few husky puppies from the Museum gift shop found a good spot right in front. As the theme suggests, Good Luck Mushers 2020!









What happens to my donation?

Ever wonder how the museum processes your donation? A condensed answer would go something like this. If it is made of organic materials, it visits the freezer for freeze/thaw cycles, and waits in a quarantine area. This prevents unseen pest invasion into our collection. The donation is assigned a unique reversible catalog number, which is affixed in a manner appropriate for its composition. It is gently cleaned if necessary, then described, photographed, measured, its providence recorded, condition accessed, and storage location is all entered in our digital data base. If the donation needs special physical support, it receives custom housing. Examples include rolled storage tubes for large textiles, protective sleeves for photos and archives, possibly archival boxes with custom supports or padding for smaller textiles and fragile objects. Some donations are in sound condition and can be simply stored on cushioned shelving or hung on padded hangers. Framed two-dimensional art is placed on our new sliding cable hanging system. Wrangell Museum has a variety of mobile display cases in the exhibit gallery and lobby areas. They allow us to rotate the stored collection into public view on a regular basis. The museum gratefully accepts donations relating to Wrangell history and culture. We encourage you to contact Wrangell Museum at 907-874-3770 if you are considering a donation.

A wonderful bonus is the original gift box included with this donation. The box came from a prominent front street business operating many years in Wrangell, known as W.C. Waters Curios Bear Totem Store, and helps document when and where her relative made the purchase.





About The Digital Archives

The large majority of photographs that are donated to the museum do not have information on people, date or location included on image. A special thank you goes out to those people in Wrangell that have included the "full" information or have later researched and confirmed persons and locations. There are several local people who have been involved with the museum for decades, whose input and information is irreplaceable!

People who have been working on the archive for many years have familiarized themselves with Wrangell history, Tracy Churchill, who started working on the digital photo archive 18 years ago with Ken Mason, learned a lot about photo identification. However, although she has been working on the collection for several years, the collection is ever-evolving with new people to identify and further information subject matter. Tracy plans to build a portfolio including identification of local persons, at least up to 1940 to assist in identification of photographs in the future.

We have a great appreciation for local Wrangell authors who have done extensive research on historical photographs for publications about local business, industry and historical events, all add to the unique place we call home.

If you can remember to label your photographs (if you are one that still prints photographs) if you have a collection from the past, or present, that will be much appreciated by people in the future.

Withdrawing a Motion

A common misconception on Withdrawing a Motion is that both the member that moved and the member that seconded the motion must withdraw. That is not accurate.

Here is how this works: A motion may be withdrawn by the <u>mover</u> only with the *permission* of the **group**.

The mover may ask to withdraw a motion and the chair would then ask for any objections. If there are none, the motion is withdrawn.

A polled vote is not required, the Mayor can ask if there are any objections to the motion being withdrawn.

If there is an objection, then a vote must be taken, and the motion withdrawn only with a majority vote.

Mr. Glasner purchased Lot C, Torgramsen-Glasner Subdivision in 2016. He sought and received a contract zone specifically for a single building indoor storage facility. Mr. Glasner requested a modification to his contract zone in late 2016 to add a second storage facility on the same property.

Mr. Glasner's original proposal changed the Single-Family zone to Light Industrial for only a single storage building. His first modification added a second storage unit building. He constructed two steel buildings of 120' X 45' and 84' X 30'.

Mr. Glasner is now submitting a modified site plan and seeking to construct a third building with 4 garage units with a footprint of 60' x 38'.

Access to the facility is currently via an existing driveway from Zimovia Highway. He widened the driveway after comments and concerns of his neighbor regarding the close proximity of vehicles and concern of conflicts of access. Based on the proposed site plan and aerial, the new building will be 25 feet from the property line with the trailer park and approximately 40+ feet from building 1, in a portion of the area that looks like it is currently used for parking and storage. Additional parking and staging is available between buildings 1 and 2 and can be made available on the sides of building 3.

Contract Zones modify the underlying zone, in this case, Single Family Residential, to Light Industrial for a very specific use as outlined in the applicant's proposal, and on which all reviews are made. The Contract Agreement is then prepared between the applicant and the Borough based on the specific request and approval. To amend or modify the proposed use and activities, requires approval and a modification to the agreement, as changes could create new or adverse impacts not originally anticipated.

The Commission determined that the proposed expansion will not create additional impacts in the area and affect the Contract Zone Agreement. The Commission is making a recommendation to the Assembly to approve the modification with the following findings as to appropriateness for the area and effects on property owners. Findings address requirements of WMC 20.76.030 (C):

- 1) Justification for the proposed change, including the effect on the objectives of the comprehensive plan
- 2) Effect of the proposed change on property owners, including traffic flow, population, density, parking, sewer and water
- 3) Approval or Disapproval

FINDINGS OF FACT:

- 1. Justification for the proposed change, including the effect on the objectives of the comprehensive plan: The Commission deems it in the best interest of the community to approve the requested modification to the contract zone allowing a third building per the proposed modified site plan. The activities of the proposed use is in high demand and provides positive benefits to the community. The proposed use may not meet the objectives of the Future Residential Growth of the Comprehensive Plan (Ch 6.8.2) nor does it fall within the Future Growth Map 6-18 for Residential development per the underlying zone prior to the agreed zone change, but it does meet Land Use Policy 32 designating areas for commercial and industrial development. The existing use has not seemed to create major impacts to neighbors. The one complaint received by staff regarding the conflicting driveway access was addressed during the last modification request. Implementing the conditions meets Policy 33 promoting compatibility.
- 2. Effect of the proposed change on property owners, including traffic flow, population, density, parking, sewer and water: The Commission finds that the impacts of an additional storage building to adjacent property owners will be minimal. Lighting can be directed downward and access times limited to minimize noise and visual impacts. The access driveway was shifted over previously to avoid traffic flow and access conflicts with the adjacent landowner and no additional complaints or comments have been received by staff. The condition requiring a 25-foot vegetative buffer remains as part of the agreement.
- **3. Approval or Disapproval:** The Commission recommends approval of the contract zone agreement modification request.



THIS MODIFIED AGREEMENT is made 29 day of 2016, between DONALD AND GAIL GLASNER, herein as "Glasner's.", whose address is 227 Doxy Drive, Park Ridge, NJ 07656, and the CITY & BOROUGH OF WRANGELL, referred herein as "Borough" whose address is Post Office Box 531, Wrangell, Alaska 99929.

The parties to this agreement, in consideration of the mutual covenants and promises contained herein, agree as follows:

RECITALS

1. The Glasner's are the new owners of the following described real property, to-wit:

Lot C, of the Torgramsen-Glasner Subdivision, according to Plat No. 2016-2, Wrangell Recording District, First Judicial District, State of Alaska.

- 2. The Wrangell Borough Assembly approved a <u>Modified Contract Zoning Agreement</u> to rezone the property from Single Family Residential to Light Industrial, for only the specific use as set forth below for a period 10 years and with the following condition(s):

the Borough removes the structure at the Borough's expense, the Glasner's shall pay the Borough the full amount of all removal costs, fees and expenses.







RECOMMENDATION MOTION:

Move to approve a contract award to Heller High Water, LLC in the amount of \$67,000 for the City Dock Summer Float Procurement Project Rebid.

SUMMARY STATEMENT:

The cruise ship and local charter industries have indicated the need for additional mooring capacity at City Dock due to the industry's growth over the last several years. On days where more than two cruise ships are in town, the process of lightering (transferring) the passengers between an off-shore anchored ship, to the dock, is time consuming and a loss of passenger experience in Wrangell. The Harbor Department currently has three summer floats that are configured for the north side of City Dock approach dock, and there is one configured for the south side of the approach dock. The subject new summer float has been designed to be added to the existing float for the south side, and it is designed as a 10' (w) x 130' (l) mixed steel and timber floating dock.

Under the FY20 Budget, the Harbor Department scheduled the procurement of one City Dock Summer Float with funding from the Commercial Passenger Vessel Excise Tax Fund. The dock procurement was estimated at \$55,000. Additional project costs were estimated at \$30,000 for the lumber and hardware package, which the Harbor Department plans to procure and install on the steel float once it arrives in Wrangell. All work is anticipated to be complete in time for the new float to be placed in the water for use by the beginning of the summer season.

A recommendation to award this project to the low bidder, Heller High Water, LLC, was approved by the Assembly in February. Prior to issuing the contract, staff learned that the low bidder's pipe material did not meet specification, nor did the second low bidder's pipe material meet specification, both due to the lack of availability of the pipe material that met the standard specified in the Borough's solicitation. Upon counsel's recommendation, the Borough manager rejected all bids and the project was rebid, with the opening of the rebids on March 24, 2020. The apparent lowest, responsive and responsible bid was received from Heller High Water, LLC (the original low bidder) in the amount of \$67,000. Two other bids were received from Tamico (\$75,000) and Island Construction (\$118,70). Staff recommends awarding the procurement contract to Heller High Water, LLC who confirmed that the material specified in our solicitation rebid is included in their bid.

The original low bid in February was \$66,301.07. The difference between the two is \$698.93.
