SUMMARY STATEMENT:

The Wrangell Harbor Basin Replacement project is priority 11 on the CIP list that was approved by the Assembly in December of 2022 by Resolution 12-22-1733. Staff will be applying the end of February 2023 for a U. S. Department of Transportation, Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant. The grant request will be for a capital improvement request that will include engineering design, survey, permitting and construction for Reliance Float, Inner Harbor, Fish and Game Float and the Airplane Pullout. The maximum grant amount provided by RAISE is \$25 million. For communities like Wrangell located in Rural areas, there is no match required.

Last year, we applied for a planning grant for the engineering design for the Wrangell Harbor Basin replacement in order to determine the actual cost of construction. The estimated cost for construction as determined by staff based on unit costs provided by engineers was over \$26 million. In order to apply for the capital grant, the Borough Assembly must commit any funds over the budgeted grant request in the application and/or anything over \$25 million. The actual costs to reconstruct the Wrangell Harbor Basin will be determined as part of the engineering design phase of the capital improvement grant request. Staff is still determining the budget of the grant request and will modify what floats are part of the application in order to keep the request below \$25 million. However, if engineering design is larger than the staff estimate, the attached Resolution commits the excess funds to come from Harbor Reserves and/or General Revenue Bond.

We scored high on the application for engineering design in 2022 but were not selected due to the lack of data metrics for certain merit criteria. We are having a Benefit Cost Analysis completed by Rain Coast Data, a requirement for all capital construction grant request projects to provide the necessary metrics for justifying the merit criteria. Staff is still working on the estimated cost for the reconstruction based on inflation and updated unit costs for the RAISE grant 2023. However, if engineering design is larger than the staff estimate, the attached Resolution commits the excess funds to come from Harbor Reserves and/or General Revenue Bond.

WHEREAS, the Assembly of the City and Borough of Wrangell is pursuing an application for the replacement construction of the Wrangell Harbor Basin facilities from the U.S. Department of Transportation- Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant, and

WHEREAS, the Wrangell Harbor Basin Replacement is listed as Priority 11 on the Capital Improvement list per Resolution 12-22-1733, and

WHEREAS, the condition of the float systems comprising the Wrangell Harbor Basin are in a state of disrepair creating major safety and operational issues for the Borough and Harbor users, as well as negatively impacting the local marine environment, and

WHEREAS, the community relies on the Wrangell Harbor Basin for economic growth, primary transportation links, movement of freight, and contribution to the local quality of life, and

WHEREAS, the Reconstruction of the Wrangell Harbor Basin project will include the engineering design, surveying, permitting and construction estimated to be just under \$25 million, and

WHEREAS, the RAISE grant program maximum funding amount is \$25 million, and

WHEREAS, the RAISE grant program will waive the 20% match requirement for communities, like the City and Borough of Wrangell, that are designated Rural; and

WHEREAS, the City and Borough of Wrangell will commit funds from the Harbor Reserve and/or a General Revenue Bond for any project cost overruns above the amount applied for and received in RAISE 2023 and over the \$25 million maximum award amount, and

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF WRANGELL, ALASKA.

SECTION 1: The Assembly hereby authorizes the Borough Manager to execute any and all documents necessary for applying for funds from the RAISE 2023 program on behalf of this organization.

SECTION 2: The Assembly hereby authorizes the commitment of funds from the Harbor Reserve and/or a General Revenue Bond for any project cost overruns above the amount applied for and received in RAISE 2023 and over the \$25 million maximum award amount.

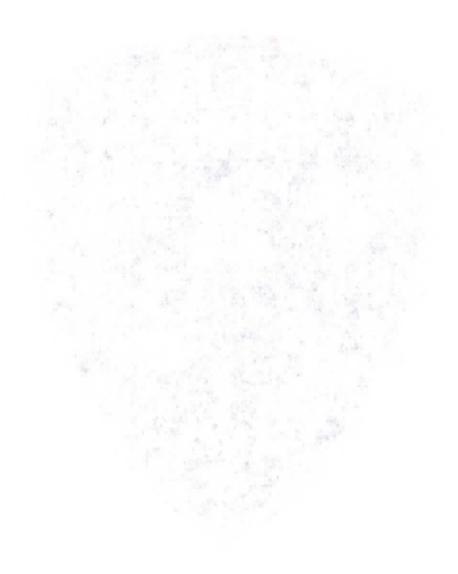

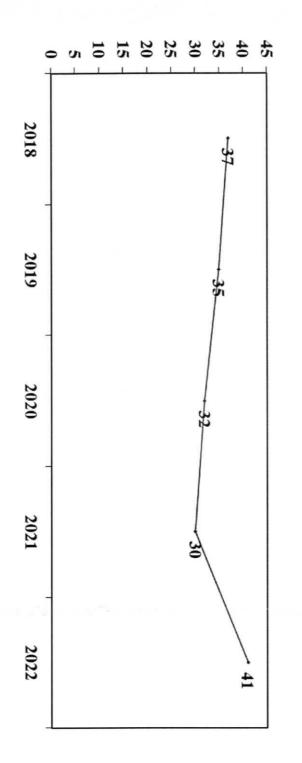

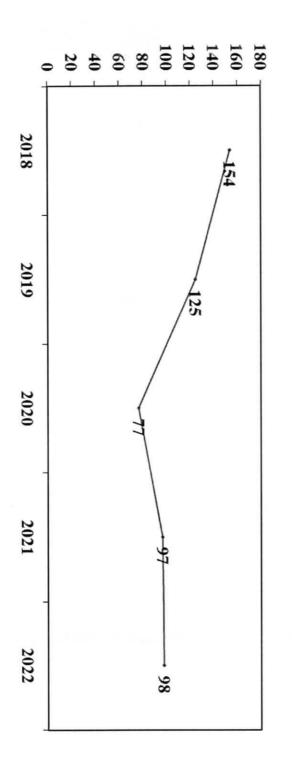

Five Year Comparison 2018-2022 **Alcohol Offenses**



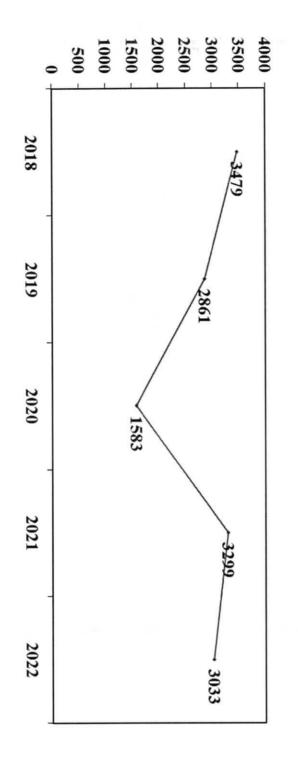
Five Year Comparison 2018-2022 Animals

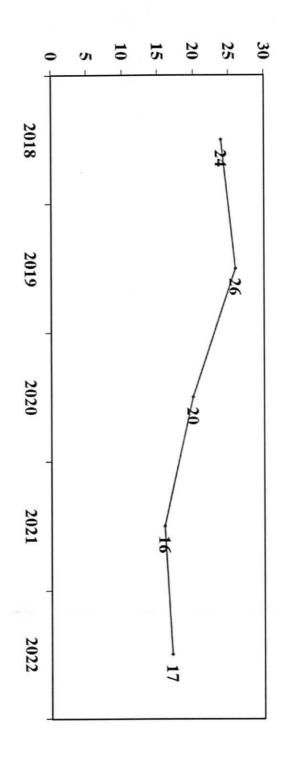

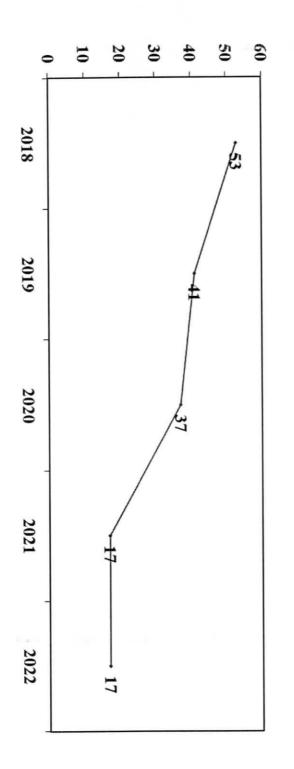

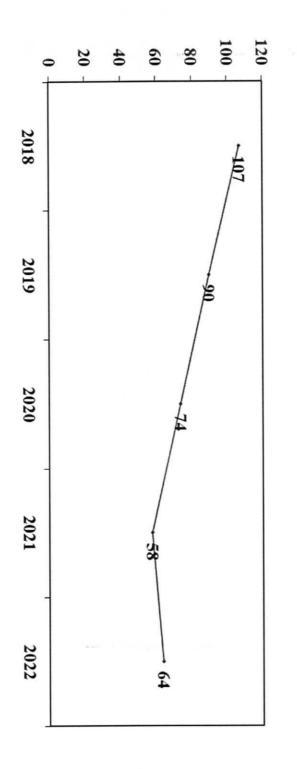
Five Year Comparison 2018-2022 **Miscellaneous Offenses**



Five Year Comparison 2018-2022 **Crimes Against Person**



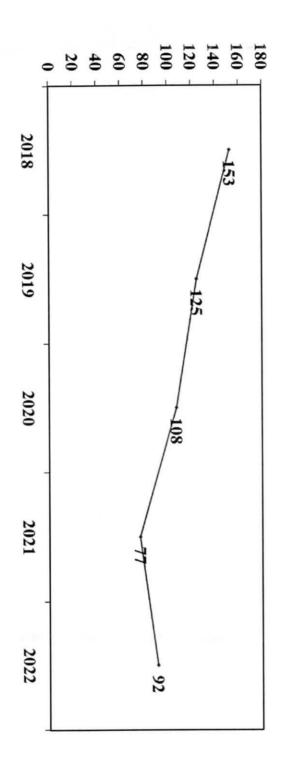

Mr. Burr is hoping to have enough data by the end of next month to consider changing the mitigation plan.

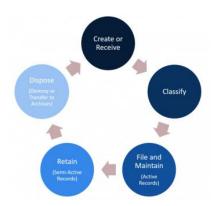

SUMMARY STATEMENT:

We received a request from James D. Leslie to purchase the filled City-Owned Tidelands that they are currently leasing.

WMC Section on the Sale of Tidelands

WMC 16-12-030 – Sale of Tidelands: The policy of outright disposal by sale of tide and submerged lands is not favored; the orderly development of the borough with due consideration toward ocean resource harvesting, municipal revenue and public recreation would indicate a strong preference toward tidelands leasing. However, when it is in the public interest, the assembly may, by resolution, authorize the sale of tracts of tide and submerged lands in the manner provided for the sale of other real property owned by the borough. Tidelands, which may be sold pursuant to this section, as that term is used herein, refers only to those tide and submerged lands conveyed by the state of Alaska to the then-City of Wrangell pursuant to AS <u>38.05.820</u>.

WMC 16.12.040(9) - Additionally, no sale of tidelands shall occur except upon a public hearing as per WMC 16.12.040(2). At the public hearing, the applicant must clearly demonstrate the benefits of sale of the subject tidelands tract that could not be realized by the borough through leasing; a determination by the assembly adverse to the applicant may not be appealed unless clearly erroneous. An applicant for purchase of tidelands must conclusively demonstrate the outright sale of the nominated tidelands tract, as contrasted with the lease of such tract, is in the borough's best interest. The borough reserves the right to refuse sale of any tidelands tracts, regardless of sufficiency of proof.

The reasoning behind the request is because 1) the tidelands may be classified as "tidelands" however, they are filled. The lot is approximately 100 yards from the tidelands, with city hall between the lot and the tideline. 2) Since the lease began in 1977, there have been extensive improvements on the property, including a structure that has an office space on the bottom, and an apartment above. 3) If sold, the property would be on the tax rolls and would most likely bring in more or around the same in taxes, than the annual rental is currently.

The Port Commission and Planning & Zoning Commission have both written memos on this request and those memos are attached.

If the Assembly approves moving forward with the sale of these tidelands, the next step will be to obtain an appraisal and post the public notice, inviting those who want to protest the sale, to do so. This will be done 30-days prior to the approval of the tidelands comes to the Assembly for approval. Although the tidelands are currently leased to the applicant, the last assessment was done back in April/May of 2022. Therefore, these tidelands would need a new assessment. The cost would be borne by the applicant.

Wrangell Assembly members,

I would like you to take my request to purchase the tideland into consideration. The land I am requesting to purchase from the city is Lot 15, Block 1-A, Alaska Tidelands Survey 83. This lot has been leased as tidelands since 1978. I had the lease transferred to me, from my mother in the winter of 2021, with an expiration date of December 13, 2032.

There is a building owned by me on the land leased from the city. The building is currently being leased as both commercial space, and residential. I operate a rental company as J. Leslie Rentals, Alaska Business License # 2086999. Owning a building on leased land has made it difficult to conduct business. To obtain loans, lines of credit, potential future sales of the building are very difficult due to banks not willing to work with parties on leased land.

At one time, the location was tidelands. The landscape of down town Wrangell has changed over the years. Now the lot is approximately 100 yards from the tidelands, with city hall between the lot and the tide line. Under sections (A 16.12.030) of Sale of tidelands, Tidelands is defined as those tide and submerged lands, conveyed by the state of Alaska the the then-City of Wrangell pursuant to AS 38.05.820.

For the reasons stated above, I believe the lot should be considered to be sold.

SUMMARY STATEMENT:

SHORT TERM LEASE AGREEMENT

This Short Term Lease Agreement (hereinafter "Lease") is made and entered into between **THE CITY AND BOROUGH OF WRANGELL, ALASKA** (hereinafter "CBW" or "Landlord"), whose address is P.O. Box 531, Wrangell, Alaska 99929, and **CHANNEL CONSTRUCTION, INC.** (hereinafter "CCI" or "Tenant"), whose address is P.O. Box 33359, Juneau, Alaska 99803, effective this ______ day of January, 2023 (the "Effective Date").

RECITALS

WHEREAS, CBW owns the site of the old Buhler sawmill site at 6-mile Zimovia Highway, more particularly described and shown on Exhibit A attached to and by this reference incorporated into this Lease (the "Property"); and

WHEREAS, CCI intends to temporarily store scrap materials on the two acre portion of the Property drawn on Exhibit A (the "Leased Premises") and to later transport those materials to another location for processing; and

WHEREAS, CBW intends to develop a long-term economic development plan ("LTEDP") for the Property and any activities being conducted on the Property must be in accord with the LTEDP and any associated land use requirements; and,

WHEREAS, Wrangell Municipal Code Chapter 16.08 authorizes CBW to lease CBW-owned tidelands; and

WHEREAS, The CBW Planning and Zoning Commission and CBW Port Commission have approved CCI's lease application, and documentation related to those approvals are attached hereto as Exhibit B;

NOW, THEREFORE, in consideration of the matters recited above, and the mutual covenants herein, the parties agree as follows:

1. <u>**Grant of Leased Premises.</u>** Under the terms and conditions set forth herein, CBW leases to CCI, and CCI rents from CBW, the Leased Premises. A legal description of the Property and a depiction of two acre portion thereof constituting the Leased Premises is shown on Exhibit A.</u>

2. Length of Term. The term of this Lease shall be for one hundred and

twenty (120) days following the Effective Date (the "Lease Term").

3. <u>**Rent.</u>** The monthly rent during the term of this Lease shall be due and payable by CCI in equal monthly installments of \$1000, plus sales and all other taxes CBW is authorized or obligated to collect on such transactions, to be paid to the CBW Finance Director or his representative on or before the close of business on the first day of each month for the previous month's usage, without any prior demand therefor.</u>

4. <u>Use of Leased Premises</u>. CCI may temporarily store scrap materials on the Leased Premises during the term of the Lease. So long as such scrap materials are drained of all fluids including anti-freeze, and so long as batteries and tires are removed, CCI may also accept scrap materials from the CBW general public and CBW for storage. CCI shall use the Leased Premises only for the purposes set forth above and no other purpose or purposes. CCI may construct temporary structures which are consistent with such permitted use. It is expressly understood by the parties that no provision of this Lease is intended to authorize CCI to operate a permanent scrap metal recycling or storage business on the Property.

5. <u>Subletting and Assignment</u>. CCI will not assign or encumber this Lease, in whole or in part, or sublet all or any part of the Leased Premises. This prohibition against assigning or subletting shall be construed to include a prohibition against any assignment or subletting by operations of law.

6. <u>Surrender of Possession</u>. Upon the expiration or earlier termination of the Lease Term, unless CCI and CBW have entered into a new lease for the Leased Premises commencing upon the termination of the Lease Term, CCI shall promptly and peaceably surrender the Leased Premises in as good order and condition as at the commencement of the Lease Term and at CCI's sole cost shall remove from the Property all stored scrap materials and all of CCI's buildings, equipment, and structures.

7. <u>Holding Over</u>. CCI's continuing in possession of the Leased Premises after the expiration or earlier termination of the Lease Term will not renew or extend this Lease. In the absence of any agreement renewing or extending this Lease, CCI's continued possession of the Leased Premises after the end of the Lease Term will be a tenancy from month to month, terminable upon 30 days written notice by either party at any time, at a monthly rental equal to 150% of the monthly rent in effect at the end of the Lease Term, subject to all other terms of this Lease. For good cause, CBW may waive all or part of the increase in monthly rent during the holdover period. Notwithstanding the above, the holdover period may not exceed three months following the Lease Term.

8. <u>Work Practices</u>. CCI shall conduct its work on the Property in accordance with the Recycling Industry Operating Standard, and in compliance with all applicable laws and regulations.

9. <u>Force Majeure.</u> The parties shall not be deemed in default with respect to the performance of any of the terms, conditions and covenants of this Lease if the same shall be due to any act of God, any strike, lockout, earthquake, civil commotions or disturbances, invasion, rebellion, hostilities, military or usurped power, or sabotage.

10. **Inspection, Ingress, and Egress.** CBW reserves the right of ingress to and egress from the Property and the Leased Premises. CBW reserves the right to enter any part of the Property and the Leased Premises, including buildings or structures, for the purpose of inspection or environmental testing at any time. Except in the case of an emergency, all such inspections and environmental testing will be coordinated with CCI to minimize interference with its activities.

11. **Insurance.** CCI shall, at CCI's sole cost, keep in force during the term of this Lease and any holdover period the following insurance policies:

a. A policy of commercial general liability insurance covering property damage and liability for personal injury occurring on or about the Property, with limits in the amount of at least One Million Dollars (\$1,000,000) per occurrence for injuries to or death of any person.

b. Workers' compensation insurance as required by AS 23.30.045. This coverage shall include employer's liability protection not less than One Million Dollars (\$1,000,000) per person, One Million Dollars (\$1,000,000) per occurrence. Where applicable, coverage for all federal acts (i.e. U.S. Longshoremen and Harbor Worker's Compensation and Jones Acts) shall also be included. The workers' compensation insurance shall contain a waiver of subrogation clause in favor of CBW.

c. A policy of site-specific pollution liability insurance specifically covering CCI's activities on the Property in the amount of at least One Million Dollars (\$1,000,000) per occurrence.

Copies of all insurance policies and a certificate of insurance with respect to each policy shall be delivered to CBW upon CCI taking occupancy of the Leased Premises and if there are any changes to the policies such changes shall be promptly provided to CBW. CBW shall be designated as an Additional Insured on each and every insurance policy by an endorsement to each policy. Copies of such endorsements shall be furnished to CBW promptly with respect to each insurance policy.

12. **Prior Environmental Contamination and Surviving Obligations.** The parties understand that environmental contamination has existed on the Property prior to CBW's ownership. Pursuant to a duly executed Prospective Purchaser Agreement between CBW and the Alaska Department of Environmental Conservation (hereinafter "ADEC"), CBW is immune from action by ADEC for hazardous material as defined below existing prior to the purchase. The parties understand that any commingling of new hazardous waste with preexisting waste may expose both CBW and CCI to liability for pre-existing waste. Considering that environmental liability for hazardous waste release can be long lasting, the parties agree all the following Environmental and indemnification obligations shall survive the Lease Term.

13. Environmental Protection and Safety.

a. Hazardous Substances. The words "Hazardous Substances" are used in their very broadest sense and refer to materials that, because of their quantity, concentration or physical, chemical, or infectious characteristics, may cause or pose a present or potential hazard to human health or the environment when improperly used, treated, stored, disposed of, generated, manufactured, transported or otherwise handled. "Hazardous Substances" include without limitation any and all hazardous or toxic substances, materials or waste as defined by or listed under the Environmental Laws. "Hazardous Substances" also includes, without limitation, petroleum and petroleum by- products or any fraction thereof and asbestos.

b. Environmental Laws. The words "Environmental Laws" mean all federal, state and local statutes, regulations, ordinances, and requirements, now or hereafter in effect, pertaining to environmental protection, contamination or cleanup, including without limitation (i) the Federal Water Pollution Control Act (33 U.S.C. §1251 et. seq.); (ii) the Federal Resource Conservation and Recovery Act of 1976 (42 U.S.C. §6901 et. seq.); (iii) the Federal Comprehensive Environmental

Response, Compensation and Liability Act of 1980 (42 U.S.C. §9601 et. seq.); (iv) the Hazardous Materials Transportation act, 49 U.S.C. Section 5101, et seq.; (v) Alaska Environmental Conservation Act, Alaska Stat. §46.03.010 et seq.; (vi) Alaska Water Pollution Control and Waste Disposal Act, Alaska Stat. §46.03.050 et seq.; (vii) Alaska Oil and Hazardous Substance Pollution Control Act, Alaska Stat. §46.04.010 et seq.; (viii) Alaska Hazardous Substance Release Control Act, Alaska Stat. §46.09.010 et seq.; and (ix) Prohibited Acts and Penalties, Alaska Stat. §46.03.710 et seq., all as now or hereafter amended.

c. CCI shall immediately notify CBW upon becoming aware of any of the following: (i) any spill, release or disposal of a Hazardous Substance on any of the Property, or in connection with any of its operations if such spill, release or disposal must be reported to any governmental authority under applicable Environmental Laws; (ii) any material contamination, or imminent threat of contamination, of the Property by Hazardous Substances, or any violation of Environmental Laws in connection with the Property operations conducted on the Property; (iii) any order, notice of violation, fine or penalty or other similar action by any governmental authority relating to Hazardous Substances or Environmental Laws and the Property or the operations conducted on the Property.

d. CBW reserves the right to inspect and investigate the Property and operations thereon at any time and from time to time, and CCI shall cooperate fully with CBW in such inspection and investigations. If CBW at any time has reasonable cause to believe that CCI or any occupants of the Property are not complying with all applicable Environmental Laws or with the requirements of this Lease or that a material spill, release or disposal of Hazardous Substances has occurred on or under the Property, CBW may require CCI to furnish CBW at CCI's expense an environmental audit or a site assessment with respect to the matters of concern to CBW. Such audit or assessment shall be performed by a qualified consultant approved by CBW. Any inspections or tests made by CBW shall be for CBW's purposes only and shall not be construed to create any responsibility or liability on the part of CBW to CCI or to any other person or entity.

e. CCI shall be responsible for removing any Hazardous Substances from the Property following the termination of this Lease and shall clean up the Property to the standard required by law or regulation, environmental or otherwise, and to the reasonable satisfaction of CBW; provided that CBW's approval of a Property cleanup plan shall first be obtained. f. To ensure prior contamination is not disturbed, CCI shall under no circumstances drill, dig, or otherwise disturb soil or any locale that CBW has identified as contaminated. CCI shall not transport any soil from the Property without CBW's permission.

g. CCI agrees that it will not store any Hazardous Substances on the Property. CCI further agrees to ensure that all fluids are drained from vehicles or other scrap materials before they are stored on the Property.

h. If Hazardous Substances introduced to the Property by CCI cause or result in residual contamination of the Property CCI shall be responsible for any such residual damage to the Property resulting therefrom.

i. CCI shall, at its sole cost and expense, dispose of all refuse resulting from its use of the Property, including garbage and food of any kind, by disposing all such materials not consumed on Property off-site or in a permitted landfill.

14. Indemnification.

a. CCI shall indemnify, defend, and hold CBW, its agents, and employees harmless from and against any and all liability, loss, suit, claim, judgment, fine, demand, damage, penalty, property damage, or personal injury of whatever kind, including sums paid in settlements of claims, attorney fees, consultant fees, expert fees, or costs incurred arising from or connected with this Lease, CCI's use or occupation of the Property, CCI's operations, or any act or omission by CCI, its agents, contractors, employees, customers, associates, invitees, or licensees. CCI shall give CBW reasonable notice of any such claims or actions.

b. Without limiting the foregoing, this indemnification obligation includes the payment of all costs of any investigation of site conditions, or any cleanup, abatement, remediation, removal, or restorative work required by this Lease, or by any federal, state, or local governmental agency with appropriate jurisdiction because of Hazardous Substances present in the soil or groundwater on or under the Property or other affected properties incurred, arising from, or connected with this Lease, CCI's use or occupation of the Property, CCI's operations, or any act or omission by CCI, its agents, contractors, employees, customers, associates, invitees or licensees.

15. **Events of Default.** Each of the following shall constitute an event of

default under this Lease:

a. The failure of CCI to pay monthly rent or any other sum of money due under this Lease within ten (10) days after the date such payment is due.

b. The failure of CCI to perform or observe any covenant or condition of this Lease, other than a default in the payment of money described in the preceding subsection (a), which is not cured within thirty (30) days after notice thereof from CBW to CCI, unless the default is of a kind that cannot be cured within such 30-day period, in which case no event of default shall be declared so long as CCI shall commence the curing of the default within such 30 day period and thereafter shall diligently and continuously prosecute the curing of same.

c. The use of the Leased Premises or buildings and improvements thereon for purposes other than those permitted herein, to which CBW has not given its written consent.

d. The commencement of a case under any chapter of the federal Bankruptcy Code by or against CCI, or the filing of a voluntary or involuntary petition proposing the adjudication of CCI as bankrupt or insolvent, or the reorganization of CCI, or an arrangement by CCI with its creditors, unless the petition is filed or case commenced by a party other than CCI and is withdrawn or dismissed within ninety (90) days after the date of its filing.

e. The admission in writing by CCI of its inability to pay its debts when due; the appointment of a receiver or trustee for the business or property of CCI, unless such appointment shall be vacated within ten (10) days after its entry; CCI making an assignment for the benefit of creditors; or the voluntary or involuntary dissolution of CCI.

16. <u>Landlord's Remedies.</u> Upon the occurrence of an event default, CBW has all of the following remedies, all in addition to any other remedies that CBW may have at law or in equity:

a. CBW may terminate this Lease by written notice to CCI, upon which termination CCI shall immediately surrender possession of the Leased Premises, vacate the Leased Premises, and deliver possession of the Leased Premises to CBW. CCI hereby makes a present grant to CBW of a full, free and irrevocable license to enter into and upon the Leased Premises, in the event CBW terminates this Lease in accordance with this subsection (a), and to repossess the Leased Premises, to expel or remove CCI and any others who may be occupying or within the Leased Premises, and to remove any and all property therefrom, using such force as may be necessary, with or without process of law, without being deemed in any manner guilty of trespass, eviction or forcible entry or detainer, and without relinquishing CBW's right to rent or any other right given to CBW hereunder or by operation of law.

b. CBW may by written notice declare CCI's right to possession of the Leased Premises terminated without terminating this Lease. CCI hereby makes a present grant to CBW of a full, free and irrevocable license to enter into and upon the Leased Premises, in the event CBW terminates CCI's right of possession in accordance with this subsection (b), and to repossess the Leased Premises, to expel or remove CCI and any others who may be occupying or within the Leased Premises, and to remove any and all property therefrom, using such force as may be necessary, with or without process of law, without being deemed in any manner guilty of trespass, eviction or forcible entry or detainer, and without relinquishing CBW's right to rent or any other right given to CBW hereunder or by operation of law.

c. CBW may recover from CCI, with or without terminating this Lease, actual attorney's fees and other expenses incurred by CBW by reason of CCI's default.

17. <u>Waiver</u>. The failure of either party to insist upon the strict performance of any provision of this Lease, or to exercise any right, power or remedy consequent upon a breach thereof, shall not constitute a waiver by said party of any such provision, breach or subsequent breach of the same, or any other provision. All rights and remedies of the parties hereunder, or otherwise available at law or in equity, are cumulative.

18. <u>Compliance with Laws</u>. Tenant's improvement and use of the Leased Premises shall comply with all governmental statutes, ordinances, rules and regulations, including without limitation the CBW Zoning Code, all applicable building codes, and orders of any governmental authorities having jurisdiction under any environmental law, now or hereafter in effect. CCI is responsible for obtaining any and all permits or easements necessary to access the Leased Premises from the Zimovia Highway.

19. Modification. This Lease may only be modified or amended by a

document in writing, executed by CCI and CBW.

20. <u>**Time of Essence.**</u> Time is of the essence of each provision of this Lease.

21. <u>**Parties Interested Herein.**</u> Nothing in this Lease, express or implied, is intended or shall be construed to give to any person or entity other than CBW and CCI any right, remedy or claim, legal or equitable, under or by reason of this Lease. The covenants, stipulations and agreements contained in this Lease are and shall be for the sole and exclusive benefit of CBW and CCI, and their permitted successors and assigns.

22. <u>Addresses for Notices.</u> All notices, demands and requests from CCI to CBW shall be given to CBW at the following address:

All notices, demands or requests from CBW to CCI shall be given to CCI at the following address:

Each party may, from time to time, designate a different address or different agent for service of process by giving written notice given to the other party.

23. <u>Interpretation</u>. Each party hereto has been afforded the opportunity to consult with counsel of its choice before entering into this Lease. The language in this Lease shall in all cases be simply construed according to its fair meaning and not for or against either party as the drafter thereof.

24. Attorney's Fees.

a. If CBW is involuntarily made a party to any litigation concerning this Lease or the Property by reason of any act or omission of CCI, or if CBW is made a party to any litigation brought by or against CCI without any fault on the part of CBW, then CCI shall pay the amounts reasonably incurred and expended by CBW, including the reasonable fees of CBW's agents and attorneys and all expenses incurred in defense of such litigation.

b. In the event of litigation between CBW and CCI concerning enforcement of any right or obligation under this Lease, the non-prevailing party shall reimburse the prevailing party for attorney's fees pursuant to Alaska Rule of Civil Procedure 82.

25. <u>Governing Law and Venue.</u> This Lease will be governed by, construed and enforced in accordance with, the laws of the State of Alaska and the City and Borough of Wrangell. Any action or suit arising between the parties in relation to or in connection with this Lease, or for the breach thereof, shall be brought in the trial courts of the State of Alaska for the First Judicial District at Wrangell.

26. <u>Severability/Binding Effect</u>. If any provision of this Lease, or any application thereof, shall be invalid or unenforceable, the remainder of this Lease and any other applications of such provision shall not be affected thereby. This Lease shall be binding upon and inure to the benefit of the parties' heirs, executors, other legal representatives, successors and assigns.

27. <u>Execution in Counterparts.</u> This Lease may be executed in two or more counterparts, each of which shall be an original and all of which together shall constitute one and the same document.

28. <u>Entirety of Lease.</u> This Lease constitutes the entire and integrated agreement between CBW and CCI concerning the subject matter hereof, and supersedes all prior negotiations, representations or agreements, either written or oral. No affirmation, representation or warranty relating to the subject matter hereof by any employee, agent or other representative of CBW shall bind CBW or be enforceable by CCI unless specifically set forth in this Lease.

29. <u>Effective Date.</u> The Effective Date of this Lease is the date that it is executed by the parties following approval of the Lease by the CBW Assembly pursuant to Wrangell Municipal Code 16.08.100.

AN ORDINANCE OF THE ASSEMBLY OF THE CITY AND BOROUGH OF WRANGELL, ALASKA, AMENDING CERTAIN SECTIONS IN CHAPTER 5.10, PURCHASES AND SALES, OF THE WRANGELL MUNICIPAL CODE

BE IT ORDAINED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF WRANGELL, ALASKA:

[The changes to the existing code are shown as follows: the words that are underlined are to be added and the words that are bolded and in brackets are to be deleted.]

SEC. 1.<u>Action.</u> The purpose of this ordinance is to amend Section 5.10.030, When prior approval by the assembly is required; Section 5.10.040, When competitive bidding or quotations are required; and 5.10.050, When competitive bidding or quotations are not required, in the Wrangell Municipal Code.

SEC. 2.<u>Amendment</u>, Section 5.10.040 of the Wrangell Municipal Code is hereby amended as follows:

5.10.030 When prior approval by the assembly is required.

Every contract for, or purchase of, supplies, materials, equipment, contractual services, or public improvements for more than <u>\$50,000</u> [\$25,000], excluding freight, shall require the prior approval by motion or resolution of the assembly; and under no circumstances may such contract or purchase be made without first obtaining the approval of the assembly.

5.10.040 When competitive bidding or quotations are required.

A. Purchases of, or contracts for, supplies, materials, equipment, contractual services, or public improvements whose cost does not exceed **\$20,000** [**\$10,000**] in a single transaction may be made on the open market without competitive bidding or quotations; provided, that such purchases or contracts are for budgeted items or items previously approved by the assembly.

B. Except as otherwise provided in WMC 5.10.050, purchases of, or contracts for, supplies, materials, equipment, or contractual services whose cost exceeds \$20,000 [\$10,000] but does not exceed \$50,000 [\$25,000] in a single transaction shall, at the option of the borough purchasing authority, be made in the open market by written quotation or telephone solicitation or through the competitive bidding process set out in subsection (C) of this section.

C. Except as otherwise provided in WMC 5.10.050, before any purchase of, or contract for, supplies, materials, equipment, or contractual services is made whose cost exceeds 50,000 [\$25,000], the borough purchasing authority shall submit to at least three persons, firms or corporations dealing in and able to supply the same, or to a smaller number if there are not three dealing in and able to supply

the same, invitations to bid and specifications to give them opportunity to bid. [He shall also publish] <u>Public</u> notice of the proposed purchase <u>shall be posted</u> in the newspaper of general circulation within the borough.

5.10.050 When competitive bidding or quotations are not required.

The following may be purchased or contracted for without giving an opportunity for competitive bidding or soliciting quotations:

A. Supplies, materials, equipment, or contractual services whose cost does not exceed \$20,000 **[\$10,000]**, excluding freight costs, in a single transaction;

•••

F. Supplies, materials, equipment, or contractual services which must be purchased from a specific source in order to prevent incompatibility with previously purchased supplies, materials, equipment, or contractual services. For purposes of this subsection the term "incompatibility" is defined as the inability to (1) interconnect, combine, interchange, or join, or (2) that which causes or necessitates maintenance expertise or training where such acquisition would result in substantial duplication. The assembly must approve by motion or resolution any purchase whose cost exceeds \$50,000 [\$25,000] which is to be excluded from competitive bidding by the authority of this subsection;

K. Public improvement whose cost does not exceed <u>\$20,000</u> [\$10,000] in a single transaction.

SEC. 3.Classification. This ordinance is of a permanent nature and shall be codified in the Wrangell Municipal Code.

SEC. 4. Effective Date. This ordinance shall be effective upon adoption.

SUMMARY STATEMENT:

The Swimming Pool has been losing water in the bottom of the pool's concrete basin, and repairs are needed before the pool can be returned to service.

PND Engineers reviewed the existing condition, the 2015 pool repairs method and materials, the original construction plans, and they developed a modified repair design. The Borough, on two separate occasions, issued RFP solicitations for the repair work and received no response to either solicitation.

In an attempt to further this repair project, staff have recommended a different approach based on feedback from a couple of the local contractors, who have suggested the work be performed on a Time and Expense (T&M) basis. While working through the manner in which we will select a contractor for construction of the repairs, it is advantageous to proceed in ordering the materials since they will require approximately several weeks to acquire.

Based on the revised design provided by the engineer, we have reassessed the value of the construction work and find that funding in the amount of \$30,000 is necessary for the material and labor to construct the repairs for the pool. The following is a breakdown of expected costs:

- Materials identified by engineer \$12,000 (to be purchased directly by the CBW)
- Pool basin repair construction \$18,000 (labor to be contracted)

Resolution 01-23-1752 amends the FY23 Budget to accommodate expenditures for this project by transferring \$30,000 from General Fund Reserves to the Parks & Recreation CIP Fund for the Pool Repair project.

SUMMARY STATEMENT:

R&M Engineering was selected in 2020 to perform the subdivision development with survey, wetland delineation, permitting, and initial design for the Alder Top Village Subdivision.

With the subdivision development complete and the final plat scheduled to be complete with monuments in place after construction of the roadway, the Borough has committed to completing the design and permitting and moving forward with construction of the roadway and utilities for the first phase of the subdivision development. R&M will further their design work to date to finalize design and develop construction bid ready documents.

R&M has provided a fee proposal for developing the monitoring plan, as required by the State Historical Preservation office, and a fee proposal to finalize the design. Together the two proposals total \$ 109,616.

It is recommended to enter into a Professional Services Agreement with R&M Engineering-Ketchikan, Inc. for the Alder Top Village Subdivision Road & Utilities Design project to advance the road and utilities infrastructure project.

RECOMMENDATION MOTION:

Move to authorize Staff to proceed with the Property Tax Foreclosures for the tax years 2017 to 2022 per Wrangell Municipal Code 05.04.370.

SUMMARY STATEMENT:

Both the Wrangell Municipal Code and the State Statutes allows for annual tax foreclosures for delinquent property taxes. These provisions assures that taxes will be collected so that cities counting on these revenues will not come up short when trying to provide public services such as police, fire, library, parks, pools, roads, and other basic services provided.

Generally, we try and do a foreclosure every other year. A foreclosure takes at a very minimum 15 months and usually longer to complete. The guidelines are governed by the State of Alaska and have many legal filings and some long waiting periods in between. Needless to say, it has been over 10 years since the last property tax foreclosure process has been done.

Section 5.04.370 of the Wrangell Municipal Code requires the assembly to elect to proceed with a foreclosure based on any and all delinquent real property taxes. Once the assembly approves the foreclosure we do the following:

1. Send a courtesy letter to all delinquent property tax owners that they have 30 days to avoid being on the foreclosure list.

- 2. File a petition for judgment with the court
- 3. Publish the foreclosure list in the paper for four consecutive weeks
- 4. Motion for judgment after the foreclosure is in the paper
- 5. Then there is a one year redemption period.

6. At the end of the one year redemption period there is notice of Expiration of Redemption after the one year is completed.

- 7. Wait 30 days after this publication.
- 8. City would get deed to the property.

9. Bring to the assembly to either use the property for a public purpose or get permission to sell it.

10. When sold, the city would claim all taxes through the current year, penalties and Interest and any other foreclosure costs such as attorney fees, filing fees and publication costs. The balance of funds are returned to the foreclosed owner upon application by them.
