Harbormaster Report March 2023

Administration: The hiring committee for the Harbor Administrative Assistant has made the decision to hire Andrew Eyon. He has been the Temporary Assistant for the last six months. Andrew is learning every day and has done a good job of representing the Harbor in the office. I look forward to working with him for many more years.

I attended the Seattle boat show from February 6th through 8th. The Seattle Boat show hosts 300 exhibitors, more than 800 new and used brokerage boats, and almost 100 boating seminars. This show brings together a variety of boating enthusiasts to one venue, making it the West Coast's largest marine boating event. This year's attendance was close to pre-pandemic numbers, with 34,242 attendees compared to 42,643 pre-pandemic. The numbers are moving in the right direction. We had a lot of interest from customers looking for stalls in Southeast AK. It seems like we should have another good year for transients visiting Wrangell during the coming summer months.

I had the opportunity to join members of the Alaska Association of Harbormasters and Port Administrators in Juneau for the annual Legislative Fly-In. The AAHPA connects 47 member ports and harbors, as well as another 60 corporate members. The Association, with support from its members, offers three \$2500 scholarships for vocational students pursuing a career related to the maritime industry. This year, they have extended the deadline as there were not enough applicants.

The Association hosts this Fly-In yearly to lobby our representatives and senators in the State Legislature for funding for the Harbor Facility Grant Program. The purpose of this grant is to provide financial assistance to municipally-owned harbor facilities. The Alaska Legislature passed this legislation in 2006, establishing a new 50/50 matching grant program called the Harbor Facility Grant Program.

This grant program is funded annually at the discretion of the Alaska Legislature and consists of two tiers, Tier I and Tier II. The first tier has priority and consists of major maintenance and repair of a harbor facility that was previously owned by the state and is now locally owned. The second tier consists of all other harbor facilities and those harbor facilities that have already received a Tier I grant. A harbor facility may only receive one Tier I grant but is eligible for multiple Tier II grants.

Wrangell was one of three recipients of the 2024 grant awards, but the Governor did not include it in his initial budget. This is why it was important for me to attend the Fly-In and lobby with AAHPA. I met with Senator Stedman, Representative Dan Ortiz, Representative Rebecca Himschoot, Majority Leader Cathy Giessel, Senate President Gary Stevens, and Speaker of the House Cathy Tilton. They were all very receptive to funding the Matching

Harbor Grant program. We are optimistic that this program will be funded, and we can get to work rebuilding Meyers Chuck's mooring floats.

Harbors: We have received the quote for lumber to repair the Fish and Game dock from the sinking of the Tobica. The price tag just for lumber is \$7k. All additional labor will be billed out hourly to complete the project. Once winter decides to give us a break the crew will be working to make the repairs.

Port: We have entered into an agreement with PN&D for a condition assessment of the Concrete T Dock. This dock is an alternative loading and unloading dock for the barge lines that service Wrangell. This is also Alaska Marine Lines main line barge primary loading and unloading dock for fish processing. As this dock was built 25 years ago it is time to have a full assessment of the condition. They have contracted with Alaska Commercial Divers to conduct the underwater assessment of the steel piling. PN&D will do the concrete structure and above water steel piling assessment. This work is to begin the middle of March and be completed by April 30th, 2023.
