Mayor Matthew Porter called the regular meeting to order at 6:05 p.m. The following City Council members were present: Councilman David R. Duke, Councilman Dave Strang, Mayor *pro tem* Jeff Forrester, Councilman Scott Williams, and Councilman Garrett Mize. Councilman Timothy T. Wallis was absent.

Mayor Porter requested Item B be pulled from Consent Agenda and considered individually.

Council Action

A motion was made by Mayor *pro tem* Forrester, seconded by Councilman Williams, to approve the Consent Agenda, except for Item B, as presented. A vote was taken and the motion passed 6-0 with Councilman Wallis absent.

B. Consider, and act upon, Ordinance No. 2022-68 amending Ordinance No. 2022-56, which established the budget for fiscal year 2022-2023; providing for repealing, savings and severability clauses; and providing for an effective date of this ordinance.

Staff Comments

Finance Director Beard reported there was a change in the proposed dollar amount for the budget amendment. The police department is requesting to use state-seized funds for \$179,879 to purchase drones, a utility vehicle and trailer, Knox Box equipment for all police vehicles, and a digital forensics workstation replacement. All items will be used for law enforcement purposes per Chapter 59 of the Texas Code of Criminal Procedures. This will increase the General Fund budget by \$179,879. The Unassigned Fund Balance will not be affected, but this same amount will reduce the Assigned Fund Balance for Law Enforcement.

Council Action

A motion was made by Councilman Strang, seconded by Mayor *pro tem* Forrester, to approve Item B with the amendment presented. A vote was taken and the motion passed 6-0 with Councilman Wallis absent.

WORK SESSION

Mayor Porter convened the Council into Work Session at 6:58 p.m. Mayor Porter convened the Council into a break at 6:58 p.m. Mayor Porter reconvened the Council into Work Session at 7:03 p.m.

WS1. Presentation of the Community Waste Disposal (CWD) Annual Report.

Robert Medigovich, representing Community Waste Disposal, addressed Council giving a 2021 annual review including residential trash service, residential single stream recycling service, residential rear load collection on Saturdays, multifamily recycling, residential bulk and loose brush on-call service, residential bulk and loose brush extra service, commercial new service vehicle, commercial recycling program, Wylie ISD recycling program, residential trash service and residential driver incident, customer service inquiries, CNG truck parking expansion, transfer station expansion, equipment purchases and maintenance shop, CWD mobile app and address search tool, X-treme Green events, paint reuse program, sponsorship participation, awards given, and saved resources statistics.

WS2. Discuss WWTP Demolition.

Clayton Barnard representing Freese and Nichols, addressed Council giving a presentation on the Wastewater Treatment Plant Demolition options including the current status of the plant, demolition options including no demo and remaining as is; wastewater interceptor improvements with no demo with an associated cost of \$775,000; basin removal with option one (with a top removal) having a cost of \$1,952,000 or option two (with a full removal) having a cost of \$4,630,000; and basin and structure demolition including proposed easements with option one having a cost of \$3,000,000 and option two having a cost of \$4,900,000.

Council questions included how much property would be left and recoverable if everything is removed, whether are there any concerns with people accessing the site, what is the maintenance cost now, what was Wylie paying NTMWD for the permit fee to maintain the site, what is the City's risk for leaving it the way it is, could holes be created in the basins to allow stormwater to drain instead of holding water.

Council comments and discussion included expressing concerns with the cost for the number of acres and added it would be difficult to attract a developer to the site to recoup the funds, would like more information on the project

and what the restrictions would be with the top removal, needs to stay the way it is now and may make improvements later, look at a five to ten-year plan that the City could budget for over an extended period, it creates an opportunity for a public park and would like to see it on the tax rolls.

Council's direction was to leave it as is and gather additional information for a plan for the site.

WS3. Discuss proposed amendments to the City Ordinance and Zoning Ordinance regarding Code Enforcement policies and Zoning Uses.

Community Services Director Jasen Haskins addressed Council stating staff is presenting proposed amendments to both the City Ordinance and Zoning Ordinance to strengthen and clarify staff's ability to enforce public nuisance violations. The amendments to the City's Code of Ordinances are to align with state law changes, to allow for the city to immediately abate violations at the property owners' expense for repeat offenders and to simplify the lien filing process.

Council questions included what would the process be for the signing of liens, providing additional information on the newly added section a-4, and is there a list of charges for the services.

Council's direction was to proceed with bringing back an ordinance with the proposed changes.

Councilman Mize stated he requested a discussion item be placed on the agenda regarding donation boxes located throughout the City that can become a nuisance to the public if not maintained. Mize stated he wanted to give property owners a tool so that they may have control of donation boxes on their property and a tool for staff to help keep our City beautiful; have reasonable regulations on the donation boxes to ensure they are utilized in the best way.

Council questions and comments included would it be possible to require donation boxes to have a person present, could the restriction be amended to regulate the number of donation boxes based on the size of the property instead of limiting it to only one box per lot, and what is the abatement process. Haskins requested additional input on the temporary use box locations. Forrester replied he thought it should be the same allowed locations for both permanent and temporary use.

Council direction was to proceed with bringing back an ordinance with the proposed changes and adding donation boxes, both permanent and temporary use, allowed at the same locations, and changing 11.b.2 to regulate the number of boxes based on the size of the lot.

Recommendation

Discussion

Our current metal detector purchased in 2013 is unexpectedly no longer functioning properly and unable to be repaired. To ensure the safety of our citizens and staff during court operations it is necessary that we purchase a replacement as soon as possible.

Texas Code of Criminal Procedure - Article 102.017, Court Costs, Municipal Court Building Security Fund (b) may be used for security personnel, services, or items related to buildings that house the operation of a municipal court.

The Municipal Court Building Security Fund expense will increase \$5,000 and the fund balance will decrease by the same amount. The estimated fund balance will be \$18,304.

ORDINANCE NO. 2022-69

AN ORDINANCE OF THE CITY OF WYLIE, TEXAS, AMENDING ORDINANCE NO. 2022-56, WHICH ESTABLISHED THE BUDGET FOR FISCAL YEAR 2022-2023; REPEALING ALL CONFLICTING ORDINANCES; PROVIDING FOR A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Council heretofore adopted Ordinance No. 2022-56 setting forth the Budget for Fiscal Year 2022-2023 beginning October 1, 2022, and ending September 30, 2023; and,

WHEREAS, the City Departments and Divisions routinely review their budget appropriations to determine if any changes are necessary; and

WHEREAS, based upon said review the City staff now recommends that certain amendments to the Budget be considered by the City Council; see Exhibit A; and,

WHEREAS, the City Council has the authority to make amendments to the City Budget under Article VII, Section 4 of the City Charter, as well as State law; and,

WHEREAS, the City Council has determined that the proposed amendments to the FY 2022-2023 Budget; see Exhibit A, with the revenues and expenditures therein contained, is in the best interest of the City; and therefore, desires to adopt the same by formal action.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WYLIE, TEXAS:

SECTION I: The proposed amendments to the FY 2022-2023 Budget of the City of Wylie; Exhibit A, as heretofore adopted by Ordinance No. 2022-69, are completely adopted and approved as amendments to the said FY 2022-2023 Budget.

SECTION II: All portions of the existing FY 2022-2023 Budget and Ordinance No. 2022-56, except as specifically herein amended, shall remain in full force and effect, and not be otherwise affected by the adoption of the amendatory ordinance.

SECTION III: Should any paragraph, sentence, sub-division, clause, phrase or section of this ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision thereof, other than the part or parts as declared to be invalid, illegal, or unconstitutional.

SECTION IV: This ordinance shall be in full force and effect from and after its adoption by the City Council and publication of its caption as the law and the City Charter provide in such cases.

SECTION V: That all other ordinances and code provisions in conflict herewith are hereby repealed to the extent of any such conflict or inconsistency and all other provisions of the Wylie City Code not in conflict herewith shall remain in full force and effect.

SECTION VI: The repeal of any ordinance, or parts thereof, by the enactment of the Ordinance, shall not be construed as abandoning any action now pending under or by virtue of such ordinance; nor shall it have the effect of discontinuing, abating, modifying or altering any penalty accruing or to accrue,

nor as affecting any rights of the municipality under any section or provision of any ordinances at the time of passage of this ordinance.

WHEREAS, in January 2022, the City Council of the City of Wylie, Texas ("City Council") adopted Ordinance No. 2022-01 that, among other things, established a Code of Conduct; and

WHEREAS, the City Council has investigated and determined that it would be advantageous and beneficial to the citizens of Wylie to amend Ordinance No. 2022-01 and Wylie's Code of Ordinances, Ordinance No. 2021-17, as amended, Chapter 2 (Administration), Article III (Officers), Division 2 (Code of Conduct), Section 2-58 (Board of Review); and

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WYLIE, TEXAS that:

SECTION 1. <u>Findings Incorporated.</u> The findings set forth above are incorporated into the body of this Ordinance as if fully set forth herein.

SECTION 2. <u>Amendment of Wylie's Code of Ordinances, Ordinance No. 2021-17, as amended,</u> <u>Chapter 2, Article III, Division 2, Section 2-58, and Ordinance No. 2022-01</u>. Chapter 2, Article III, Division 2, Section 2-58, and Ordinance No. 2022-01 are amended to read as follows:

"CHAPTER 2 (ADMINISTRATION)

ARTICLE III (OFFICERS),

•••

DIVISION 2 (CODE OF CONDUCT)

•••

Sec. 2-58. Board of Review

. . .

- (B) Qualifications
 - (1) All members must live within the City of Wylie city limits and be at least 18 years of age;

- (2) Board of Review (BOR) members may not be:
 - a. The spouse or the domestic partner of the individual filing the Complaint ("Complainant") or the individual who is the subject of the Complaint ("Respondent") is the spouse or domestic partner.
 - b. Serving on any other Council appointed Board or Commission during their term on the BOR;
 - c. A City Council member or City of Wylie employee, or the spouse or domestic partner of a City Council member, Board and Commission member, or City of Wylie employee;
 - d. An elected public official; or
 - e. A candidate for elected public office at the time of their term on the BOR.
- (C) Terms of appointment / Limitations
 - (1) No member shall serve on the board for more than three consecutive, two-year terms or six consecutive years, whichever is less; provided, however, that should a board member's replacement not be qualified upon the expiration of any term of a board member, then that board member shall holdover on the board until a qualified replacement board member has been appointed.
 - (2) Except for a board member whose tenure has been extended by the City Council as provided above, a member who has served three consecutive, two-year terms or six consecutive years, whichever is less, on the board may be reappointed to serve on the board after being off the board for at least one year, and upon reappointment, the member is eligible to serve another three consecutive terms or six consecutive years, whichever is less. Such member is eligible, however, for appointment to a different board or commission without waiting.
 - (3) BOR members shall serve until any Complaints pending during their appointed term have been fully adjudicated by the BOR.
 - (4) If a person selected to serve on the BOR pursuant to this subsection cannot fulfill his or her duties as a member of the BOR due to illness, travel, disqualification under the terms outlined above, or another bona fide reason, or otherwise refuses to serve on the BOR, that person shall be requested to confirm that fact with the City Secretary in writing within 15 calendar days of receipt of the service notification. In this event, the City Secretary shall repeat the process outlined herein until a substitute has been selected.
- ..."

SECTION 3. <u>Repealing/Saving.</u> Each Ordinance referenced in this Ordinance and the Code of Ordinances shall remain in full force and effect, save and except as amended by this or any other Ordinance. All provisions of any other ordinances in conflict with this Ordinance are hereby repealed to the extent they are in conflict; but such repeal shall not abate any pending prosecution for violation of the repealed ordinance, nor shall the repeal prevent a prosecution from being commenced for any violation if occurring prior to the repeal of the ordinance. Any remaining portion of conflicting ordinances shall remain in full force and effect.

SECTION 4. <u>Severability.</u> Should any section, subsection, sentence, clause or phrase of this Ordinance be declared unconstitutional and/ or invalid by a court of competent jurisdiction, it is expressly provided that any and all remaining portions of this Ordinance shall remain in full force and effect. Wylie hereby declares that it would have passed this Ordinance, and each section, subsection, clause or phrase thereof, regardless of whether any one or more sections, subsections, sentences, clauses or phrases are

declared unconstitutional and/ or invalid.

SECTION 5. <u>Effective Date.</u> This Ordinance shall become effective from and after its adoption. The term limitations and other provisions set forth in Section 2 shall apply retroactively to members serving on the board referenced herein as of the effective date of this Ordinance, including those board members whose appointments were made prior to the adoption of this Ordinance.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WYLIE, TEXAS:

SECTION 1. <u>Findings Incorporated.</u> The findings set forth above are incorporated into the body of this Resolution as if fully set forth herein.

SECTION 2. <u>Amendment of Resolution No. 2022-15(R)</u>. Section 1 of Resolution No. 2022-15(R) is hereby amended as follows:

"…

<u>SECTION 1:</u> The following rules shall govern the Board of Review:

A. Creation and appointment

The Board of Review (BOR) is created by Wylie Ordinance No. 2022-01 and serves at the will of the City Council. The BOR shall consist of five (5) regular members and two (2) alternates who will serve no more than three consecutive, two-year terms or six consecutive years, whichever is less; provided, however, that should a board member's replacement not be qualified upon the expiration of any term of a board member, then that board member shall holdover on the board until a qualified replacement board member has been appointed. Except for a board member whose tenure has been extended by the City Council as provided above, a member who has served three consecutive, two-year terms or six consecutive years, whichever is less, on the board may be reappointed to serve on the board after being off the board for at least one year, and upon reappointment, the member is eligible to serve another three consecutive terms or six consecutive years, whichever is less. Such member is eligible, however, for appointment to a different board or commission without waiting.

The members will be at least 18 years of age, a resident citizen of the City, and may not serve on any other Council appointed Board or Commission during their term. Members of the City Council, City of Wylie employees, an elected public official, and a candidate for elected public office at the time of their term on the BOR may not serve on the BOR. The spouse or domestic partner of a City Council member, Board and Commission member, or City of Wylie employee may not serve on the BOR. The BOR members are required to complete Open Meetings Act training and receive Certificate of Completion by the first ninety (90) days of first year appointment.

..."

SECTION 3. Resolution No. 2022-15(R) shall remain in full force and effect, save and except as amended by this or any other ordinance. All provisions of any resolution in conflict with this Resolution are hereby repealed to the extent they are in conflict. Any remaining portions of said resolutions shall remain in full force and effect.

WORK SESSION

WS1. Discuss the Animal Services facility's current status, needs for improvement, and future growth.

Jeff Forrester stated the facility needs to be able to handle the growth in the city's population and the number of animals coming into the shelter. He would like to see multiple options for improvements, expansions, and/or adding a new building to the facility.

Amber Porter would like all the animals to be housed indoors.

Susan Cranford would like a separate building for an adoption center.

Lt. Matt Miller stated that Shelia Patton has looked into the history of the current facility.

Shelia Patton stated that she has worked at the city for 16 years, and during that time, there has only been one improvement to the facility. It was to add a laundry room, a cat playroom, office space, and a ceiling to the cat room. The shelter was built in 2000, and the city's population was about 15,000 at that time. The shelter was built as a shared space between Animal Services and the Service Center. In 2006 the city's population increased to about 33,000; because of this, the city renovated the shelter. They added a parking lot, removed the kennels from inside the building, added a new dog building, and added the indoor/outdoor runs in the bay. The city's current population is about 61,000. With the increase in population, our intakes and services have gone up. The city has grown since 2000, but the facility hasn't grown with it. Shelia suggests getting a shelter planner to look at our current and future needs. The shelter planner would also ensure that the facility complies with state laws.

Jeff Forrester has two questions. What is the cost of a consultant? Do we have a list of partners we currently work with?

Shelia Patton stated she has not contacted a shelter planner yet. She will check into it and get back to the board.

Jeff Forrester's recommendation is to find out the cost of using a shelter planner or a consultant. He would also like several options for improvements, expansions, and/or adding a new building to the facility.

Susan Cranford agrees with everything that was said. She stated that getting a shelter planner would be best because they would be the most knowledgeable.

Amber Porter agrees with everything. She would like all the animals to be brought indoors and for there to be a separate building for an adoption center.

Dr. Brad Abraham said he agrees with everything. He likes that the current facility has a drop off area for after hours impounds and emergencies.

Lt. Matt Miller stated the current facility is not what we want to present as a city. He would like clarification from Amber about the animals being outdoors.

Amber Porter does not want the animals housed outdoors or in a separate building.

Lt. Matt Miller, in reference to the cost of a new facility, Holstead ran some numbers based on the Public Safety Building and came up with a 10,000 square foot facility being about 2 million dollars. This amount was a rough estimate; it went before council and was removed. Everyone knows it's time for improvements, but we must start the process.

Jeff Forrester stated he wants to see a facility that the city can be proud of, and the current facility is outdated, and it is time for improvements.

Shelia Patton stated that we would look into all the recommendations.

Lt. Matt Miller stated we would look into general numbers and get back to the board. He also stated that the staff and he are excited about the new facility.

Shelia Patton stated that the staff has worked hard to present the facility in a positive light, and she is excited to be working toward improving the facility.

The Animal Shelter Advisory Board met on October 19, 2022. The attached By-laws and Rules of Procedure were considered, approved, and placed on file. These items are being submitted as required by City ordinance.

CITY OF WYLIE ANIMAL SHELTER ADVISORY BOARD BYLAWS

ARTICLE I

<u>Name</u>

<u>Section 1.</u> The City of Wylie Animal Shelter Advisory Board is hereby established to act in an advisory capacity to the city council and to assist the city in complying with the requirements of Chapter 823 of the Texas Health and Safety Code.

<u>Section 2</u>. As authorized by the City Charter, City of Wylie, and City Ordinance No. 2003-11, this body shall be known as the Animal Shelter Advisory Board.

ARTICLE II

Members

Section 1. Number of Members/Qualified Appointment/Terms. The Board shall consist of five (5) members. The Board shall consist of one licensed veterinarian, one member of the City Council of the City of Wylie, Texas, The Animal Services Manager of the City of Wylie, Texas (whose duties include the daily operation of the Wylie animal shelter), one representative from an animal welfare organization, and one resident of the City of Wylie, Texas, with all Board members appointed by the City Council for a term of two (2) years, with the exception of the Animal Shelter Manager who shall be a permanent member of the board.

Section 2. Except for the animal services manager, no board member shall serve for more than three (3) consecutive terms or six (6) consecutive years (whichever is less); provided, however, should a Board member's replacement not be qualified upon the expiration of any term of a Board member, then that Board member shall holdover on the Board until a qualified replacement Board member has been appointed.

Section 3. In addition to Board members, the City Manager may appoint a staff designee as an ex officio member of the Board, who shall have no right to vote on any matter before the Board. Each Board member shall serve without compensation but may be reimbursed for actual expenses approved in advance by the City Council.

ARTICLE III

<u>Meetings</u>

<u>Section 1</u>. The Animal Shelter Advisory Board shall meet at least three (3) times per year and any additional meetings as may be called.

<u>Section 2</u>. Special meetings may be called by the Chair or at the call of any two members of the Board, provided that notice thereof be given in writing to the Chair or Vice Chair.

<u>Section 3</u>. Three (3) Board members shall constitute a quorum of the Board for the purpose of conducting its business, exercising its power, and for all other purposes. No action of the Board shall be valid or binding unless adopted by the affirmative vote of a majority of those Board members present and voting.

<u>Section 4</u>. No action of the Board shall be valid or binding unless adopted by the affirmative vote of a majority of those Board members present and voting.

<u>Section 5</u>. When vacancies occur on the Board, the City Council shall appoint, by majority vote, a replacement to serve the remainder of the term.

<u>Section 6</u>. Each Board member serves at the pleasure of the City Council and may be removed at the discretion of the City Council. Board member absences shall be controlled by Article VIII of Wylie's Charter.

<u>Section 7</u>. Robert's Rules of Order (current edition) shall govern the parliamentary procedure of the Board in cases to which they are applicable and in which they are not inconsistent with these by-laws.

ARTICLE IV

Powers and Duties

<u>Section 1</u>. The Board shall act in an advisory capacity to Wylie staff and the City Council in any matter pertaining to compliance with Chapter 823, Health and Safety Code.

Section 2. The board, through its chairperson, shall report to the city council concerning its activities and proposals by submitting to the city council the approved minutes of each meeting of the board and copies of all reports of inspections conducted by the department of state health services, veterinarians or other authorities and all statistical reports of shelter operations considered and approved by the board.

<u>Section 3</u>. The Board's authority shall not extend to the direction, supervision, employment, or termination of Wylie employees. No supervisory power of the Board is created.

<u>Section 4</u>. The Board will develop a set of by-laws governing rules of procedure for their meetings and operation for City Council approval.

<u>Section 5</u>. The Board shall not have the power to obligate Wylie for funds and/or expenditures or incur any debt on behalf of Wylie.

<u>Section 6</u>. All powers and duties prescribed and delegated herein are delegated to the Board as a unit, and all action hereunder shall be of the Board acting as a whole. No action of an individual Board member is authorized except through the approval of the Board or City Council.

<u>Section 7</u>. The Board shall have any other power and/or duty as prescribed and authorized by the City Council.

The Animal Shelter Mission... ...is to promote and protect the health, safety and welfare of animals and people in Wylie, Texas.

City of Wylie, Texas Animal Shelter Advisory Board Rules of Procedure



1. Statement

1.1. It is hereby declared that appointment to the Animal Control Advisory Board is a distinct honor and the trust imposed in the appointee involves the corresponding obligation of the appointee to serve the community by regular attendance and participation in the proceedings of the body.

2. Creation and Membership

- 2.1. The Animal Shelter Advisory Board was established by City Ordinance No. 2003-11, and serves at the will of the City Council.
- 2.2. The Board shall consist of five (5) regular members who will serve for terms of two (2) years. A Board member shall generally be limited to three two-year terms, with the exception of the Animal Shelter Manager who shall be a permanent member of the board per Ordinance 2020-01. The Board shall consist of one licensed veterinarian, one member of the City Council of the City of Wylie, Texas, The Animal Services Manager of the City of Wylie, Texas (whose duties include the daily operation of the Wylie Animal Shelter), one representative from an animal welfare organization, and one resident of the City of Wylie, Texas.
- 2.3. In accordance with State law, the Board members are required to complete Open Meetings training and receive a Certificate of Completion within the first ninety (90) days of first year appointment. This may be taken online via the Office of Attorney General's website (www.oag.state.tx.us). The Office of the Attorney General offers free video training courses to ensure that all elected and appointed government officials have a good command of both open records and open meetings laws.

3. Officers

- 3.1. The Board shall, at the first meeting after July 1st (and at such other times as these offices may become vacant), select from among its members a Chairperson and Vice-Chairperson to serve for a period of one (1) year.
- 3.2. In the absence of both the Chairperson and Vice-Chairperson during a meeting, the remaining Board members shall elect an Acting Chairperson.

4. Officer's Duties

4.1. The Chairperson shall preside over all meetings and briefing sessions, and perform all duties as required by law.

4.2. The Vice-Chairperson shall assume all duties of the Chairperson in the absence of the Chairperson.

5. Powers and Duties of the Board

- 5.1. The Animal Shelter Advisory Board shall act in an advisory capacity to Wylie staff and the City Council in any matter pertaining to compliance with Chapter 823, Health and Safety Code.
- 5.2. The Board shall perform all duties as prescribed by State statutes and the City's Code of Ordinance Chapter 18. The City Council has final authority in these matters, but should seek recommendations from the Animal Shelter Advisory Board prior to making final decisions.
- 5.3. The Board shall work with the Animal Services Manager (or designee) on various policy concerns and issues regarding Wylie Animal Services.
- 5.4. The Board shall make recommendations for changes to Chapter 18 of the City Code of Ordinances and/or policies as it relates to compliance with Chapter 823, Health and Safety Code when deemed appropriate.
- 5.5. The Board shall maintain contact with the stakeholder groups from which its members are appointed in working with the Animal Services Manager and staff.
- 5.6. The Board shall work with the Animal Services Manager and designated staff collaboratively to ensure best-in-class quality animal services with the city of Wylie..
- 5.7. The Board shall perform all other duties as the City Council may direct.

6. Orientation Training

6.1. Upon his or her appointment to the Board, all new members shall attend an orientation presented by City Staff to familiarize the board members with the operation of Municipal Government, the department organization and policies, and the operating procedures of the Animal Shelter Advisory Board.

7. Rules of Order

- 7.1. The Chairperson shall rule on all points of order.
- 7.2. The Board members may overrule the Chairperson on points of order by a two-thirds (2/3) vote of members present.
- 7.3. Any provisions of these rules not governed by City Ordinance may be temporarily suspended by a favorable two-thirds (2/3) vote of all members of the Board, whose vote shall be entered upon the minutes.

8. Quorum

- 8.1. A quorum shall consist of three (3) members.
- 8.2. No matters may be handled without the presence of a quorum.
- 8.3. No action of the Board shall be valid or binding unless adopted by the affirmative vote of a majority of those Board members present and voting.

9. Agendas

- 9.1. An agenda shall be prepared by the Animal Services Manager or his/her designee for each meeting of the Animal Services Advisory Board. A copy of the agenda shall be posted in the Municipal Complex as required by law, as well as on the website.
- 9.2. There shall be attached to each agenda item, a report of matters pending further action by the Commission.
- 9.3. All regular and special meetings shall follow, as closely as possible, the printed agenda. The agenda should include, but is not limited to the following;
 - a. Ratification of Minutes;
 - b. Citizens' participation on items not on the agenda;
 - c. Executive Session, as needed;
 - d. Consent agenda;
 - e. Items for individual consideration;
 - f. Breaks at the discretion of the Chairperson;
 - g. Commissioners or Staff comments on general business;
 - h. Adjournment.
- 9.4. Agendas may be amended by the Chairperson as to order of items, but not as to content, unless overruled by a majority of the members present.

10. Minutes of Meetings

- 10.1. Minutes of all regular and special meetings shall be kept by the Secretary, designated by the Animal Services Manager, and are subject to amendment and ratification by the Board at the next regular meeting.
- 10.2. The minutes of the Board's proceeding shall show the overall vote, or if absent or failing to vote, shall reflect that fact.

11. Regular meetings

- 11.1. The Animal Shelter Advisory Board shall meet at least three (3) times per year and any additional meetings as may be called.
- 11.2. Any Board member missing three (3) consecutive regularly scheduled meetings without prior notification to Staff and/or a valid reason, which may include family emergency, illness, or other reasonable cause, may be subject to dismissal from the Board by the City Council.
- 11.3. All meetings shall be held in full compliance with the provision of state law, ordinances of the City, and these rules of procedure.

12. Special Meetings

- 12.1. Special meetings may be called by the Chairperson, or at the request of two (2) or more members, or may be scheduled by a majority of the Board at any previous meeting. The time and place of the special meeting shall be determined by the convening authority.
- 12.2. All members must be notified of any special meeting by giving written notice to all members by an email address of record at least seventy-two (72) hours before the meeting, and the notice must specify the purpose of the meeting.
- 12.3. Special meetings must be posted in accordance with the open meetings act.

13. Addressing the Board

- 13.1. Persons desiring to address the Board shall complete a "Request to Speak" card and submit the card to the Secretary.
- 13.2. The Secretary will sort the speaker cards by agenda item and deliver them to the Chairperson.
- 13.3. The Chairperson will refer to the speaker cards for comments on items not on the printed agenda, and individual agenda item comments.
- 13.4. Persons who note on a speaker card their desire to address the Board will be called to the podium by the Chairperson at the appropriate time and will follow the guidelines of Ordinance 2019-29 as outlined below when addressing the Board;
 - a. Approach the podium, state their name and address and whether or not they are representing a person, group, or organization;
 - b. Speak so that all present in the room may hear clearly;
 - c. Address all statements and questions to the Chairperson;

- d. Be courteous in language and deportment;
- e. Be concise and focused in their Comments;
- f. Group comments should not exceed 6 minutes, individual comments should not exceed 3 minutes unless an interpreter is needed, in which case 6 minutes is allowed.
- 13.5. The Chairperson may interrupt an individual to redirect or terminate remarks when they are not relevant to the matter before the Board, or when the Chairperson determines the remarks to be out of order.

14. City Staff Responsibilities

- 14.1. The Animal Services Manager or designee shall be responsible for providing the Board with the necessary professional, technical, and clerical services, including:
 - a. Prepare and submit the agenda with staff reports and any special items as directed by the Chairperson;
 - b. Coordinate the services of all City Staff and other sources of public information for and on behalf of the Board;
 - c. Maintain a true copy of all Board proceedings;
 - d. Maintain all Board records;

15. Written Request Required

- 15.1. Every proposal submitted for Board action shall be made in accordance with approved application procedures from the appropriate Ordinance or Regulations.
- 15.2. The proposal shall be complete in all respects before being accepted for filing and Board consideration.

16. Conflict of Interest Rules

- 16.1. Conflict of Interest. Should any member of the Board feel he/she has a conflict of interest with an agenda item before the Board, they should openly declare so at the introduction of the item. They are thereby prohibited from discussing, participating in, or voting on the item in question. They shall also fill out a Conflict of Interest form and file it with the Secretary.
- 16.2. Abstention. Should any member of the Board choose to abstain from voting on any question before the Board where no declared conflict of interest exists, their vote shall be recorded as an affirmative vote in the official minutes.

17. Motions

- 16.3. A motion may be made by any member. A second to the motion shall be required before an item is put to a vote.
- 16.4. All votes shall be by a simple majority of members present, except as otherwise stated in these rules of procedure.
- 16.5. When fewer than all the members are present for voting and when all motions for a given application fail to carry by a majority vote, consideration of the application shall be continued under this rule to the next regular meeting, to the extent allowed by law. Failure of the Board to secure a majority concurring vote at said next regular meeting shall be recorded in the minutes as a denial of the proposal under the rule.
- 16.6. When a vote is required by state law or other requirement, and fewer than all members are present, and a simple majority is not reached, the vote shall be recorded as a denial.

17. Repealing Clause

17.1. All previously adopted Rules of Procedure of the Animal Shelter Advisory Board are hereby expressly repealed.

18. Suspension of Rules of Procedure

18.1. Any one or all of these rules of procedure may be suspended in order to allow a particular consideration of a matter, provided that it does not violate the state law or home rule charter, and provided that not less than two-thirds Board members vote in favor of such suspension. Where any rule embodies a provision of state law, identically or in substance, such rule may not be suspended.

Discussion

In recent years, the marketplace for ammunition has been greatly impacted by both the COVID 19 pandemic shutdowns and labor shortages and the war in Ukraine. The nationwide supply chain shortage has made it difficult to locate ammunition and has caused prices to vary wildly. Mutiny Machine is able to fulfil large orders with competitive pricing that is at near prepandemic price, and being able to order from a single vendor in large quantities will allow the City to save significantly on shipping. This purchase represents unfulfilled inventory needs from FY 21-22 and current fiscal year requirements.

Staff recommends this one-time purchase of ammunition from Mutiny Machine LLC in the amount of \$58,300.00 as providing the best value to the City. Recommendation

Motion to approve the Item as presented.

Discussion

The fitness equipment at the Wylie Recreation Center is inspected and monitored for wear and tear, and is recommended for replacement and upgrades as needed. Replacing the machines on a regular basis helps ensure that the Recreation Center is offering the safest possible equipment, granting improved accessibility, and reducing staff time for maintenance as well as overall down time for the machines.

There are several machines that are beginning to display wear and tear and would be best to replace now before there are any real issues, namely three treadmills, an elliptical, and our back-extension machine. In order to increase offerings at the Recreation Center and improve machine use, staff recommends replacing and adding newer weight plates and a weight plate stand for the strength equipment side of the room.

Staff recommends the purchase of fitness equipment and installation services from Team Marathon Fitness in the amount of \$50,616.00 as providing the best value to the City. The City is authorized to purchase from a cooperative purchasing program with another local government or a local cooperative organization pursuant to Chapter 791 of the Texas Government Code and Section 271 Subchapter F of the Local Government Code; and by doing so satisfies any State Law requiring local governments to seek competitive bids for items.

Consider, and act upon, Ordinance No. 2022-71 amending Wylie's Code of Ordinances, Ordinance No. 2021-17, as amended, Chapter 54 (Health and Sanitation), Article IV (Weeds, Rubbish, Insanitary Matter); providing for repealing, savings and severability clauses; providing for an effective date of this ordinance; and providing for the publication of the caption hereof.

Recommendation

Motion to approve the Item as presented.

Discussion

At the November 2022 City Council meeting, staff presented amendments to Chapter 54, Article IV of the City Code of Ordinances. This Article covers the violations for public nuances such as weeds and trash and codifies the remedies the City and its officers are allowed to implement.

Staff suggested amendments that included alignment of the City's Code Enforcement with state law changes (Sec 54-63), allow for the City to immediately abate violations at the property owners expense for repeat offenders (Sec 54-66.a.4), and simplify the lien filing process to align with state law (Sec 54-66(c).

At the November meeting, Council directed staff to present an ordinance with the recommended changes. The ordinance and the proposed amendments are attached.

ORDINANCE NO. 2022-71

AN ORDINANCE OF THE CITY OF WYLIE, TEXAS, AMENDING WYLIE'S CODE OF ORDINANCES, ORDINANCE NO. 2021-17, AS AMENDED, CHAPTER 54 (HEALTH AND SANITATION), ARTICLE IV (WEEDS, RUBBISH, INSANITARY MATTER); PROVIDING FOR REPEALING, SAVINGS AND SEVERABILITY CLAUSES; PROVIDING FOR AN EFFECTIVE DATE OF THIS ORDINANCE; AND PROVIDING FOR THE PUBLICATION OF THE CAPTION HEREOF.

WHEREAS, the City Council of the City of Wylie, Texas ("<u>City Council</u>") has investigated and determined that it is in the best interest of the City of Wylie, Texas ("<u>Wylie</u>") to amend and update Chapter 54, Article IV of the City Code of Ordinances; and

WHEREAS, the City Council further finds that it is a reasonable exercise of its police power to provide remedies and penalties for violations of Chapter 54, Article IV; and

WHEREAS, the City Council has determined that amendments would be advantageous and beneficial to the health, safety, and welfare of the citizens of Wylie.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WYLIE, TEXAS:

SECTION 1: <u>FINDINGS INCORPORATED</u>. The findings set forth above are incorporated into the body of this Ordinance as if fully set forth herein.

SECTION 2: <u>Amendment of Wylie's Code of Ordinances, Ordinance No. 2021-17, as amended,</u> <u>Chapter 54, Article IV.</u> Chapter 54, Article IV is hereby amended as depicted in "Exhibit".

SECTION 3: <u>SAVINGS/REPEALING CLAUSE</u>. All provisions of any ordinance in conflict with this Ordinance are hereby repealed to the extent they are in conflict; but such repeal shall not abate any pending prosecution for violation of the repealed ordinance, nor shall the repeal prevent a prosecution from being commenced for any violation if occurring prior to the repeal of the ordinance. Any remaining portions of said ordinances shall remain in full force and effect.

SECTION 4: <u>SEVERABILITY</u>. Should any section, subsection, sentence, clause or phrase of this Ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, it is expressly provided that any and all remaining portions of this Ordinance shall remain in full force and effect. Wylie hereby declares that it would have passed this Ordinance, and each section, subsection, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional or invalid.

SECTION 5: <u>AMENDMENTS.</u> For clarity in reading amendments to the Wylie Code of Ordinances, any language intended to be added to the code may be underscored in the amending ordinance, and any language intended to be deleted from the code may be placed in brackets and stricken through. These markings, when used, and the deleted portions shall be removed when amendments are printed in the code. The amended provisions as set forth in this Ordinance have also been renumbered for ease of reading.

SECTION 6: <u>EFFECTIVE DATE</u>. This Ordinance shall be effective upon its passage and publication as required by law.

CODE OF ORDINANCES Chapter 54 - HEALTH AND SANITATION ARTICLE IV. WEEDS, RUBBISH, INSANITARY MATTER

ARTICLE IV. WEEDS, RUBBISH, INSANITARY MATTER¹

Sec. 54-61. Definitions.

(a) The following words, terms and phrases, when used in this section, shall have the meanings ascribed to them in this subsection, except where the context clearly indicates a different meaning:

Brush means scrub vegetation or dense undergrowth.

Carrion means the dead and putrefying flesh of any animal, fowl or fish.

Enforcement officer means the city code and environmental inspector, or such other persons designated by the city manager.

Filth means any matter in a putrescent state.

Garbage means all decayable wastes.

Impure or unwholesome matter means any putrescible or non-putrescible condition, object or matter which tends to, may or could produce injury, death or disease to human beings.

Junk means all worn out, worthless or discarded material, including, but not limited to, odds and ends, old iron or other material; glass; cordage; refrigerators and appliances, if outside buildings.

Objectionable, unsightly or insanitary matter means any matter, condition or object which is or should be objectionable, unsightly or insanitary to a person of ordinary sensitivities.

Owner means a person having the title to real property.

Refuse means a heterogeneous accumulation of worn-out, used up, broken, rejected or worthless materials and includes garbage, rubbish, paper or litter and other decayable or non-decayable waste.

Rubbish means trash, debris, rubble, stone, useless fragments of building materials, refrigerators and appliances, or other miscellaneous useless waste or rejected matter.

Weeds means vegetation that because of its height is objectionable, unsightly or insanitary, but excluding:

- (1) Shrubs, bushes, and trees;
- (2) Cultivated flowers; and
- (3) Cultivated crops.
- (b) Any word not defined in subsection (a) of this section shall be construed in the context used and by ordinary interpretations, not as a word of art.

Sec. 54-62. Penalty for violation of article.

Any person who commits an offense under the provisions of this article shall be subject to the penalty provided for in section 1-13.

(Code 1997, § 54-112; Code 2005, § 54-62; Ord. No. 92-14, § I(2.07), 12-8-1992)

Sec. 54-63. Property within city to be free of conditions constituting public nuisances; enumeration of conditions.

A person owning, claiming, occupying or having supervision or control of any real property, occupied or unoccupied, within the city limits,, commits an offense if such person permits or allows any stagnant or unwholesome water, sinks, filth, carrion, weeds, rubbish, brush, refuse, junk or garbage, or impure or unwholesome matter of any kind, or other public nuisance as defined by the State of Texas Health and Safety Code Section 343.011 to accumulate or remain on such real property or within any easement area on such real property or upon any adjacent right-of-way for streets and alleys between the property line of such real property and where the paved surface of the street or alley begins. Such conditions are hereby defined as public nuisances.

Sec. 54-64. Weeds of height greater than 12 inches constitutes offense.

A person, owner, tenant, agent or person responsible for any premises within the city, occupied or unoccupied, commits an offense if such person permits or allows weeds to grow on the premises to a greater height than 12 inches. Such premises shall include, but not be limited to, the parkway between sidewalk and the curb; the right-of-way between any fence, wall or barrier and the curb or pavement if such exists or the centerline of such right-of-way; or the area between a fence, wall or barrier and within any abutting drainage channel easement to the top of such channel closest to the property. The city may abate, without notice weeds higher than 48 inches.

Sec. 54-65. Cultivated and uncultivated agricultural properties; height limitations.

With respect to uncultivated agricultural properties, a person, owner, tenant, agent or person responsible for such property commits an offense if such person permits or allows weeds to grow to a greater height than 12 inches within 150 feet from any adjacent property under different ownership or any street right-of-way. However, on cultivated agricultural properties where the distance between the growing crop and abutting property under different ownership or street right-of-way is less than 150 feet, the person, owner, tenant, agent or person responsible for such property commits an offense if such person permits or allows weeds to grow to a greater height than 12 inches between such growing crop and such property or street right-of-way, so long as no traffic visibility obstruction will exist.

Sec. 54-66. Notice of violation; delivery of notice; abatement by city; charges; collection; lien; perfection of lien.

- (a) If any person violates the provisions of this article, the enforcement officer or their designee shall give notice to such person setting forth the noncompliance with this article. Such notice shall be given in any one of the following ways:
 - (1) Personal delivery in writing;
 - (2) By letter addressed to such person at his post office address, and which shall be deemed to have been received five days from the date of mailing;
 - (3) If personal service cannot be obtained, or the owner's post office address is unknown:
 - a. By publication at least once;
 - b. By posting the notice on or near the front door of each building on the property to which the violation relates; or
 - c. By posting the notice on a placard attached to a stake driven into the ground on the property to which the violation relates, if the property contains no buildings.
 - (4) The notice shall also state that should another such violation of the same kind or nature occur, on or before the first anniversary of the date of the notice, the city, without further notice, may correct the violation at the property owner's expense.
- (b) If such person fails or refuses to comply with the demand for compliance in the notice within ten days of such notice or publication, the city may do such work or cause such work to be done to bring the real property into compliance with this article. The costs, charges and expenses incurred in doing or having such work done or improvements made to the real property shall be a charge to and the personal liability of such person, called charges. The charges to be collected by the city under this article shall include, in addition to the costs and expenses of mowing or correcting a condition upon a tract of land, a sum specified in the fee schedule in Appendix A to this Code, which sum is hereby found to be the cost to the city of administering the terms of this article.
- (c) If a notice, as provided in this section, is delivered to the owner of such real property, and they fail or refuse to comply with the demand for compliance within the applicable time period, as provided in this subsection, the costs, charges and expenses shall be, in addition to a charge to and personal liability of the owner, a privileged lien upon and against such real property, including all fixtures and improvements thereon. In order to perfect such lien, the enforcement officer or his designee shall first give such owner written notice of demand for payment of such charges. Such written notice may be given by any one of the methods provided for the initial notice requiring compliance. If the owner fails or refuses to make complete payment of such charges within 20 days of such notice, the mayor or their designee shall file a written statement of such charges with the county clerk of the county in which the real property is located for filing in the county land records. The statement shall be sufficient if it contains the following:
 - (1) The name of the owner, if known;
 - (2) A legal description of the real property;
 - (3) The amount of the charges including interest thereon;

The statement may also contain such other information deemed appropriate by the enforcement officer or his designee. All charges shall bear interest at the rate of ten percent per annum from the date the city incurs the expense. The city may bring suit to collect the charges, institute foreclosure proceedings, or both. The statement, as provided in this section, or certified copy of such statement, shall be prima facie evidence of the city's claim for charges or right to foreclose the lien. The owner or any other person responsible, as provided in this section, shall be jointly and severally liable for the charges.

Sec. 54-67. Enforcement of article.

The provisions of this article shall be enforced by representatives of the city's code enforcement department. Notwithstanding any provisions of this article to the contrary, the enforcement officer has authority to issue immediate citations to persons violating any provision of this article in the presence of such official. It shall be unlawful for any person to interfere with the enforcement officer, his designee or an environmental health specialist, in the exercise of their duties under this article.

Discussion

OWNER: Juwaiter Muhammad

APPLICANT: McRight Smith

The applicant is requesting to rezone 1.27 acres located at 2021 North State Highway 78. The current zoning is Commercial Corridor (CC) and the requested rezoning is Commercial Corridor - Special Use Permit (CC-SUP) to allow for vehicle sales and display.

The current development on the subject property contains a minor automobile repair use. The site plan for this development was approved in October 2019. The property owner is requesting for the allowance of office space within the existing building and 10 existing parking spaces on the existing lot to be used for vehicle sales as shown in the zoning exhibit.

The Special Use Permit conditions state that vehicle sales shall only be permitted as an accessory use to the minor automobile repair business. Should the auto repair use cease, the zoning reverts back to CC only. Additionally, SUP conditions limit vehicle sales to passenger vehicles.

The conditions also allow for both the minor automobile repair use and vehicle sales use to be parked at a ratio of 1:400. The development exceeds this parking requirement by providing 24 spaces, two being handicapped. The proposal is not affecting any existing landscaping or fire lane access easements.

The properties adjacent to the subject property are zoned commercial. The subject property lies within the Regional Commercial sector of the Comprehensive Land Use Plan. The proposed zoning is compatible with the Plan.

Notices were sent to 11 property owners within 200 feet as required by state law. At the time of posting no responses were received in favor or in opposition of the request.

P&Z Recommendation

The Commission voted 6-1 to recommend approval. The dissenting commissioner stated that he did not think the use was appropriate in that area.

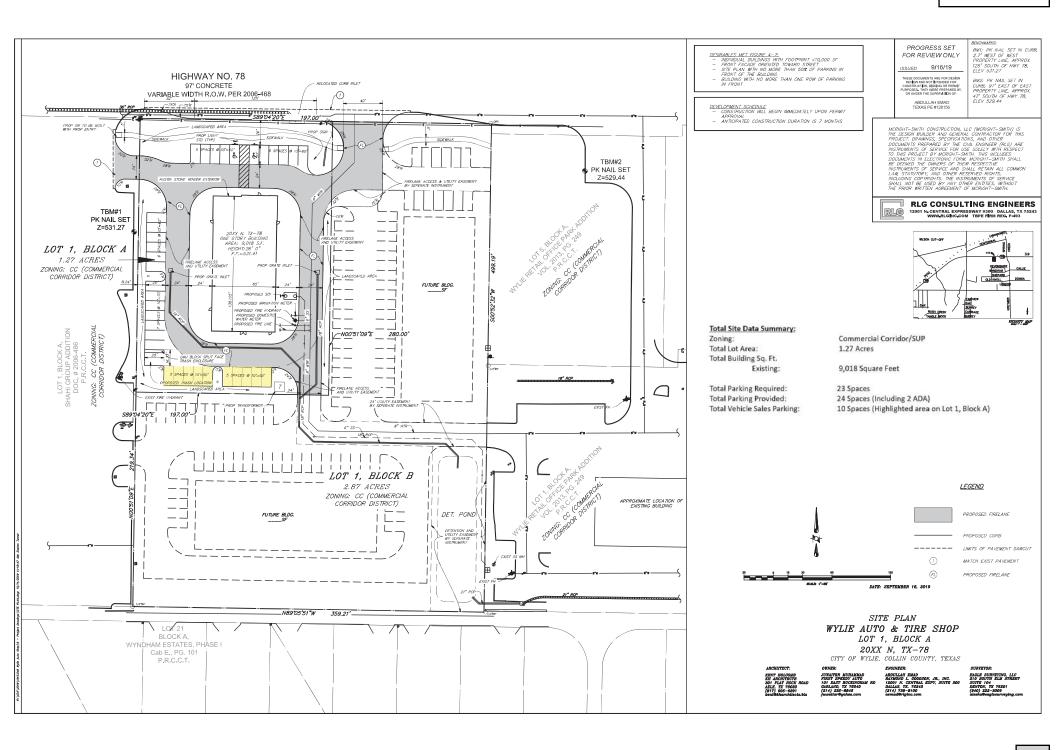

Conditions For Special Use Permit

I. PURPOSE:

The purpose of this Special Use Permit is to allow for a limited accessory Vehicle Display, Sales, or Service Use and the continued use of a Automobile Repair, Minor use.

- **II. GENERAL CONDITIONS:**
 - 1. The site shall be developed and uses allowed shall be in accordance with Commercial Corridor (CC) design standards, as provided in Article 4 and 5 of the City of Wylie Zoning Ordinance as adopted April 2021, except as specifically provided herein.
 - 2. This Special Use Permit shall not affect any regulations within the Zoning Ordinance (adopted as of April 2021), except as specifically provided herein.
 - 3. The design and development of the Wylie Auto & Tire Shop Lot 1, Block A development shall take place in general accordance with the Zoning Exhibit (Exhibit C).

III. SPECIAL CONDITIONS:

- 1. The Automotive Repair, Minor use shall become legally conforming.
- 2. Vehicle Display, Sales, and Service shall be allowed, only as an accessory use to the Automobile Repair, Minor Use and shall only be allowed until the main use ceases.

a. The Vehicle Display, Sales, and Service Use shall apply to new and used passenger automobiles, sport utility vehicles, and light trucks only.

b. Servicing of said vehicles shall be limited to those services allowed under the Automotive Repair, Minor Use. c. A maximum of 10 parking spaces for auto sales shall be allowed as depicted on Lot 1, Block A of the Zoning Exhibit (Exhibit C)

- 3. The overall parking for the site shall be at a ratio of 1:400 requiring a minimum of 23 parking spaces.
- 4. The Zoning Exhibit (Exhibit C) shall serve as the Site Plan for the development. Approval of the SUP shall act as site plan approval.

Recommendation

Discussion

OWNER: Wylie Economic Development Corporation

APPLICANT: Vasquez Engineering

The applicant is requesting to rezone 11.622 acres located east of the Downtown Historic District on the southwest corner of State Highway 78 and Brown Street. The property is currently zoned Commercial Corridor. The applicant is requesting a Planned Development to allow for a commercial environment that integrates and connects with Wylie's historic downtown.

The proposal includes a master plan of six commercial lots which include an interconnect of both vehicular and pedestrian pathways. A retention pond shall also be provided to serve as a gathering space.

The zoning exhibit calls out for the potential of 24,000 sq. ft. of office space, over 10,000 sq. ft. of retail space, in excess of 5,500 sq. ft. sit-down restaurant space, two drive-thru restaurants of about 3,000 sq. ft. each, and a convenience store with fueling services of 4,650 sq. ft.

The Planned Development establishes uses that are allowed by-right within the subject property:

- All by-right Commercial Corridor District uses except industrial uses (Sections 5.2H and 5.2I)
- Convenience Store
- Motor Vehicle Fueling Station
- Restaurant with Drive-In or Drive-Thru Services
- Food Truck Park

Alcohol/Liquor Uses, which shall be exempt from distance requirements from church, public hospitals, public schools and private schools

The following uses are expressly prohibited on the subject property:

-Sexually Oriented Business

- -Equipment Rental
- -Automobile Rental
- -Automotive Repair Minor
- Car Wash
- -Vehicle Display, Sales or Service
- And as mentioned above, any uses listed under sections 5.2H and 5.2I of the Zoning Ordinance

The following are modifications to the Commercial Corridor district design standards that the Planned Development is requesting:

- Lot 6 shall provide an architectural design standard that integrates with the Downtown Historic standards of Section 6.3.4.5 of the Zoning Ordinance.
- The overall site shall be allowed to be used to determine the 20% landscaping area calculation.
- Existing tree plantings in the public right-of way shall be allowed to count towards the landscape buffer requirement.
- Monument signage shall be allowed to be separated by at least 50 feet of any other monument sign on the same property.

The properties adjacent to the subject property are zoned commercial to the west and south, downtown historic to the east, and industrial to the north.

The subject property lies within the Regional Commercial Sector of the Comprehensive Land Use Plan. The proposed zoning is compatible with the Plan.

Notices were sent to 54 property owners within 200 feet as required by state law. At the time of posting two responses were received in favor and none in opposition of the request.

If zoning is approved each lot will be required to present a site plan and plat for consideration.

P&Z Recommendation

After some discussion regarding the alcohol sales provision, the Commission voted 6-0 to recommend approval as presented.

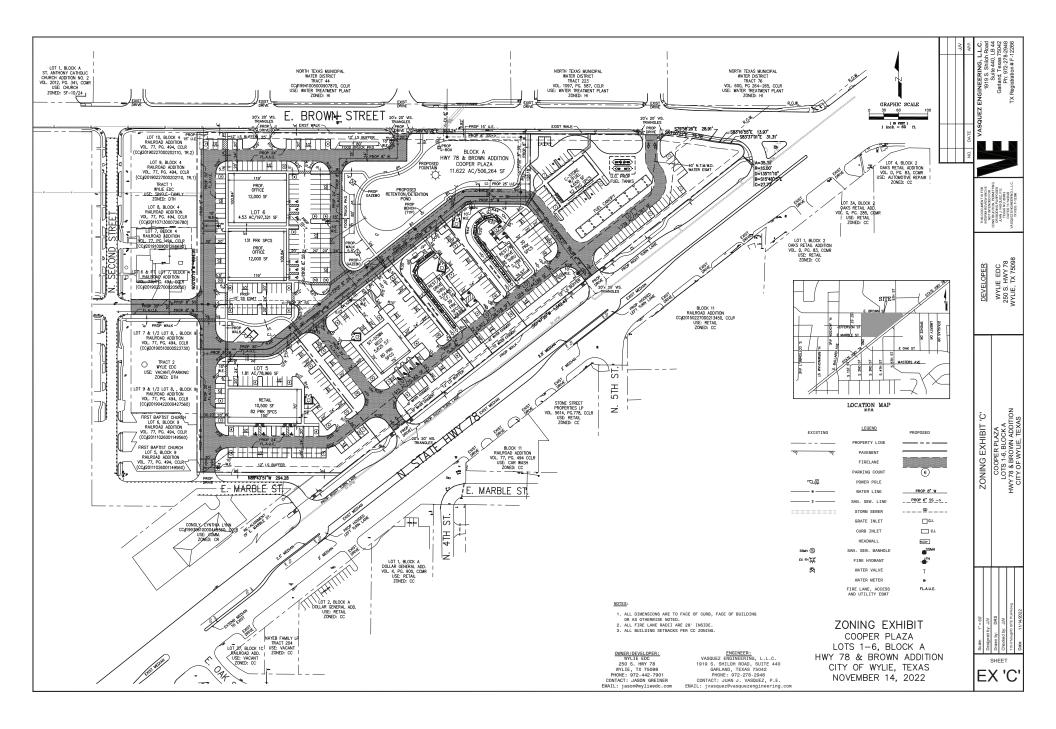

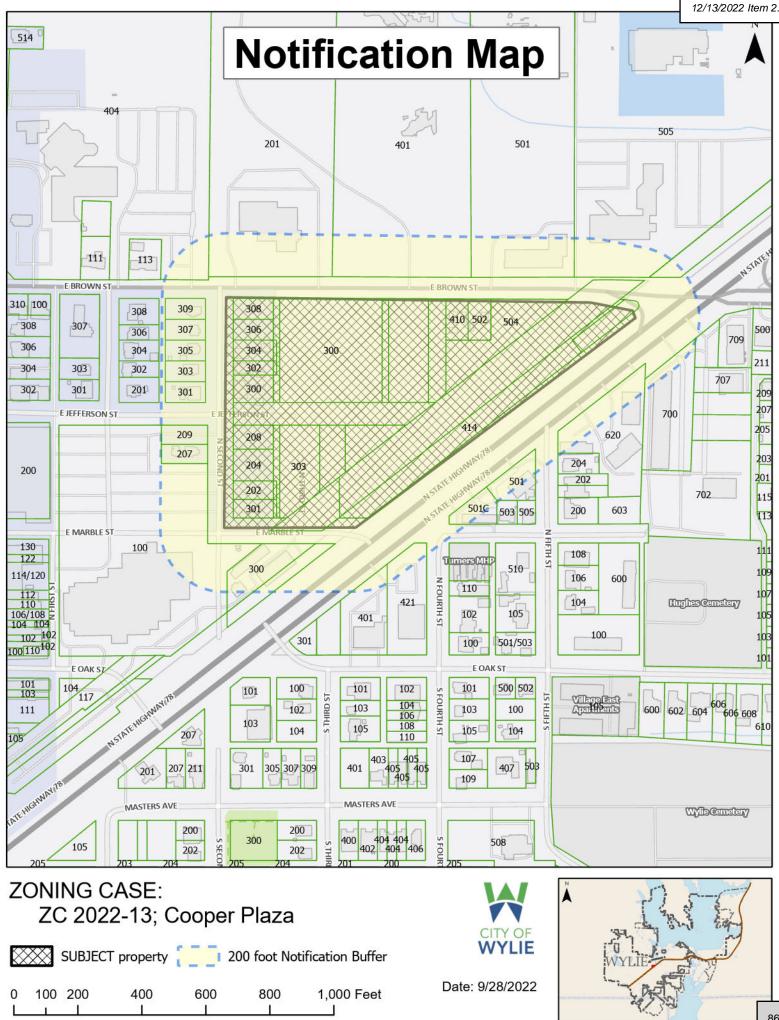
I. PURPOSE:

The purpose of this Planned Development is to create a vibrant multi-modal commercial environment that integrates with Wylie's historic downtown.

- II. GENERAL CONDITIONS:
 - 1. Unless otherwise explicitly stated in the PD, all variations are from the City of Wylie's Zoning Ordinance as amended April 2021.
 - 2. This Planned Development shall not affect any regulations of the aforementioned Zoning Ordinance except as specifically provided herein.
 - 3. The underlying zoning for this Planned Development District shall be Commercial Corridor (CC).
 - 4. The development shall be in general conformance with the Zoning Exhibit.
 - 5. The entire site, as depicted on the zoning exhibit, shall be used to determine landscaping calculations (20% of the site).
- **III. SPECIAL CONDITIONS:**
 - 1. The following uses as defined in the Commercial Corridor District (CC) shall be expressly permitted on the subject property:
 - a. Convenience Store
 - b. Motor Vehicle Fueling Station
 - c. Restaurant with Drive-In or Drive-Thru Service
 - d. Food Truck Parking
 - e. Alcohol/Liquor Uses, which shall be exempt from distance requirements from churches, public hospitals, public schools and private schools
 - 2. The following uses as defined in the Commercial Corridor District (CC) shall be expressly prohibited on the subject property:
 - a. Sexually Oriented Business
 - b. Equipment Rental
 - c. Automobile Rental
 - d. Automobile repair Minor

- e. Car Wash
- f. Any and all uses listed under Sections 5.2.H and 5.2.I of the Zoning Ordinance
- g. Vehicle Display, Sales or Service
- 3. The street frontage required landscape buffer, as required by Section 4.3.E.a(1) shall be allowed to include public right-of-way and landscape plantings shall also be allowed within the City's existing utility easement pending minimum distance separations are maintained as required by the City's Engineering Department.
- 4. No lot on the site shall be restricted by the distances to other Beer & Wine Package Sales establishments, churches, schools, city parks, or residences, as defined in Section 5.2 or any other distance restriction to other businesses defined in the Zoning Ordinance.
- 5. Section 7.3.H.2.a shall be amended to allow 9 feet by 20 feet standard car parking spaces on Lot 1 only.
- 6. All structures on Lot 6 of this development shall comply with a historic architectural standard that integrates with Section 6.3.E.5 of the Zoning Ordinance (Downtown) except as noted as follows: Section 6.3.E.5.a.1.d second floor windows, recessed with multiple lights, lintels, and sills shall not be required. Section 6.3.E.5.c Building Proportions-Commercial Structures shall not be required.
- 7. Section 22-448.a.4 shall be amended to allow a monument sign to be separated by at least 50 feet from any other monument sign on the same property, measured along the right-of-way.

Flag Retirement Program

The City of Wylie created the flag retirement program to honor those who fought to protect our freedom. We accomplish this by retiring and recycling your damaged American flags.

Recycle Bin Locations:

The City of Wylie citizens may take worn and tattered flags to any city building or Fire Station where the bins are located inside the lobby area.

- City Hall, 300 Country Club Rd., Wylie, TX 75098
- Public Safety Building, 2000 N. Highway 78, Wylie, TX 75098
- Fire Station #1, 1401 S. Ballard Ave., Wylie, TX 75098 (Personnel must be at location for drop off)
- Fire Station #2, 555 Country Club Rd., Wylie, TX 75098
- Fire Station #3, 210 N. WA Allen Blvd, Wylie, TX 75098
- Fire Station #4, 3200 McMillen Rd., Wylie, TX 75098



What happens next?

City of Wylie employees will collect the flags from the bins. They will then be reserved for our local organizations to pick up so they may respectfully retire them in a flag ceremony. <u>http://usscouts.org/ceremony/flagret1.asp</u>

- Respectful Flag Donation box will be purchased by the City of Wylie.
- One donation box will be placed at each of the following locations:
 - PSB
 - City Hall
 - Fire Station 1 Donation box will be located in the bay area, personnel must be at station for drop off.
 - Fire Station 2 Donation box will be located in the bay area, personnel must be at station for drop off.
 - Fire Station 3
 - Fire Station 4
- The Respectful Flag Donation box will be purchased as a temporary collection box. A long term goal for this program will be for the Boy Scouts to build a donation bin for each location (6 bins).
- Information about the program will be listed in two online locations. It can be found under "Services" on the Wylie homepage and under "Community" on the Fire Department homepage. The tab will be titled "Flag Retirement Program".
- A city employee at each donation site will check the bins and notify the Fire Administration office when the bin is full. Someone from the Fire Administration office will pick up the flags or the flags can be delivered directly to the Fire Administration office, by the employee, where they will be held for the organizations to pick up.
- Once the organization is able to collect the flags from the Fire Administration office, they will be retired in a respectful flag ceremony.
 - Examples of organizations that can collect the flags include: American Legions, VFW's and Girl Scouts/Boy Scouts
