# BIOGRAPHY

Sonny Behan, also known as Sonny Sundancer, is an acclaimed artist renowned for his magnificent largescale wildlife murals and intricately detailed oil paintings. His art, which seamlessly blends realism with abstraction, can be found in galleries and streets worldwide, from South Africa to New York. His bold use of color and dynamic compositions capture the movement of the animals he brings to life.

Born in the UK, Sonny was raised in South Africa from the age of ten, a

time that sparked his passion for wildlife. His global mural tour and solo exhibition in New York in 2018 marked the beginning of a meteoric rise, leading to an increasing demand for his art.

Now based out of Miami, Sonny has expanded his artistic repertoire to include intricate bronze sculptures, including a large-scale public sculpture at the United Nations HQ in NYC.

Sonny's passion for using his creativity to highlight the need to protect and preserve the natural world has earned him the reputation of being an artist who is deeply engaged and driven to make an impact. To this end, he has collaborated with prominent non-profits and organizations, such as World Wildlife Fund, United Nations, UNICEF, IFAW, Global Citizen and Discovery Inc., to create public art installations and campaigns to raise funds and awareness for conservation efforts.


In 2021 Sonny unveiled a large-scale (10ft) public sculpture at the United Nations Headquarters in NYC during the UN General Assembly in partnership with Discovery Inc. to bring attention to the plight of wild tigers.













On September 20 2021, Sonny Behan to the United Nations (UN) headquarters in New York to celebrate tigers and raise awareness for endangered species ahead of the 76th session of the UN General Assembly. The sculpture, placed at the entrance of the UN Plaza next to the renowned 'Non-Violence' sculpture, also draws attention to the UN's Decade on Ecosystem Restoration, a call for the protection and revival of ecosystems around the world for the benefit of people and nature.


This public artwork was created in collaboration with Discovery's Project C.A.T. campaign, launched in partnership with World Wildlife Fund (WWF), which supports nearly six million acres of tiger habitat across India, Bhutan and Russia. The ambitious project took over a year to bring to life, from conceptualisation to installation and was publicly unveiled at the iconic bell ringing ceremony to close the markets at the Nasdaq Market Site in Times Square.











# CONCEPTUAL IDEAS FOR WYLIE SCULPTURES





- Interactive Sculptures: The concept involves two sculptures interact with each other in a meaningful way.
- Caddo Tribesman in Action: The primary focus of one sculpture is a life-sized Caddo tribesman in the midst of shooting his bow. The sculpture aims to capture the essence of strength, artistry, innovation, focus, and grace inherent in the Caddo culture.
- **Elements of Motion:** Both sculptures incorporate elements that convey a sense of movement, including details such as flowing hair, billowing clothing, and scattered dirt.
- **Fragmented Hollow Design:** A distinctive feature of both sculptures is their hollow, fragmented design, with approximately 50% to 60% of the structure intentionally missing. Despite this, the complete forms are still recognizable.
- Traditional Exterior Patina: The exterior of both sculptures is adorned with traditional patina, adding depth and character to their appearance.
- Internal Color Sand Patterns: On the inside, both sculptures are painted with vibrant color patterns that represent the Caddo tribe, adding cultural significance to the artworks as well as a contemporary flair.



- **Dynamic Bison Sculpture:** The second scul 03/21/2024 Item DS1. so a life-sized bison in action, running through a cloud of dust. This depiction emphasizes the bison's powerful and graceful attributes, creating a sense of speed and vigor.
- **Frozen in Time:** These sculptures are designed to freeze a moment in time, capturing a memory as it forms, encapsulating the essence of a particular moment in history.
- Appearance and Disappearance: The sculptures create a captivating illusion of both appearing and disappearing, generating a sense of constant movement and change.
- **Spatial Interaction:** Although set far apart from each other, the sculptures are strategically placed to interact visually from a distance, forming a harmonious composition and allowing viewers an educational experience.
- Illusory Movement: The combination of hollow elements, fragmented design, and internal colors creates an optical effect where the sculptures appear to move and change as viewers walk around them, especially as lighting conditions shift.

# FEASIBILITY CONSIDERATIONS

**Hollowness for Budget Constraints:** Careful consideration must be given to the degree of hollowness to ensure that the sculptures remain life-sized while staying within the budgetary constraints.

Low Ground Mounting for Realism and Cost Efficiency: Suggesting low-to-the-ground mounting not only enhances the sculptures' realism but also reduces the costs associated with base plinths and installation.

**Prioritizing Safety:** It is crucial to design the sculptures with safety in mind, avoiding sharp edges or protruding pieces that could pose a risk to viewers or maintenance personnel.

**Dual Budgets for Cost Reduction:** Combining the budgets for each sculpture could potentially lead to reduced costs in fabrication, shipping, installation, engineering, and other associated expenses. This approach may provide more flexibility and efficiency in managing the project without sacrificing in scale and impact.
























### **CALL TO ORDER**

# A. Discussion and final report regarding Revery by artist Katy Antill

(C. Ehrlich, Public Arts Advisory Board Coordinator)

### **Staff/Board Comments**

PAC Ehrlich reported that all work including permitting and electrical had been completed and signed off by building inspections. Artist Antill was mailed her final check for the project

PAC Ehrlich reported that the dedication was scheduled for some time in April once all paving and lamdscaping was completed. She noted that monarch butterflies will be part of the dedication ceremony.

# B. Discussion regarding the 2024/2025 Municipal Trails art sites and art proposal (C Ehrlich, Public Arts Advisory Board Coordinator)

### **Board Discussion**

PAC Ehrlich reported that during the 2023/2024 proposal process, artist Sonny Behan had made a proposal for two sculptures. He had to decline from participation during the 23/24 year due to excessive projects but agreed to provide his proposals during Phase 3 (2024/2025). PAC Ehrlich displayed the designs for the board; which consisted of a bison and native American hunter. The proposal was in bronze relief with 40-60% bronze and patina and the remainder cut out.

PAC Ehrlich stated that if the board was interested in the proposal, as part of the guidelines, they could do a specific selection process. The consensus of the board was very favorable with a few questions for the artist. The board wanted to insure the cutouts and bronze front view would be the same from the back view; what the weight would be to sustain winds and how clean the edges would be to insure they were not sharp.

PAC Ehrlich told the board she would check with the artist regarding their concerns.

C. Discussion and update regarding the progress of the two 2024 art pieces by Yoshi Wright (C Ehrlich, Public Arts Advisory Board Coordinator)

### **Board Discussion**

PAC Ehrlich reported that artist Wright was now working with a Texas certified engineer to bring back the final signed plans for the two art pieces (Sacred Fire and Ancestor).
