PAAB Liaison Pannell updated the board artist Behan received his first milestone payment, and is currently working with his foundry and engineer to finalize the approved design, including the antler adjustments.

Once the stamped engineer drawings are submitted and the permit is issued by the city Behan will move forward with the large-scale foam and clay model that will be used to create the mould. He is hoping to be ready to bronze by the end of May.
