YMC Ch. 12.05 Revision

Discussion regarding what changes need to be made to the Code. Suggestions included raising fines for vandalism/other crimes, requiring violators to do community service, and possibly giving the option of paying off fines by performing community service. Councilmember Beck suggested a \$100 fine for the first offense, and higher for subsequent offenses. Perhaps the *extent* of the damage could dictate the severity of the punishment (ie: costly damage should require higher fines and more hours of community service than easy-and-cheap-to-repair damages.) He also would like to see these rules apply to all Town-owned properties, not just the Town Park. A guest asked if we'd looked into what neighboring cities did as far as rules/punishments, and Mayor Listek said we will. This subject will be continued at the next Council Meeting. (*Discussion only*)

NCEMS Board Representative

At the November meeting, Ronald Homola said he would fill the NCEMS Board position which Michelle Dawson had to resign from. So motion was made to appoint Ronald as the official Yacolt Rep for the Board.

New Business

Organized Run

Karissa and Rod Schoene introduced themselves as organizers for all sorts of Runs, from 5Ks to Ultra-Marathons. They have 15 years' experience producing racing events, and have worked with several cities in Clark and neighboring counties, under the business name Bivouac Racing. They are planning a marathon in the Bells Mountain/Tarbell trail system on Sunday July 3rd and would like to use Yacolt Rec Park as their base camp, for their runners to set up tents the night before. They are also willing to incorporate the Rendezvous Days' Bigfoot Fun Run into their plan. They expect around 100 participants in their big race. They have already gotten permitted by DNR, and they will provide emergency medical staff, lots of volunteers (although they may need more), insurance, timers, and so on. They don't expect it will cost the Town much for them to integrate the Bigfoot Run in with their marathon. They would like to work with the Town to come up with a workable plan. After some discussion, a motion was made to integrate this run into our Rendezvous Days events, with Bivouac Racing as the organizers.



Item Title: Slide Purchase

Proposed Meeting Date: January 10, 2022

Action Requested of Council: Approve purchase of the embankment slide

Proposed Motion: "I move that we purchase the embankment slide offered to us by Summit USA

for \$8500."

Summary/ Background: At the Council meeting on May 10, 2021, Council approved for Mayor Listek to shop for an embankment slide for the Town Square park, with a target price of \$12,000. The purchase of the slide is part of a public works project for Park Improvements. The total cost of this public works project is far below the amounts that trigger formal competitive bidding procedures under the statutes. So the Town invited competitive bids on an informal basis, and worked with a number of slide manufacturers over a period of several months to encourage the most competitive bids possible for equipment that satisfied the Town's specifications for the slide. In November, Mayor Listek got a call from Summit USA, saying they had a slide that they had custom made for an order, but the order didn't go through. So they have a slide all ready to go, in the size, shape, and color we had hoped for, and they are discounting it for us by almost \$5000, for a final price of \$8500. Our 2021 Budget allowed for this purchase, and the invoice for the slide is included with the final bills for 2021. This is a very unique opportunity for the Town to be able to purchase this slide at such a low price.
